### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Evans Enterprises, Inc. 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Evans Enterprises, Inc. 401(k) Profit Sharing Plan & Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. ## **Note 1 - Description of Plan**

The following brief description of the Evans Enterprises, Inc. 401(k) Profit Sharing Plan & Trust (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering qualified employees of Evans Enterprises, Inc. (Company, Employer, and Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (the ERISA).

The Plan Administrator and Company shareholders are responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

### **Eligibility**

Employees were eligible to participate in the participant deferral and Qualified Automatic Contribution Arrangement (QACA) safe harbor matching portions of the Plan if they were 18 years of age and had completed 60 days of service.

Employees were eligible for the employer discretionary nonelective contribution portion of the Plan if they were 18 years of age and had completed one year of service. A year of service for purposes of eligibility for employer discretionary nonelective contributions was a consecutive 12-month period during which the employee had 1,000 or more hours of service. In addition, employees must have been employed by the Company on the last day of the Plan year in order to receive allocations of the employer discretionary nonelective contributions.

### **Entry Date**

Employees were able to enter the participant deferral and QACA safe harbor matching portions of the Plan on the first day of each month coinciding with or following the date on which the employee satisfies the applicable eligibility requirements.

Employees were able to enter the discretionary nonelective portion of the Plan on the first day of January or July coinciding with or following the date on which the employee meet the eligibility requirements.

### **Contributions**

Each year, participants were able to contribute an amount of their pretax annual compensation, as defined in the Plan. Contributions were subject to certain Internal Revenue Code (IRC) limitations. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. The Plan allowed participants to designate contributions as Roth contributions. Participants were also able to contribute amounts representing distributions from other qualified plans (rollover).

The Company contributed a QACA safe harbor matching contribution equal to 100% of a participant's elective deferrals not exceeding 1% of the participant's compensation, plus 50% of each participant's elective deferrals in excess of 1% but not in excess of 6% of the participant's compensation, for a total maximum matching contribution of 3.5%. In addition, the Plan allowed for employer discretionary nonelective contributions which were contributed at the discretion of the Company's management. No discretionary contributions were made for the year ended December 31, 2023.

The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 6% of eligible compensation and their contributions invested in a designated American Funds target retirement date fund until changed by the participant.

### Participant Accounts

Each participant's account was credited with the participant's contributions, the Company's QACA safe harbor matching contributions, as well as allocations of the Company's discretionary nonelective contributions (if any) and Plan earnings. Participant accounts were charged with withdrawals and an allocation of administrative expenses that are paid by the Plan. Allocations were based on participant's compensation, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

### Investment Options

Upon enrollment in the Plan, a participant could direct deferrals and employer contributions in any of the funds offered by the Plan. Participants could change their investment options daily.

### Vesting

Participants were vested immediately in their contributions plus actual earnings thereon. A participant was 100% vested in the Company's QACA safe harbor matching after 2 years of credited service. Vesting in the employer discretionary nonelective portion of their accounts was based on years of credited service as set forth in the following table:

**Forfeitures**

At December 31, 2023 and 2022, forfeited non-vested accounts totaled \$0 and \$31,294, respectively. These accounts could be used to reduce future employer contributions and/or offset plan expenses. During the year ended December 31, 2023, forfeited non-vested accounts of \$9,199 were used to pay administrative expense of the Plan and \$18,440 were used to reduce employer matching contributions.

**Notes Receivable from Participants**

Participants could borrow from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes were secured by the balance in the participant's account. The loan interest rate was set at the prime rate. Principal and interest were paid ratably through payroll deductions over a period not to exceed five years, unless the proceeds of the note were used to acquire the participant's residence, in which case the loan terms could range up to 15 years. A participant could have no more than one note outstanding at any one time.

**Payment of Benefits**

Participants could elect to receive either a lump-sum amount equal to the value of their vested interest or annual installments as defined in the Plan document upon retirement, termination of service, death or disability. A terminated participant with a balance of less than \$1,000 could be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 could still be automatically paid out if their balance was rolled into a qualified Individual Retirement Account. Distributions could be made at the participant's election prior to termination upon attainment of age 59 ½, hardship, disability, or deemed severance resulting from 30 days active duty in the uniformed services, as defined in the Plan document.

**Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the ERISA. Effective December 2022, the Plan Sponsor was acquired by Integrated Power Services. As a result of this transaction, effective January 1, 2024, the Plan was merged into an existing plan sponsored by Integrated Power Services. The Plan provided notice to employees that no further contributions would be made to the Plan including elective deferral contributions effective December 22, 2023, the blackout period. All existing account balances were transferred over during the blackout period and were completed by December 29, 2023. At such time, all participants in the Plan became immediately vested in all employer contribution account balances and sources.

**Note 2 - Significant Accounting Policies****Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

### **Use of Estimates**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determined the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Interest income was recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported on the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

### **Contributions**

Participant contributions and QACA safe harbor matching contributions were recorded in the year in which the employee contributions are withheld from compensation.

### **Notes Receivable from Participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and are expensed when they are incurred.

### **Payments of Benefits**

Benefit payments to participants were recorded upon distribution.

### **Expenses**

The Plan's expenses were paid by either the Plan or the Company, as provided by the Plan document. Expenses that were paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that were paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses were included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

**Note 3 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds (including money market mutual funds) – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Common collective funds – Valued at fair value based on the NAV of units held of the collective fund. The NAV, as provided by the trustee is used as a practical expedient to estimate fair value. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

(I) The EB MaGIC 95 Stable Value Fund's objective is to protect principal while providing a reasonable level of income together with stability of principal. To achieve this, the fund invests in a diversified portfolio which includes synthetic GICs, which are high-quality debt securities that are insulated from market volatility by a bank-issued or insurance company-issued wrap contract; guaranteed investment contracts (GICs), which are obligations of credit-worthy life insurance companies; and cash and equivalents.

### Note 4 - Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company (the trustee of the Plan).

### Note 5 - Tax Status

The Plan used a pre-approved plan document sponsored by Capital Group Retirement Plan Services which received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

During the plan year ended December 31, 2023 and 2022, the Plan had certain operational and administrative issues occur. In order to prevent the Plan from incurring a qualification defect, the Plan's sponsor has taken the necessary corrective action outlined in Note 8. The Plan Sponsor believes the Plan has maintained its tax-exempt status. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 - Related Party and Party-In-Interest Transactions**

Certain Plan investments consisted of mutual funds managed by American Funds or units of a common collective fund (CCF) managed by KeyBank, NA. American Funds is an affiliate of Capital Bank and Trust Company, the trustee, as defined by the Plan. American Funds also provided certain sub-account recordkeeping for the CCF managed by KeyBank, NA. As described in Note 2, the Plan paid certain expenses related to the Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under the ERISA.

**Note 7 - Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8 - Delinquent Participant Contribution**

It was noted in 2022 and 2021, that there were delays by the Company in submitting participant deferrals and loan repayments to the trustee in aggregate amounts of \$142 and \$48,606, respectively. Delays in remitting contributions to the trustee were due to administrative errors, and the Company will make contributions to the affected participant's account to compensate those participants for potential lost income due to the delay.

**Note 9 - Transfer to Integrated Power Services Retirement Savings Plan**

As disclosed in Note 1, the Plan Sponsor was acquired by Integrated Power Services in December 2022. In December 2023, all participants with account balances were transferred into the Integrated Power Services Retirement Savings Plan for a total of \$14,928,455.

**Note 10 - Subsequent Events**

The Plan was merged into the Integrated Power Services Retirement Savings Plan effective January 1, 2024, due to the Plan Sponsor being acquired by Integrated Power Services in December of 2022.

The Plan Sponsor has evaluated subsequent events through October 11, 2024, the date which the financial statements were available to be issued.
