Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

Note 1 - Plan Description

The following description of JIT Packaging, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that began on February 1, 2017 and is available to eligible employees of JIT Packaging, LLC (the "Company"). Participation in the Plan is strictly voluntary, and employees can elect to participate after attaining age 21 and completing two months of eligible service, as defined by the plan document. All eligible employees on November 1, 2016 became immediately eligible on February 1, 2017. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company was acquired by Box Acquisitions, LLC (d/b/a Box Partners, LLC) during April 2023. On January 1, 2024, the Plan merged into the Box Partners, LLC 401(k) Plan and was simultaneously terminated (see Note 8).

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Certain participant contributions in 2022 were paid after the time frame required by the Department of Labor. The Company remitted these contributions and their related lost earnings to the Plan during 2023.

The Plan provides for safe harbor matching contributions of 100 percent of the participant's contribution up to 3 percent of the participant's compensation, plus 50 percent of the participant's contribution between 3 and 5 percent of compensation. The Company may also make discretionary qualified nonelective contributions to the Plan. The Company did not make any discretionary qualified nonelective contributions during 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants' contributions, the employer matching contributions, and the employer discretionary contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1 percent above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

Note 1 - Plan Description (Continued)

Benefit Payments

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age in the form of a lump-sum amount equal to the vested balance of a participant's account.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Empower Trust Company, LLC and Empower Annuity Insurance Company of America or their affiliates. Empower Trust Company, LLC and Empower Annuity Insurance Company of America are the trustees of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

The Plan provides for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

Termination

As further discussed in Note 8, on January 1, 2024, the Company merged the Plan into the Box Partners, LLC 401(k) Plan and simultaneously terminated the Plan in accordance with the provisions set forth in the plan document and ERISA.

As noted above, participants are fully vested in all contribution types and continued to remain fully vested as participants of Box Partners, LLC 401(k) Plan.

Note 2 - Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for its fully benefit-responsive investment contract, which is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. See Note 6 for a discussion of investments valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's management determines the Plan's valuation policies utilizing information provided by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively, the "Trustees"). See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

December 31, 2023 and 2022

Note 2 - Summary of Significant Accounting Policies (Continued)

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2023 or 2022. If a participant ceases to make scheduled repayments and the plan administrator deems the note receivable to be in default, the note receivable balance is reduced and a benefit payment recorded.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 10, 2024, which is the date the financial statements were available to be issued. During April 2023, the Company was acquired by Box Acquisitions, LLC (d/b/a Box Partners, LLC). As part of the integration following the acquisition, on January 1, 2024, the Company merged the Plan into the Box Partners, LLC 401(k) Plan and simultaneously terminated the Plan (see Note 8).

Note 3 - Certified Information

Empower Trust Company, LLC and Empower Annuity Insurance Company of America hold the Plan's investments and participant notes receivable and execute all related transactions during the periods under audit. The investment and participant notes receivable balances and related income included in the accompanying financial statements are based solely on information certified by Empower Trust Company, LLC and Empower Annuity Insurance Company of America.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Note 5 - Fair Value Measurements (Continued)

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodology has been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Note 6 - Investment Contracts

For the period from January 1, 2023 through December 29, 2023 and the year ended December 31, 2022, the Plan had a benefit-responsive investment contract with Empower Annuity Insurance Company of America (the "Guaranteed Interest Fund"). Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower Annuity Insurance Company of America is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a quarterly basis for resetting and there is no stated minimum or maximum interest rate. When establishing interest crediting rates for this product, Empower Annuity Insurance Company of America considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Note 6 - Investment Contracts (Continued)

Certain events limit the ability of the Plan to transact at contract value with Empower Annuity Insurance Company of America. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (iii) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is not probable. There are no events that allow the issuer to terminate the contract prior to the scheduled maturity date and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time. The contract was liquidated at contract value in 2023.

Note 7 - Reconciliation of the Financial Statements to Form 5500

The transfer out described in Note 8, was recorded on the 5500 as of December 31, 2023. As a result, the change in net assets available for benefits differs from the financial statements by \$5,558,866. Note 8 - Subsequent Event - Plan Transfer

During April 2023, the Company was acquired by Box Acquisitions, LLC (d/b/a Box Partners, LLC). As part of the integration following the acquisition, on January 1, 2024, the Company merged the Plan into the Box Partners, LLC 401(k) Plan and simultaneously terminated the Plan.

All of the participants were already fully vested in all contributions and related earnings thereon, and the participants continued to remain fully vested as participants of the Box Partners, LLC 401(k) Plan.

In preparation for the merger and termination, all of the Plan's participant investment balances in the amount of \$5,460,040 were liquidated on December 29, 2023 and were in transit as of December 31, 2023. These investments, along with contribution and participant notes receivable balances, were received into the Box Partners, LLC 401(k) Plan on January 2, 2024.
