Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of New England Baptist Hospital 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA ("ERISA Section 103(a)(3)(C) audit"). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

Prior to January 1, 2009, records were maintained at a contract, not plan, level; therefore, management has not maintained, and Prudential Insurance Company of America ("Prudential") did not provide, sufficient accounting records and supporting documentation relating to certain annuity contracts and custodial accounts issued to current and former employees, and supporting documentation is not adequate to assure the completeness and accuracy of the amounts included in the financial statements. Accordingly, we were unable to apply auditing procedures sufficient

to determine the extent to which the financial statements have been affected by these conditions.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan’s financial statements in accordance with auditing standards generally accepted in the United States of America (“GAAS”) and to issue an auditor’s report. However, because of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits.

The following description of the New England Baptist Hospital 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a complete description of the Plan’s provisions.

General

The Plan was a defined contribution plan established under Section 403(b) of the Internal Revenue Code of 1986, as amended (“IRC”). All employees of the New England Baptist Hospital and Subsidiaries (“Hospital” or “Plan Sponsor”) were eligible to participate in the Plan as soon as administratively practical. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The plan sponsor and plan administrator was the Hospital. Upon the formation of Beth Israel Lahey Health (“BILH”) on March 1, 2019, the Hospital became an affiliate of BILH, its sole corporate member. BILH was formed through the combination of hospitals and other affiliates of three legacy health care systems based primarily in the Eastern Massachusetts market, including the former CareGroup system, the former Lahey Health System, and the Seacoast Health System. The Board of Directors has delegated responsibility for oversight of the Plan to BILH, who has delegated to the BILH Retirement Plans Committee the responsibility to oversee the Plan, including administrative matters, and to determine the appropriateness of the Plan’s investment offerings as well as to monitor investment performance.

Effective December 31, 2023, the Plan was restated and merged into the Beth Israel Lahey Health 403(b) Retirement Savings Plan and the sponsorship of the plan was transferred to BILH. Concurrent with the merger, the assets of the Plan, comprised of \$158,432,092 investments and \$1,291,615 notes receivable from participants, were transferred to the Beth Israel Lahey Health 403(b) plan as noted in the accompanying statement of changes in net assets available for benefits.

Contributions

Each year, participants could contribute up to 100% of pre-tax eligible compensation, as defined in the Plan, subject to Internal Revenue Service (“IRS”) limitations. Participants who have attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”). Participants directed the investment of their contributions into various investment options offered by the Plan.

Participants who were eligible for the employer match received 3% of the participant’s base pay, up to 100% of the participant’s contribution, per pay period. However, for payroll periods beginning on and after February 14, 2010, no matching contributions would be made with respect to a participant who was a “90% Grandfathered Employee” under the New England Baptist Hospital Retirement Plan, unless and until the Hospital determined otherwise in its discretion; in which case, a matching contribution shall be made to the extent determined by the Hospital for such participants. In general, a “90% Grandfathered Employee” was a fully vested participant in the New England Baptist Hospital Retirement Plan for whom the sum of (i) his or her age (next birthday) as of February 10, 2010, and (ii) the product of 1.5 and his or her total accrual service under the New England Baptist Hospital Retirement Plan as of September 30, 2009, was equal to or greater than 93.

In addition, the Hospital made a core contribution on behalf of all benefit eligible employees equal to 2% of such participant's base pay for the payroll period for those participants who had one year of service and were not vested in an accrued benefit under the New England Baptist Hospital Retirement Plan.

Participant Accounts

Each participant's account was credited with the participant's contributions and the Hospital's contributions as well as allocation of plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were vested immediately in their contributions and the Hospital's contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. Each loan shall be repaid in substantially equal installments over the term, not to exceed five years (or an extended repayment period for the purchase of a primary residence). The loans were secured by the balance in the participant's account and bore an interest rate which was commensurate with local prevailing interest rates as determined by the plan administrator. Principal and interest were paid by the participant directly to Fidelity Management Trust Company ("Fidelity"), the custodian of the Plan.

Payment of Benefits

Amounts could be distributed to participants only (i) upon termination of employment, (ii) upon attaining the age of 59½, or (iii) upon demonstration by the participant to the plan administrator that the participant is suffering from "hardship" (as defined in applicable regulations promulgated or to be promulgated pursuant to Section 401(k) of the IRC of standards established by the Secretary of the Treasury or his delegate). On termination of service, participants could elect to receive their distributions equal to the value of their account in either a lump-sum amount or in a series of installments. In addition, participants could elect to roll their account into another qualified plan.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and

assumptions that affect the reported amounts of assets and liabilities, and changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments, other than fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

The Plan's fully benefit-responsive investment contracts (Note 5) are valued at contract value. Contract value is the relevant measurement because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment transactions are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan custodian deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Hospital. Expenses that are paid by the Hospital are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

The plan recordkeeping agreement provides for an annual payment by the recordkeeper to the Plan of \$38,500, payable quarterly in arrears, for the year ended December 31, 2023. The Hospital may direct the recordkeeper to reimburse the Hospital for fees and expenses associated with services provided to the Plan. Amounts unused for expenses may be allocated to participant accounts, as outlined in the amendment. For the year ended December 31, 2023, \$164,519 were used for expenses and \$27,981 were allocated to participants.

The Plan also provides for revenue sharing agreements with various investment brokers of the Plan's investments. The total revenue credit income amounted to \$192,500 for the year ended December 31, 2023. The revenue credit can be used to pay for plan expenses or to offset employer's

contributions. As of December 31, 2023, there was no revenue credit that remained unused and available.

Annual Reporting Requirements

Prior to January 1, 2009, Prudential Insurance Company of America (“Prudential”) maintained records at a contract level, not plan level, and administratively decided not to provide accounting records and supporting documentation at the participant or plan level relating to certain annuity and custodial accounts issued to current and former employees. As such, neither the Plan Sponsor nor Prudential have been able to produce sufficient records and supporting documents relating to certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009. As a result, the completeness and the accuracy of the annuity and custodial accounts, related investment income, and distributions related to these accounts, if any, could not be determined.

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2024, the date the financial statements were available to be issued.

3. Certified Investments

Certain information disclosed in the accompanying financial statements related to investments and notes receivable from participants held as of December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, Prudential, and MetLife Life Insurance Company (“MetLife”), qualified institutions.

4. Fair Value Measurements

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none">• Quoted prices for similar assets or liabilities in active markets;• Quoted prices for identical or similar assets or liabilities in inactive markets;• Inputs other than quoted prices that are observable for the asset or liability;• Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual Funds

Valued at the daily closing net asset value ("NAV") as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed Brokerage Account

Valued at the closing price reported in the active markets in which the individual securities are traded. A self-directed brokerage account which provides the options to invest in several eligible mutual funds is offered by Fidelity or other companies available through the Fidelity Funds Network. Account assets not invested in individual mutual funds will be held in Fidelity Cash Reserves, a money market mutual fund.

Pooled Separate Accounts

The pooled separate accounts are valued based on the observable NAV of the underlying investments. NAV is used as a practical expedient for fair value. The pooled separate accounts include asset allocation funds, aggressive growth funds, conservative funds, growth and income funds, growth funds, and income funds. When quoted prices are not available for identical or similar securities, the underlying investments are valued under a discounted cash flows approach that maximizes observable inputs, such as current yields of similar instruments, but includes adjustments for certain risks that may not be observable, such as credit and liquidity risks. There are no unfunded commitments, and the redemption frequency and redemption notice period are both daily.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Fully Benefit-Responsive Investment Contracts

The Prudential Guaranteed Interest Account is a traditional fully benefit-responsive guaranteed annuity contract available as an investment option to plan participants that is fully and unconditionally guaranteed by Prudential. When participants choose to allocate a portion of their retirement savings to the Prudential Guaranteed Interest Account, the principal is held in a general account, which accrues interest daily. The participant's principal, plus a specified minimum rate of interest, is guaranteed by Prudential. The interest rates are set by Prudential at the beginning each calendar quarter. The interest rates are credited based upon a number of factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within Prudential's general account. The minimum interest rate under the contract is 3.10%.

A total transfer of the contract to other financial institutions would limit the ability of the Plan to transact at contract value with Prudential. The plan administrator believes that the event that would limit the Plan's ability to transact at contract value with participants is not probable of occurring.

There are no events that would allow Prudential to terminate the contracts with the Plan at an amount other than contract value.

The MetLife GTS Fixed Account is a traditional fully benefit-responsive guaranteed annuity contract available as an investment option to plan participants that is fully and unconditionally guaranteed by MetLife. When participants choose to allocate a portion of their retirement savings to the MetLife GTS Fixed Account, the principal is held in a general account, which accrues interest daily. The participant's principal, plus a specified minimum rate of interest, is guaranteed by MetLife. The interest rates are set by MetLife at the beginning each calendar quarter. The interest rates are credited based upon a number of factors, including, but not limited to, the level of net investment income that the Hospital can earn on its newly purchased general account assets, the absolute level of interest rates, the shape of the yield curve, how interest rates have moved since the inception of the contract, the minimum guaranteed interest rate, and interest rates on alternative investments. The minimum interest rate under the contract is 3.00%.

A termination of the contract or transfer to another financial institution, initiated by the Plan, would limit the ability of the Plan to transact at contract value with MetLife. The plan administrator believes that the event that would limit the Plan's ability to transact at contract value with participants is not probable of occurring.

There are no events that would allow MetLife to terminate the contracts with the Plan at an amount other than contract value.

The New York Life Guaranteed Interest Account is a traditional fully benefit-responsive guaranteed annuity contract available as an investment option to plan participants that is fully and unconditionally guaranteed by New York Life Insurance Company. When participants choose to allocate a portion of their retirement savings to the New York Life Guaranteed Interest Account, the principal is held in a general account, which accrues interest daily. The participant's principal, plus a specified minimum rate of interest, is guaranteed by New York Life Insurance Company. The interest rates are set by New York Life Insurance Company every January 1 and July 1. The interest rates are credited based upon a number of factors, including but not limited to, current economic and market conditions and the general interest rate environment. The contract was terminated in 2021 at contract value and is no longer an investment option for the Plan.

The contract value for fully benefit-responsive investments amounted to \$-0- and \$2,109,041 for the years ended December 31, 2023 and 2022, respectively.

6. Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments are managed by Fidelity Investments (an affiliate of Fidelity), Prudential, and MetLife, the custodians as defined by the Plan, and therefore, these transactions qualify as exempt party-in-interest transactions. In addition, Fidelity Workplace Services, LLC is the plan recordkeeper, and therefore, these transactions qualify as exempt party-in-interest transactions. Notes receivable from participants are also exempt party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment. The Hospital pays directly any other fees related to the Plan's operations.

7. Tax Status

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform to the sample language provided by the IRS. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b). The plan administrator believes that the Plan is currently designed and operating in accordance with the applicable requirements of section 403(b) of the IRC and, therefore, believes that the Plan is qualified and continues to be tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.
