Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of Northeast Health System 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA ("ERISA Section 103(a)(3)(C) audit"). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

Prior to January 1, 2009, records were maintained at a contract, not a plan, level; therefore, management has not maintained, and Lincoln National Life Insurance Company did not provide, sufficient accounting records and supporting documentation relating to certain annuity contracts and custodial accounts issued to current and former employees, and supporting documentation is not adequate to assure the completeness and accuracy of the amounts included in the financial statements. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements have been affected by these conditions.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”), and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America (“GAAS”) and to issue an auditor's report. However, because of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

1. Description of the Plan

The following description of the Northeast Health System 403(b) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description and the plan document for a more complete description of the Plan’s provisions.

General

The Plan, established on January 1, 2007, and most recently restated December 1, 2017, is a contributory defined contribution plan that covered all eligible employees of Northeast Health System, Inc. (the “Company” or “Plan Sponsor”) and affiliated organizations (see note below). All employees are eligible to participate upon employment with the Company, except for those employees whose contributions would be \$200 or less. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Board of Trustees has delegated responsibility for oversight of the Plan to Beth Israel Lehey Health (“BILH”), who has delegated to the BILH Retirement Plans Committee the responsibility to oversee the Plan, including administrative matters, and to determine the appropriateness of the Plan’s investment offerings as well as to monitor investment performance.

Affiliation and Entity

Effective May 1, 2012, Northeast Health System, Inc. and Lahey Clinic Foundation, Inc. completed an affiliation agreement. This affiliation established Lahey Health System, a new parent organization.

Effective July 1, 2014, Northeast Health System, Inc. is no longer the parent corporation of the affiliated entities listed above. Northeast Health System, Inc. is a subsidiary of Lahey Health System.

Effective September 27, 2017, the Board executed a resolution to provide for a 2017 plan year matching contribution and fully vest the account balances for employees of Seacoast Nursing and Rehabilitation Center whose employment with Northeast Health System ended September 30, 2017, as a result of a business transaction.

Employees of the following Northeast Health System, Inc. affiliated employers are covered under the Plan through participation agreements.

Effective July 1, 2014, notwithstanding the above, prior service will be credited solely for eligibility and vesting purposes for services performed for Lahey (and affiliates) and Winchester Hospital (and affiliates), as determined under the 403(b) plans sponsored by such entities, if the employee is employed by the employer on or after July 1, 2014, and transfers directly to the employer from such entity. Prior service will not receive credit for allocation purposes. Notwithstanding the

foregoing, no employee shall be credited with more than one vesting year of service for any plan year.

Effective December 31, 2023, the Plan was restated and merged into the Beth Israel Lahey Health 403(b) Retirement Savings Plan, and the sponsorship of the plan was transferred to BILH. Concurrent with the merger, the assets of the Plan were transferred to the Beth Israel Lahey Health 403(b) plan as noted in the accompanying statement of changes in net assets available for benefits.

The Plan description and accounting policies represent the on-going Plan prior to the merger into the Beth Israel Lahey Health 403(b) Retirement Savings Plan.

Contributions

Each year, participants elect to defer up to the maximum percentage allowable by the Internal Revenue Service (“IRS”) of pretax annual compensation, as defined in the Plan. Participants who attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct their contributions into various investment options offered by the Plan.

Certain of the affiliated employers covered under the Plan offer employer contributions. The eligibility of the employer contributions is defined in each adopting agreement as part of the plan document. The employer matching contributions were as follows:

- CAB Health and Recovery Services, Inc. (“CAB”) and Northeast Behavioral Health Corporation (“NBH”) determine a discretionary match each year. For 2023, NBH matched 100% of the first 6% of compensation that a participant contributes to the Plan for a maximum matching contribution of 6%. Employees must have a year of service, be age 18, and be employed on the last day of the plan year to receive the employer contribution.
- Herrick House determines a discretionary match each year. For 2023, the match was 50% of the first 5% of compensation that a participant contributes to the Plan for a maximum matching contribution of 2.5%. Employees must have a year of service and be employed on the last day of the plan year to receive the employer contribution.
- Northeast Professional Registry of Nurses, Inc., Northeast Home Care (“NEHC”), North Shore PRN, Northeast Senior Health Corporation, Spectrum ADH, CareGroup Parmenter, and Northeast Link determine a discretionary match each year. For 2023, the match was 50% of the first 6% of compensation that a participant contributes to the Plan for a maximum matching contribution of 3%. Employees must have a year of service and be employed on the last day of the plan year to receive the employer contribution.

Participants Accounts

Each participant's account is credited with the participants' contributions, an allocation of (i) the Company's contribution, if any, (ii) plan earnings, and (iii) service credits. Allocations are based on participant earnings and account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Effective December 1, 2017, all participants with a balance in the Plan were granted accelerated 100% vesting in their accounts.

In addition, effective December 1, 2017, all future participants will be vested based on a three-year cliff vesting schedule.

At December 31, 2023 and 2022, forfeited non-vested employer contributions totaled \$-0- and \$135,530, respectively. These amounts will be used to reduce future employer contributions and plan expenses. Forfeitures used to reduce employer contributions during the year ended December 31, 2023, amounted to \$129,012.

Participant Loans

Participants may borrow, as permitted under plan provisions, from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their elective deferral account balance. Loan terms range from one month to five years or up to 15 years for the purchase of a primary residence. The Plan only allows one loan per participant. The loans are secured by the balance in the participant's account and bear interest at prime interest rate plus .5%. Principal and interest are paid ratably through payroll deductions for loans taken prior to July 1, 2015. Effective December 1, 2017, all participant loans are repaid through automatic clearing house ("ACH") payments from the participant's bank account and not through payroll deduction.

Payment of Benefits

Upon termination of service, or upon death, disability, or retirement, a participant will receive a lump-sum amount equal to the vested value of his or her account or another form of payment as described in the plan document.

The Plan provides for in-service withdrawals of deferral contributions for age 59½ distributions and hardships, as described in the Plan.

2. Summary of Accounting Principles

Basis of Accounting

The accompanying financial statements are prepared using the accrual basis of accounting, in accordance with generally accepted accounting principle in the United States ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value other than investments that are considered fully benefit responsive. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln National Life Insurance Company ("Lincoln"), represents the transferred balance and earnings, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are valued at the unpaid principal balance plus accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

Annual Reporting Requirements

Prior to January 1, 2009, Lincoln maintained records at a contract, not plan, level and administratively decided not to provide accounting records and supporting documentation at the participant or plan level relating to certain annuity and custodial accounts issued to current and former employees. As such, neither the Plan Sponsor nor Lincoln have been able to produce sufficient records and supporting documents relating to certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009. As a result, the completeness and the accuracy of the annuity and custodial accounts, related investment income, and distributions related to these accounts, if any, could not be determined.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2024, which is the date the financial statements were available to be issued.

3. Information Certified by the Plan's Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Fidelity Management Trust Company ("Fidelity") and Lincoln, the custodians of the Plan and qualified institutions, have certified as being complete and accurate the investments and notes receivable from participants on the statements of net assets available for benefits and the investment activity reflected in the statement of changes in net assets available for benefits as of December 31, 2023 and 2022, and the investment income and interest income on notes receivable from participants reflected on the statement of changes in net assets available for benefits for the year ended December 31, 2023. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified as complete and accurate by the custodians.

4. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

Level 1 - Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 - Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 - Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

The following is a description of the valuation methodologies used by the Plan. There have been no changes in the valuation methodologies at December 31, 2023 and 2022.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Mutual funds are valued using Level 1 inputs.

Fidelity self-directed brokerage accounts represent a brokerage account that participants are invested in mutual funds and cash reserves. The plan is individual investments in the self-directed brokerage accounts are valued on the basis of readily determinable market prices.

The valuation method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan was fully merged into the Beth Israel Lahey Health 403(b) Retirement Savings Plan on December 29, 2023, resulting in an ending balance of \$-0- as of December 31, 2023.

5. Investment Contract with Insurance Company

Effective June 15, 2017, the investments and participant accounts of the former Northeast Health Systems Non-ERISA 403(b) Plan merged into the Plan. In connection with this transaction, there were certain individual accounts maintained and invested in separate accounts by Lincoln amounting to \$1,810,823 at June 15, 2017, in individual annuities that continue to remain as a plan asset of the Plan, a fully benefit responsive Group Annuity Guaranteed Fund, and will remain a plan asset until such time as the funds are distributed. No additional contributions can be made to these accounts.

Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan's documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

6. Related-Party and Parties-in-Interest Transactions

Certain plan investments are managed by Fidelity and Lincoln. Fidelity and Lincoln are the custodians and recordkeepers for the Plan, and therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

Fidelity provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement ("MSA") between the Company and Fidelity. Fidelity receives revenue from mutual fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan. If the revenue received by Fidelity from such mutual fund service providers exceeds the amount owed under the MSA, Fidelity remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay plan expenses or allocated to the accounts of the participants. During 2023, the excess amounts received by the Plan is \$243,533, which was used to administrative expenses and allocated to participants. This is included in other income. The Plan or the Company may make a payment to Fidelity for administrative expenses not covered by revenue sharing.

7. Income Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code ("IRC"). The terms of the Plan have been prepared to conform to the sample language provided by the IRS in Revenue Procedure 2007-71. The plan administrator believes that the Plan is designed and being operated in accordance with the IRC to maintain the tax-exempt status for plan participants under Section 403(b).

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their accounts. See Note 1 for more information on the plan merger.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
