Note 1 - Plan Description

The following description of the Superfeet Worldwide, Inc. Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan is a profit-sharing plan established by Superfeet Worldwide LLC (the Company or Employer) under Section 401(a) of the Internal Revenue Code (IRC). The Plan was previously an Employee Stock Ownership Plan established under Section 4975(e)(7) of the IRC. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Termination - On June 15, 2021 (Closing Date), 100% of the Company stock was purchased by Superfeet Holdco, LLC and an amendment was adopted to terminate the Plan. Following the adoption to terminate the Plan until all assets were liquidated, Trust assets were invested primarily in investments designed to preserve principal consistent with the requirements of ERISA and trust assets are no longer invested in employer stock.

Approximately 85% of plan assets totaling \$95.5 million were paid in cash to participants in September 2021. Upon receipt of the final determination letter from the Internal Revenue Service (IRS), the remaining plan assets were distributed to participants in cash and the plan was terminated on May 3, 2024.

Plan Administration - The Plan is administered by the Advisory Committee comprised of members of the Company's management as appointed by the Board of Directors of the Company. Alerus Financial serves as the Plan's trustee (Trustee). Randall & Hurley provides record-keeping services. Although certain administrative functions are performed by officers or employees of the Company, no such officer or employee receives compensation from the Plan.

Eligibility and Participation - No individuals are eligible to become a participant in the Plan on or after the Closing Date discussed above.

Contributions - No further contributions will be made to the Plan after the Closing date except for contributions that have been accrued on behalf of participants or beneficiaries on or before the Closing Date, or that are otherwise required by the IRS in connection with the issuance of a favorable determination letter with respect to the termination of the Plan. There were no contributions made for the period ended May 3, 2024 and the year ended December 31, 2023.

Participant Accounts - Each participant's account is credited with Company contributions (if any), other income and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting of Benefits - As of the Closing Date, participants became fully vested in their account balances.

Note 1 - Continued

Distributions to Participants - Following termination of the Plan, the Trust was maintained until the accounts of all participants were distributed. Distributions to participants and beneficiaries were made in one or more payments as determined by the Trustee. To the extent any participant did not provide directions as to the payment of the distribution of their account balance, the Trustee transferred all amounts remaining in such participant's account to an individual retirement account in accordance with DOL Field Assistance Bulletin 2014-01. All distributions were made in cash.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements have been prepared on the liquidation basis of accounting as of May 3, 2024, December 31, 2023 and 2022 and for the period ended May 3, 2024 and the year ended December 31, 2023.

Use of Estimates - The preparation of the financial statements in conformity with generally accepted accounting principles in the United States of America (GAAP) requires management to make significant estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the plan year.

Other Income - Other income represents a gain pertaining to the release of contingencies associated with certain terms of the sale of the Company stock discussed above. Escrow funds totaling \$0 and \$1,106,675 were deposited in the Plan and recognized as other income for the period ended May 3, 2024 and the year ended December 31, 2023, respectively.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Transaction based fees for benefit payments are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

Subsequent Events - The Plan's management has evaluated subsequent events through October 14, 2024, the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements

GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022. There were no assets held at May 3, 2024.

Money Market Fund - Valued at cost plus accrued interest, which approximates fair value.

Note 4 - Certified Information

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at May 3, 2024, December 31, 2023 and December 31, 2022, and investment income or loss for the period ended May 3, 2024 and the year ended December 31, 2023, that is disclosed in the accompanying financial statements and supplementary information, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Alerus Financial, N.A. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 5 - Related Party and Party-in-Interest Transactions

The Plan pays certain expenses related to plan operations to various service providers. These transactions are party-in-interest transactions.

Note 6 - Tax Status

The Plan obtained its most recent determination letter dated December 23, 2023, in which the IRS stated that the termination of the Plan doesn't affect its qualification for federal tax purposes.

The plan administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Company has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 7 - Concentrations of Credit Risk

Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of the Vanguard Federal Money Market fund. This investment represented 100% of total plan investments at December 31, 2023 and 2022. The Plan's management seeks to limit its credit exposure by working with high credit quality institutions.
