Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Win-Dor, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2023 and 2022, the related statement of changes in net assets available for plan benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution, as of December 31, 2023 and 2022 and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of Win-Dor, Inc. 401(k) Profit Sharing Plan (the “Plan”) is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a qualified, defined-contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was established in 2000 by Win-Dor, Inc. (the Company or “Employer”) to provide benefits to eligible employees as defined in the Plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (IRC), as amended.

Administration

The Plan is administered by the Plan Committee. Charles Schwab Bank Trust (Trustee) holds the Plan’s assets. Plan Perfect, Inc. is the recordkeeper and processes and maintains the records of participant data.

Eligibility

Non-excluded employees of the Company who are over the age of twenty-one (21) are eligible to participate in the Plan upon the completion of 1,000 hours during the first six (6) months of employment or one (1) year of service. Eligible employees are automatically enrolled in the Plan at 3% of the participant’s eligible compensation, as defined, and may elect a permissible withdrawal from the Plan no later than 90 days after the date of the first default elective deferral. Eligible employees may enter the Plan on the first day of the first and seventh month of the Plan year, after meeting eligibility requirements. In order for the Plan to follow IRS rules, the Plan applied the eligibility requirements of an affiliate plan during the year ended December 31, 2023. The affiliated plan eligibility includes all employees, excluding employees covered by a collective bargaining agreement, leased employees and nonresident aliens of the Company that are at least eighteen (18) years of age and have completed 1,000 hours during the first three (3) months of employment or one (1) year of service, as defined in the affiliated Plan’s document.

Participant Contributions

Participants may contribute, on a pretax basis, up to a maximum dollar amount as specified in the IRC. Eligible employees are automatically enrolled in the Plan at 3% of the participant’s eligible compensation, as defined, and may elect a permissible withdrawal from the Plan no later than 90 days after the date of the first default elective deferral. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make Roth 401(k) contributions and roll over amounts representing distributions from other qualified defined-benefit or contribution plans. Contributions withheld are invested in accordance with the participant’s direction.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Employer Contributions

The Company may make a discretionary matching contribution on behalf of each eligible participant in an amount equal to a percentage of the eligible contributions made by each eligible participant during the contribution period. For the year ended December 31, 2023, the Company made no discretionary matching contributions to the Plan.

The Company contributes a safe harbor contribution on behalf of each eligible participant in an amount equal to 3% of the participant's eligible compensation. For the year ended December 31, 2023, the Company made safe harbor contributions of \$292,543.

The Company may, in its sole discretion, make a profit-sharing contribution on behalf of any or all eligible participants, as defined, who are employed by the Company on the last day of the Plan year. For the year ended December 31, 2023, the Company made a profit sharing contribution of \$322,334.

Participant Accounts

Each participant's account is credited with the participants' contributions and allocations of the Employer's safe harbor and profit-sharing contributions, plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Elections

Participants may direct their salary deferral contributions and the Company contributions, as desired, in any of several investment options held by the trustee. Participants may change their investment options any time throughout the year via the Internet website or using the automated telephone system offered by the trustee.

Vesting

Participants are immediately vested in their contributions and safe harbor matching contributions, including actual earnings thereon. Participants are vested in the discretionary matching and/or profit-sharing contributions plus earnings thereon is based on years of continuous service as follows:

Notes from Participants

Participants may borrow from their current account balance a minimum of \$1,000 up to a maximum equal to the lesser of 50%, reduced by the excess, if any, of the highest outstanding loan balance during the preceding 12-month period over the participant's outstanding loan balance as of the date such loan is made, or 50% of their vested balance. The notes receivable bear interest at 3.25% to 9.50% as of December 31, 2023 and 2022, respectively, and mature through April 2029. Notes are secured by the balance in the participant's account and bear interest at rates at prime rate plus one. Loans must be repaid within a five-year (5) period, unless the loan is used to purchase a principal residence which must be repaid within a ten year (10) period. Principal and interest are paid ratably through payroll deductions.

Benefit Payments

Upon normal retirement, retirement due to permanent disability, or death, participants or the participants' beneficiaries are eligible to receive their vested interest in funds either in the form of payments beginning at age 72 or in a lump-sum payment. The Plan can distribute all participant balances under \$5,000 without the request of the participant.

Financial Hardship Distributions

The Plan allows hardship withdrawals in accordance with IRS regulations. Among other things, the withdrawal must be necessary in light of immediate and heavy financial needs of the participant and is limited to certain purposes.

Forfeitures

Forfeitures may first be used to pay any administrative expenses and then any remaining forfeitures will be used to reduce any Employer matching contributions. As of December 31, 2023 and 2022, forfeited accounts totaled \$0 and \$815,208, respectively. Forfeitures of \$86,962 were used to pay administrative expenses and forfeitures of \$870,072 were used to fund 2023 Employer contributions for the year ended December 31, 2023.

Administrative Expenses

Most administrative expenses of maintaining the Plan are paid by the Company. Expenses paid by the Company are excluded from these financial statements. Loan application fees are charged to the individual participant's account.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates

The preparation of the Plan's financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein and, when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Notes from Participants

Notes from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2023 and 2022.

Investment Valuation and Income Recognition

Investments are reported at fair value or contract value. Fair value or contract value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements and Note 5 for a discussion on fully benefit-responsive investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Certain management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for applicable investments.

Payment of Benefits

Benefit payments are recorded when paid.

NOTE 3 – INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations (DOL) for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Bank Trust, the Trustee of the Plan, has certified to the completeness and accuracy of all investments reflected in the accompanying Statements of Net Assets Available for Plan Benefits as of December 31, 2023 and 2022, the Supplemental Schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2023, and the related investment activity reflected in the Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2023.

NOTE 4 – FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification Topic 820, *Fair Value Measurements and Disclosures* (ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Registered investment companies: Valued at the daily closing price as reported by the shares. Registered investment companies held by the Plan are open-ended shares that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The registered investment company shares held by the Plan are deemed to be actively traded

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan maintains investments in a stable value fund managed by Standard Insurance Company (“Standard”), which is determined to be fully benefit-responsive. Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The adjustment from fair value to contract value for the stable value fund is based on the contract value as reported to the Plan by Standard. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan’s investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 – FEDERAL INCOME TAX STATUS

The Plan has adopted a volume submitter 401(k) profit sharing plan sponsored by Plan Perfect Inc. The volume submitter plan has received an opinion letter from the Internal Revenue Service (IRS) as to the Plan's qualified status. The opinion letter has been relied upon by the Plan. The Plan Administrator and the trustee believe that although the Plan has been adopted after the date of opinion letter, the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS or the DOL. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in question.

NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan expenses were paid by the Company for maintaining the Plan. The Company does not expect reimbursement for these Plan expenses.

Certain Plan investments are managed by the Trustee. The Plan also holds notes receivable from participants. These transactions are considered party-in-interest transactions.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company, by action of its Plan Committee, has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, further contributions to the Plan shall cease and all participants who are affected by such termination shall become 100% vested. Net assets available for plan benefits would be distributed to the participants based on each participant's interest in the Plan.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

NOTE 10 – SUBSEQUENT EVENTS

On January 1, 2024, the Plan merged into the Pella Corporation 401(k) Savings Plan and adopted the Pella Corporation 401(k) Savings Plan as a participating employer.

Management has evaluated subsequent events through October 14, 2024, the date the financial statements were available to be issued.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Win-Dor, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2023 and 2022, the related statement of changes in net assets available for plan benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution, as of December 31, 2023 and 2022 and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The Schedule H, Line 4i – Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAP. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution, agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of Win-Dor, Inc. 401(k) Profit Sharing Plan (the “Plan”) is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a qualified, defined-contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was established in 2000 by Win-Dor, Inc. (the Company or “Employer”) to provide benefits to eligible employees as defined in the Plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (IRC), as amended.

Administration

The Plan is administered by the Plan Committee. Charles Schwab Bank Trust (Trustee) holds the Plan’s assets. Plan Perfect, Inc. is the recordkeeper and processes and maintains the records of participant data.

Eligibility

Non-excluded employees of the Company who are over the age of twenty-one (21) are eligible to participate in the Plan upon the completion of 1,000 hours during the first six (6) months of employment or one (1) year of service. Eligible employees are automatically enrolled in the Plan at 3% of the participant’s eligible compensation, as defined, and may elect a permissible withdrawal from the Plan no later than 90 days after the date of the first default elective deferral. Eligible employees may enter the Plan on the first day of the first and seventh month of the Plan year, after meeting eligibility requirements. In order for the Plan to follow IRS rules, the Plan applied the eligibility requirements of an affiliate plan during the year ended December 31, 2023. The affiliated plan eligibility includes all employees, excluding employees covered by a collective bargaining agreement, leased employees and nonresident aliens of the Company that are at least eighteen (18) years of age and have completed 1,000 hours during the first three (3) months of employment or one (1) year of service, as defined in the affiliated Plan’s document.

Participant Contributions

Participants may contribute, on a pretax basis, up to a maximum dollar amount as specified in the IRC. Eligible employees are automatically enrolled in the Plan at 3% of the participant’s eligible compensation, as defined, and may elect a permissible withdrawal from the Plan no later than 90 days after the date of the first default elective deferral. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make Roth 401(k) contributions and roll over amounts representing distributions from other qualified defined-benefit or contribution plans. Contributions withheld are invested in accordance with the participant’s direction.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Employer Contributions

The Company may make a discretionary matching contribution on behalf of each eligible participant in an amount equal to a percentage of the eligible contributions made by each eligible participant during the contribution period. For the year ended December 31, 2023, the Company made no discretionary matching contributions to the Plan.

The Company contributes a safe harbor contribution on behalf of each eligible participant in an amount equal to 3% of the participant's eligible compensation. For the year ended December 31, 2023, the Company made safe harbor contributions of \$292,543.

The Company may, in its sole discretion, make a profit-sharing contribution on behalf of any or all eligible participants, as defined, who are employed by the Company on the last day of the Plan year. For the year ended December 31, 2023, the Company made a profit sharing contribution of \$322,334.

Participant Accounts

Each participant's account is credited with the participants' contributions and allocations of the Employer's safe harbor and profit-sharing contributions, plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Elections

Participants may direct their salary deferral contributions and the Company contributions, as desired, in any of several investment options held by the trustee. Participants may change their investment options any time throughout the year via the Internet website or using the automated telephone system offered by the trustee.

Vesting

Participants are immediately vested in their contributions and safe harbor matching contributions, including actual earnings thereon. Participants are vested in the discretionary matching and/or profit-sharing contributions plus earnings thereon is based on years of continuous service as follows:

Notes from Participants

Participants may borrow from their current account balance a minimum of \$1,000 up to a maximum equal to the lesser of 50%, reduced by the excess, if any, of the highest outstanding loan balance during the preceding 12-month period over the participant's outstanding loan balance as of the date such loan is made, or 50% of their vested balance. The notes receivable bear interest at 3.25% to 9.50% as of December 31, 2023 and 2022, respectively, and mature through April 2029. Notes are secured by the balance in the participant's account and bear interest at rates at prime rate plus one. Loans must be repaid within a five-year (5) period, unless the loan is used to purchase a principal residence which must be repaid within a ten year (10) period. Principal and interest are paid ratably through payroll deductions.

Benefit Payments

Upon normal retirement, retirement due to permanent disability, or death, participants or the participants' beneficiaries are eligible to receive their vested interest in funds either in the form of payments beginning at age 72 or in a lump-sum payment. The Plan can distribute all participant balances under \$5,000 without the request of the participant.

Financial Hardship Distributions

The Plan allows hardship withdrawals in accordance with IRS regulations. Among other things, the withdrawal must be necessary in light of immediate and heavy financial needs of the participant and is limited to certain purposes.

Forfeitures

Forfeitures may first be used to pay any administrative expenses and then any remaining forfeitures will be used to reduce any Employer matching contributions. As of December 31, 2023 and 2022, forfeited accounts totaled \$0 and \$815,208, respectively. Forfeitures of \$86,962 were used to pay administrative expenses and forfeitures of \$870,072 were used to fund 2023 Employer contributions for the year ended December 31, 2023.

Administrative Expenses

Most administrative expenses of maintaining the Plan are paid by the Company. Expenses paid by the Company are excluded from these financial statements. Loan application fees are charged to the individual participant's account.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of the Plan's financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein and, when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Notes from Participants

Notes from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2023 and 2022.

Investment Valuation and Income Recognition

Investments are reported at fair value or contract value. Fair value or contract value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements and Note 5 for a discussion on fully benefit-responsive investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Certain management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for applicable investments.

Payment of Benefits

Benefit payments are recorded when paid.

NOTE 3 – INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations (DOL) for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Bank Trust, the Trustee of the Plan, has certified to the completeness and accuracy of all investments reflected in the accompanying Statements of Net Assets Available for Plan Benefits as of December 31, 2023 and 2022, the Supplemental Schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2023, and the related investment activity reflected in the Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2023.

NOTE 4 – FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification Topic 820, *Fair Value Measurements and Disclosures* (ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Registered investment companies: Valued at the daily closing price as reported by the shares. Registered investment companies held by the Plan are open-ended shares that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The registered investment company shares held by the Plan are deemed to be actively traded

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan maintains investments in a stable value fund managed by Standard Insurance Company (“Standard”), which is determined to be fully benefit-responsive. Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The adjustment from fair value to contract value for the stable value fund is based on the contract value as reported to the Plan by Standard. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan’s investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 – FEDERAL INCOME TAX STATUS

The Plan has adopted a volume submitter 401(k) profit sharing plan sponsored by Plan Perfect Inc. The volume submitter plan has received an opinion letter from the Internal Revenue Service (IRS) as to the Plan's qualified status. The opinion letter has been relied upon by the Plan. The Plan Administrator and the trustee believe that although the Plan has been adopted after the date of opinion letter, the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS or the DOL. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in question.

NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan expenses were paid by the Company for maintaining the Plan. The Company does not expect reimbursement for these Plan expenses.

Certain Plan investments are managed by the Trustee. The Plan also holds notes receivable from participants. These transactions are considered party-in-interest transactions.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company, by action of its Plan Committee, has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, further contributions to the Plan shall cease and all participants who are affected by such termination shall become 100% vested. Net assets available for plan benefits would be distributed to the participants based on each participant's interest in the Plan.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

NOTE 10 – SUBSEQUENT EVENTS

On January 1, 2024, the Plan merged into the Pella Corporation 401(k) Savings Plan and adopted the Pella Corporation 401(k) Savings Plan as a participating employer.

Management has evaluated subsequent events through October 14, 2024, the date the financial statements were available to be issued.
