Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Maple Grove Hospital Corporation 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 1, 2023, December 31, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the one-day period ended January 1, 2023 and the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter—Plan Merger

As discussed in Note 1 to the financial statements, on January 1, 2023, the Plan was merged into the North Memorial Health Care 401(k) Plan. In conjunction with the merger, all of the Plan's assets were transferred. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2022 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

THE ONE-DAY PERIOD ENDED JANUARY 1, 2023 AND THE YEAR ENDED DECEMBER 31, 2022
(Dollars in thousands)

1. DESCRIPTION OF THE PLAN

The following description of the Maple Grove Hospital Corporation 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

General—The Plan is a qualified defined contribution profit-sharing plan with elective deferral and employer matching features. Generally, all eligible employees may enter the Plan on the first day of the month following the date on which the employee has completed 30 days of service. Maple Grove Hospital Corporation (the “Company”), as plan administrator, controls and manages the operation and administration of the Plan.

On April 15, 2022, Maple Grove Hospital became a wholly owned subsidiary of North Memorial Health Care. The Maple Grove Hospital 401(k) Plan merged into the North Memorial Health Care 401(k) Plan effective as of January 1, 2023. Plan amendments were signed on December 22, 2022 to merge the two plans. There was a blackout period for plan participants from December 28, 2022 until the week of January 15, 2023 to allow time for the transfer of Maple Grove Hospital Corporation 401(k) Plan administrative records to the North Memorial Health Care 401(k) Plan, during which time plan participants were unable to change investment elections or request a loan or distribution. Administratively, Maple Grove Hospital 401(k) Plan assets were transferred to the North Memorial Health Care 401(k) Plan on December 30, 2022, the last business day in 2022, in order to have the assets available to participants in the North Memorial Health Care 401(k) Plan on January 3, 2023, the first business day in 2023.

Contributions—The Plan was established with certain safe harbor provisions. Under the safe harbor provisions, the Company matches 100% of employee contributions on the first 3% of covered compensation and 50% of the contributions from 3% to 5% of covered compensation, subject to certain Internal Revenue Code (IRC) limitations as defined in the Plan adoption agreement.

Participant Accounts—Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contribution; the Company’s matching contribution, if any; and Plan earnings and charged with withdrawals and an allocation of Plan losses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Payment of Benefits—Upon termination, death, or disability, participants may elect to receive benefits in the form of a lump-sum distribution, installment payment, or a direct rollover to an individual retirement account or another qualified employee benefit plan. However, if the participant’s vested account balance does not exceed \$5,000, it will automatically be distributed in accordance with the provisions of the Plan.

Investments—Participants may direct the investment of their account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily.

Vesting—Pursuant to safe harbor plan rules, participants are immediately vested in both their contributions and safe harbor contributions, plus earnings (losses) thereon. With respect to employer discretionary contributions, participants are vested 10%, 30%, 50%, 70%, and 100%, respectively, at the end of each year of the five years of vesting service. Matching contributions made while participants were part of the North Memorial Health Care 401K Plan and Trust, also become vested according to the same five-year graded vesting schedule as the nonelective contributions.

Forfeited Accounts—When certain terminations of participation in the Plan occur, the nonvested portion of the participant’s account, as defined by the Plan, represents a forfeiture. As of January 1, 2023, December 31, 2022, and 2021, forfeited nonvested accounts totaled \$0, \$48 and \$40, respectively. These accounts will be used to reduce future employer contributions. During the one-day period ended January 1, 2023 and the year ended December 31, 2022, there were no forfeited amounts used to reduce employer contributions.

Plan Termination—Although it has not expressed any intent to terminate the Plan, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, all of the assets of the Plan will be used to provide benefits according to the Plan. Upon termination of the Plan, a participant’s employer contributions account shall be fully vested.

Administrative Expenses—Administrative expenses of the Plan are paid by the Plan, as provided in the Plan document. Participants pay administrative costs for loans, distributions and qualified domestic relation orders. All investment management and transaction fees directly related to the Plan investments are paid by the participants and charged against the Plan’s earnings.

Notes Receivable from Participants—Participants may borrow from their individual accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years, but may extend past five years, to a maximum of 10 years, if the loan proceeds are used for the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. Participant loans are limited to 401(k) contribution and rollover contribution accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan utilizes various investment instruments, including mutual funds and investment contracts. Investment securities, in general, are exposed to various risks, such as interest rate, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the

near term and that such changes could materially affect the amounts reported in the financial statements.

Investment Valuation and Income Recognition—The Plan’s investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Personal choice retirement account funds are composed of mutual funds, which are valued based on quoted market prices in an active market, and cash and cash equivalents. The units of the stable value fund are stated at net asset value (NAV) practical expedient by the issuer of the fund based on the fair value of the underlying investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Receivable from North Memorial Health Care 401(k) Plan—The Plan’s receivable from the North Memorial Health Care 401(k) Plan is measured at the fair value of the plan assets transferred from the Plan to the North Memorial Health Care 401(k) Plan on December 30, 2022. As the merger described in Note 1 was not effective until January 1, 2023, the assets transferred were still attributable to the Plan as of December 31, 2022.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Payment of Benefits—Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not yet been paid, as of January 1, 2023, December 31, 2022 and December 31, 2021.

Excess Contributions Payable—The Plan is required to return contributions received during the Plan year in excess of the IRC limits.

Subsequent Events—Subsequent events were evaluated through October 12, 2023, the date the financial statements were available to be issued. Other than the Plan amendment disclosed in Note 1, no events have occurred that required consideration as adjustments to, or disclosures in the Plan’s financial statements.

3. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the information regarding the Plan as of December 31, 2022 and 2021 and for the year ended December 31, 2022, included in the Plan’s financial statements and supplemental schedule, that was prepared by or derived from information prepared by Empower Trust Company LLC in 2022 and Great-West Trust Company LLC in 2021, the trustee of the Plan, and furnished to the Plan administrator. In August 2022, certain operating companies within Empower’s

corporate group were renamed, including Great-West Trust Company LLC. The Plan administrator has obtained certification from the trustee that such information is complete and accurate.

4. FAIR VALUE OF FINANCIAL INSTRUMENTS

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value by creating a hierarchy for observable independent market inputs and unobservable market assumptions and expands disclosures about fair value measurements. The Plan classifies its investments into Level 1, which refers to securities valued using quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market, but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Valuation of Investments at Fair Value—Mutual funds and common collective trusts are valued at the closing price reported in the active market in which the individual security is traded. The personal choice retirement account holds mutual funds that are valued at the closing price reported in the active market in which the individual security is traded.

Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are notes receivable from participants. These transactions qualify as exempt party-in-interest transactions.
