***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Cokeva, Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

***Opinion***

NOTES TO FINANCIAL STATEMENTS  
December 31, 2023 and 2022

*NOTE 1:*    **DESCRIPTION OF PLAN**

The following description of the Cokeva, Inc. (Plan Sponsor) 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan was established January 1, 1997, to provide benefits for employees of the Plan Sponsor and the employees’ beneficiaries. The Plan is a defined contribution plan covering all employees who have attained the age of eighteen (18) years. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). John Hancock Trust Company LLC serves as the custodian of the Plan assets as well as the Plan’s trustee.

Effective January 1, 2022, the Plan was amended and restated to incorporate past amendments and to update the Plan document to reflect recent legislative and regulatory changes.

**Plan Year**

The plan year begins January 1<sup>st</sup> and ends December 31<sup>st</sup>.

**Contributions**

The Plan allows for the following types of contributions:

- **Employee Salary Deferral 401(k) Contributions**  
The Plan includes an elective salary deferral arrangement pursuant to Section 401(k) of the Internal Revenue Code (the “Code”). Employees may voluntarily contribute a percentage of their regular wages subject to various nondiscrimination tests and limitations prescribed by the Code.
- **Employee Roth Elective Deferral Contributions**  
Participants may make after-tax Roth elective deferral contributions.
- **Employer Nonelective Contributions**  
The Plan Sponsor may make nonelective contributions to the Plan equal to a discretionary amount as determined by the Plan Sponsor. Employer nonelective contributions are allocated to participants based on eligible compensation. The Plan Sponsor made no nonelective contributions to the Plan in 2023 and 2022.
- **Employer Profit Sharing Contributions**  
The Plan Sponsor may make discretionary profit sharing contributions to the Plan. Profit sharing contributions are allocated to participants based on eligible compensation. Participants must complete 1,000 hours of service during the Plan year to be eligible for employer profit sharing contributions. The Plan Sponsor elected not to make a profit sharing contribution to the Plan in 2023 or 2022.
- **Employer Matching Contributions**  
The Plan Sponsor may make a matching contribution to the Plan equal to a discretionary amount. Participants must be 18 years of age and have 6 months of service to be eligible for the employer matching contribution. The Plan Sponsor made a matching contribution of \$228,091 and \$239,162 in 2023 and 2022, respectively.
- **Employee Rollover Contributions from Another Qualified Plan**  
Participants may make rollover contributions from another qualified plan.

**NOTE 1: DESCRIPTION OF PLAN (Continued)**

**Participant Accounts and Allocations**

The Plan provides various investment fund options and allows participants to direct their investments. Investment earnings and losses are allocated to participants' accounts based on the actual earnings or losses of the investments selected. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participants vested account balance.

**Vesting**

Participants are always 100% vested in their salary deferral and employer qualified nonelective contributions.

Discretionary profit sharing employer contributions vest over a five-year period as follows:

1 year credited service	0%
2 years credited service	25%
3 years credited service	50%
4 years credited service	75%
5 years credited service	100%

Discretionary employer matching contributions vest over a four-year period as follows:

1 year credited service	25%
2 years credited service	50%
3 years credited service	75%
4 years credited service	100%

**Forfeitures**

Forfeitures from employer contributions may be used to reduce the amount of future employer contributions. The forfeiture balance was \$847 and \$1,591 at December 31, 2023 and 2022, respectively. During the years ended December 31, 2023 and 2022, forfeitures of \$1,856 and \$0 were used to reduce employer contributions, respectively.

**Retirement**

Normal retirement under the Plan is the later of the date the participant attains age sixty-five (65) or the fifth anniversary of the first day of the Plan year in which the participant commenced participation in the Plan.

**Payment of Benefits**

Payment of benefits may be made at the following times under the Plan: 1) normal retirement; 2) termination of employment of the participant; 3) death or permanent disability of the participant; or 4) in-service withdrawals after attaining the age of 59 ½. The form of benefit payments may be in a single lump sum. Effective June 1, 2023, the Plan was amended to permit partial withdrawals of vested benefits of at least \$1,000.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the Prime Rate plus 1%.

**Administrative Expenses**

Administrative costs of the Plan are shared by the Plan and the Plan Sponsor. Expenses related to specific participant transactions are charged to the respective participant's account.

*NOTE 2:* **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are maintained on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Investment Valuation and Income Recognition**

Investments in mutual funds, exchange traded funds and the money market fund, are stated at fair market value using quoted market prices when available. The net asset value is used as a practical expedient to estimate the fair value of the stable value collective trust fund. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded when earned. Dividend income is recorded on the ex-dividend date. Changes in the unit values of investments are reflected in each participant's self-directed account. Investments are valued daily.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Income Taxes**

The Plan adopted a non-standardized pre-approved profit sharing plan which obtained a favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan is acceptable under Section 401 of the Code. The Plan has not applied for its own determination letter. Although the Plan has been amended since receiving the opinion letter, Plan management believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has determined that as of December 31, 2023 there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

**Estimates and Assumptions**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**NOTE 4: FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) ASC 820 provides a framework for measuring fair value. That framework provides a three-tier hierarchy that prioritizes the inputs to valuation techniques used for measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs are unadjusted quoted prices for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, model-based valuation techniques for which all significant assumptions are observable in the market, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs that are unobservable and significant to the fair value measurement.

The asset fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

*Mutual Fund:* Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Exchange Traded Fund:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Money Market Fund:* Underlying short term investments with quoted prices in active markets to preserve the value of the investment at \$1.00 per share.

*Stable Value Collective Trust Fund:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

**NOTE 5: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts.

**NOTE 6: PARTY-IN-INTEREST TRANSACTIONS**

Fees paid by the Plan for investment management services are included as a reduction to the return earned on each fund. Certain administrative fees related to administration of the Plan and investment advisory fees were paid by the Plan. Notes receivable from participants are considered party-in-interest transactions. These investments and transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

**NOTE 7: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for Plan benefits.
