We have audited the financial statements of Jaffe, Raitt, Heuer & Weiss, Professional Corporation Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit] for the year ended December 31, 2023, and we have issued our report thereon dated October 14, 2024. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Principal Life Insurance Company, the custodian, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

## **Significant Audit Matters**

### **Qualitative Aspects of Accounting Practices**

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosure affecting the financial statements was:

- The disclosure addressing the transfer of plan assets due to merger in Note 9 to the financial statements.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. There were no significant estimates in the financial statements.

The financial statement disclosures are neutral, consistent, and clear.

We have identified the following significant risks of material misstatement as part of our audit planning:

- Management override of controls
- Improper revenue recognition
- Transfer of plan assets

### **Form 5500 Procedures**

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

## **Difficulties Encountered in Performing the Audit**

We encountered no significant difficulties in performing and completing our audit.

## **Corrected and Uncorrected Misstatements**

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. There were no misstatements detected as a result of audit procedures that were more than trivial.

There were no known uncorrected misstatements that were more than trivial.

## **Disagreements with Management**

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

## **Management Representations**

We have requested certain representations from management that are included in the management representation letter dated as of the date of the audit report.

## **Management Consultations with Other Independent Accountants**

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

## **Other Audit Findings or Issues**

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

## **Emphasis of Matter**

Our report will include the following emphasis of matter paragraph:

### **Emphasis of Matter – Significant Transfer of Assets**

All assets of the plan were transferred out of the Plan as of December 29, 2023. The Company merged the assets of Jaffe, Raitt, Heuer & Weiss, PC Retirement Plan with Taft, Stettinius & Hollister Retirement Plan effective January 1, 2024.

## **Other Matters**

Our responsibility for the ERISA-required supplementary schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplementary schedule, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

This information is intended solely for the use of the Plan Administrator, Plan Management, Trustees, and others within the Plan, and is not intended to be, and should not be, used by anyone other than these specified parties.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. **Note 1 – Description of the Plan**

The following description of the Jaffe, Raitt, Heuer & Weiss Professional Corporation Retirement Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering all employees located in the Michigan offices of Taft Stettinius & Hollister, LLP except for associate attorneys, union employees, temporary employees, and non-resident aliens and summer associates and employees who work less than 1,000 hours in a plan year. The Plan was established effective January 1, 1989 and was most recently amended and restated effective January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility**

Employees are eligible for plan participation in all contributions after completing 28 days of service and are at least age 21. Upon becoming eligible, employees will enter the Plan on the next payroll date in the month following eligibility. In order to share in employer profit sharing contributions, eligible participants must be credited with 1,000 hours of service during the plan year and be employed on the last day of the plan year.

**Contributions**

Each year, participants may contribute a percentage or specified amount of their annual compensation, not to exceed the limits of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The matching contribution is equal to 25% of the first 6% of a participant's compensation which the participant elects to contribute to the Plan during the plan year, subject to a maximum matching contribution of 1.5% of compensation.

Profit sharing amounts may be contributed at the option of the Company's board of directors. During the years ended December 31, 2023 and 2022, the Company made profit sharing contributions of \$3,146,736 and \$2,790,548.

Contributions are subject to certain limitations as mandated by the IRC.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, as well as allocations of plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions and employer matching contributions plus any earnings thereon. Participants are vested on employer profit sharing contributions as follows:

Participants are credited with a year of service if they obtain 1,000 hours of service during the plan year.

**Payment of Benefits**

The Plan provides for payment of 100% of the account balance to participants upon retirement, death, or disability. Participants terminating employment for any other reason are entitled to receive 100% of their vested account balances and any remaining non-vested portions would be forfeited. Participant distributions from the Plan can be made in a single lump payment, partial withdrawals, or installments. If the participant's vested benefit under the Plan exceeds \$5,000, then the participant must consent to the distribution before it is made. However, if the participant's vested benefit under the Plan does not exceed \$5,000, then the benefit may be distributed as soon as possible following the event that entitles the participant to a distribution. There are minimum distribution requirements once a participant reaches a certain age as defined in the Plan agreement. Generally, a participant may receive a distribution from the Plan prior to termination of employment if certain conditions are satisfied. A participant may be entitled to receive an in-service distribution from their vested account balance if they have reached the age of 59 ½. Participants may also request financial hardship distributions from elective deferral accounts if they meet certain conditions defined in the plan agreement.

**Forfeited Accounts**

At December 31, 2023 and 2022, forfeited non-vested accounts totaled \$98,061 and \$37,194, respectively. These accounts are used first to restore prior forfeitures then used to reduce employer contributions to the plan. The employer contributions reduced for forfeitures amounted to \$98,061 and \$37,194 for the years ended December 31, 2023 or 2022, respectively.

**Note 2 – Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's custodian and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Administrative expenses of operating the Plan are paid by the Company. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. The Company may elect to pay certain expenses, and if they do, those expenses would not be recognized in these financial statements.

**Subsequent Events**

Management has evaluated subsequent events through October 14, 2024, which is the date the financial statements were available to be issued.

**Note 3 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under US GAAP are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the assets or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Mutual funds* – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These

funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust funds – valued at the net asset value (NAV) of units held by the Plan at year end. The NAV, as provided by Principal Life Insurance Company, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The NAV is not a publicly-quoted price in an active market.

The target retirement funds provide an asset allocation based on an investor's targeted retirement date. The asset allocation becomes more conservative as the fund approaches its target retirement date.

### Note 4 – Related-Party Transactions and Party-In-Interest Transactions

Certain plan investments are managed by Principal Life Insurance Company who is the custodian and record-keeper of the Plan and provides securities brokerage services. These transactions qualify as party-in-interest transactions.

The Plan made payments to Principal Life Insurance Company, third party administrator and/or record-keeper, relating to withdrawals, record-keeping, and general plan administration. Direct fees incurred by the Plan for these services and during the years ended December 31, 2023 and 2022, respectively, totaled \$107,731 and \$105,285.

**Note 5 – Certified Investments**

Certain information related to participants' investments disclosed in the accompanying financial statements and ERISA-required supplementary schedule, including investments held at December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended December 31, 2023 and 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company.

**Note 6 – Tax Status**

The Company adopted a pre-approved plan, which received a favorable opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, indicating that the plan is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the letter, however, the plan administrator and the Plan's tax counsel believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 – Risks and Uncertainties**

The Plan's invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 8 – Non-Exempt Prohibited Transaction**

During 2023, the Company failed to remit to the Plan's custodian certain participant withholdings (employee deferral contributions and/or loan repayments) within the period prescribed by Department of Labor (DOL) regulations. These withholdings exceeded \$61,322 over this period and is disclosed in the attached supplementary schedule. These failures to timely remit participant withholdings qualify as non-exempt prohibited transactions. The Company remitted a corrective contribution to the Taft Stettinius & Hollister LLP Retirement Plan in 2024, for lost opportunity costs associated with the untimely remitted participant withholdings and allocate to affected participants.

**Note 9 – Significant Transfer of Plan Assets**

On December 31, 2022, the Company merged with the law firm of Taft Stettinius & Hollister, LLP. As a result of the merger, employees categorized as "Associates" were eligible to participant in the Taft Stettinius & Hollister Retirement Plan effective January 1, 2023 and are no longer eligible to participate in the Jaffe, Raitt, Heuer & Weiss Retirement Plan.

Effective January 1, 2024, the Company merged the assets of Jaffe, Raitt, Heuer & Weiss, PC Retirement Plan with the Taft Stettinius & Hollister LLP Retirement Plan. As a result, the balance of the Jaffe, Raitt, Heuer & Weiss PC Retirement Plan assets totaling \$127,317,988 were transferred to the Taft Stettinius & Hollister LLP Retirement Plan.
