Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Parata Systems, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 29, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period January 1, 2023 to December 29, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Parata Systems, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Basis for Opinion

Plan Merger

As further discussed in Note 1 to the financial statements, on March 3, 2023, Plan management elected to merge the Parata Systems, LLC 401(k) Plan into the BD 401(k) Plan. All net assets available for benefits were transferred effective as of December 29, 2023. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Notes to Financial Statements

NOTE 1 - DESCRIPTION OF PLAN

The following description of Parata Systems, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Parata Systems, LLC (the "Company") who are eligible immediately with an entry date on the first day of each month after the participant's hire date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan administrator is responsible for oversight of the Plan. The Plan's Retirement Committee determined the appropriateness of the Plan's investment offerings, monitors investment performance and reported to the Plan administrator.

Plan Merger

On July 18, 2022, Parata Systems, LLC, was purchased by BD (Becton, Dickinson and Company). Subsequent to the purchase of Parata Systems, LLC, on March 3, 2023, Plan management adopted a resolution to merge the Plan into the BD 401(k) Plan as of December 29, 2023. The transferred net assets have been recognized in the accounts of the BD 401(k) Plan as of December 29, 2023, at their balances as previously carried in the accounts of the Plan in the amount of \$39,914,398. The BD 401(k) was restated to allow for the addition of the Plan and to take ownership of the transferred net assets of the Plan.

Contributions

Prior to the merger, participants were able to contribute up to 90% of their annual pre-tax compensation, as defined in the Plan. Participants could also contribute after-tax contributions along with qualified Roth contributions to the Plan and could contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could direct the investment of their contributions into various investment options offered by the Plan. The Plan offered various money market and mutual funds as investment options for participants.

Prior to the merger, the Company made quarterly discretionary matching contributions to eligible participant, not to exceed 2% of eligible compensation. Additional matching amounts could be contributed at the option of the Company's board of directors. The Company offered automatic enrollment at 3% for employees, unless otherwise elected by participants. Contributions were subject to certain limitations as determined by the Internal Revenue Code.

Participant Accounts

Prior to the merger, each participant's account was credited with the participant's contributions, including amounts rolled over from other qualified plans, and Company contributions, as well as allocations of Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Vesting

Prior to the merger, participants were vested immediately in their contributions, including amounts rolled over from other qualified plans, plus actual earnings thereon. Vesting in the Company's discretionary matching contributions was based on years of continuous service with the Company. A participant became 100% vested after 4 years of credited service or in the event of death and disability, as defined by the Plan.

Notes Receivable from Participants

Prior to the merger, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The participant's available balance for loans was limited to the participant's vested employee portion of total account balance. The loans were secured by the balance in the participant's account and bear interest at prime rate plus 1%. Principal and interest were paid ratably through regular payroll deductions.

Payment of Benefits

Prior to the merger, the Plan permitted withdrawals when a participant terminated employment, reached normal retirement age or became disabled or deceased. Upon termination, participant consent was not required for distributions of an account balance less than \$5,000. In-service withdrawals were also permitted for certain financial hardships or when a participant attained age 59 1/2. In addition, the Plan provides that after-tax contributions and rollover contributions are available for in-service withdrawal at any time, and qualified reservist distributions and active military distributions pursuant to the HEART Act are also permitted. Benefits were payable in lump-sum payments.

Forfeited Accounts

At December 29, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$-0- and \$52,898, respectively. These accounts were used to pay administrative expenses and any remaining would be used to reduce future employer contributions. During 2023, \$16,800 of forfeitures were used by the Company to reduce employer contributions and plan expenses.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determined the Plan's valuation policies utilizing information provided by the investment advisers, custodians and trustee. See Note 4 for discussion of fair value.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation or depreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees were recorded as administrative expenses and were expensed when they were incurred. A loan becomes immediately due and payable upon a participant's termination of employment. Delinquent notes receivable from participants were recorded as a distribution based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 29, 2023 and December 31, 2022.

Contributions

Contributions from Plan participants and the matching contributions from the Company were recorded in the year in which the employee contributions were withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Certain investment related expenses were paid using the Plan's assets and were either included in net appreciation of fair value of investments or were allocated among participants in the Plan. Certain expenses relating to specific transactions, such as loan set up, loan maintenance and express mail services, were paid directly by the participant and were included in administrative expenses.

Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure through October 10, 2024, which is the date the financial statements were available to be issued.

NOTE 3 - INFORMATION CERTIFIED BY FIDELITY MANAGEMENT TRUST COMPANY (Unaudited)

Certain information related to investments from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable held at December 29, 2023 and December 31, 2022, and net depreciation in fair value of investments, and interest and dividends for the year ended December 29, 2023 was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs other than quoted market prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that were observable for the asset or liability; and
- Inputs that were derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value.

Money market and mutual funds: Valued at the daily closing price as reported by the fund. The money market and mutual funds held by the Plan were open-end mutual funds that were registered with the U.S. Securities and Exchange Commission ("SEC"). These funds were required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan recordkeeping, transaction processing and loan maintenance services were provided by Fidelity Management Trust Company, subsidiaries and affiliates, therefore, fees associated with these services qualify as party-in-interest transactions. Investment advisory services were provided by Lockton Financial Advisors LLC and Creative Planning, LLC. Fees associated with these services qualify as party-in-interest transactions. The Plan could receive revenue sharing payments from mutual fund service providers, which offset fees paid by the Plan. Fees in excess of the revenue sharing amount were allocated to participant accounts and expensed.

NOTE 6 - PLAN TERMINATION

The Plan merged into BD 401(k) Plan (see Note 1). Prior to the merger, although it had not expressed any intent to do so, the Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would have become 100% vested in their Company contributions.

NOTE 7 - TAX STATUS

The Plan had adopted a prototype plan sponsored by Fidelity Management and Research Company (FMR, LLC). The prototype plan had received an opinion letter from the Internal Revenue Service, dated June 30, 2020, that the prototype plan and related trust were designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan was designed and was currently being operated in compliance with the applicable provisions of the IRC and therefore believed that the Plan was qualified and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 29, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
