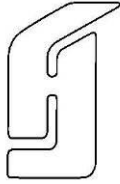

Dear Plan Administrator:

We have completed our audit of the financial statements of United Vein & Vascular Centers 401(k) Plan (the "Plan") as of and for the year ended December 31, 2023. Professional standards require that we provide you with information about our responsibilities under auditing standards generally accepted in the United States of America ("GAAS"), as well as certain information related to the planned scope and timing of our audit. Information about our responsibilities is included in our engagement letter and audit plan dated April 5, 2024. The following comments summarize the results of our 2023 audit.

Audit Report

Management elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier, that is regulated, supervised and subject to periodic examination by a state or federal agency, a qualified institution, that prepared and certified the investment information in accordance with 29 CFR2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. We have determined that an ERISA Section 103(a)(3)(C) audit is permissible under the circumstances. We have also determined that the investment information is prepared and certified by a qualified institution as described by 29 CFR2520.103-8, that the certification meets the requirements in 29 CFR2520.103-8 and, that the certified investment information is appropriately measured, presented, and disclosed in accordance with accounting principles generally accepted in the United States of America ("GAAP").

The purpose of an ERISA Section 103(a)(3)(C) audit is to express an opinion on whether the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with GAAP and that the assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the certified investment information.

Qualitative Aspects of Accounting Practices

The Plan's management is responsible for the financial statements and for selecting and using appropriate accounting policies. The significant accounting policies are described in the Summary of Accounting Policies note. The quality of these accounting policies and the clarity of the financial statements are adequate.

We noted no transactions entered into during the year for which there is a lack of authoritative guidance or consensus.

All significant transactions recognized in the financial statements have been properly recorded and recognized in the proper period.

Accounting estimates are an integral part of the financial statements. Such estimates are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. We have concluded that the methodologies used by management to develop estimates are appropriate. Further, we believe that the amounts reflected in the financial statements are reasonable.

Areas Identified as Significant and/or Fraud Risks

As anticipated, we identified in our risk assessment revenue recognition and management override of internal controls over financial reporting as fraud risks.

Difficulties Encountered in Performing the Audit and Changes in Audit Scope

We encountered no difficulties in dealing with management in performing and completing our audit. Everyone cooperated fully with us; the account schedules and analyses provided were appropriately prepared and timely.

There were no significant changes from our audit plan. We focused our audit efforts on, among other matters: 1) benefit payments; 2) contributions; 3) review of individually significant and/or nonrecurring transactions; 4) accrued liabilities, commitments and contingencies; 5) revenue recognition; 6) expense recognition; and the form, content and clarity of the presentation of the financial statements. Please note that we did not audit and express no opinion on the internal control over financial reporting.

Independence

There were no relationships between any of our representatives and the Plan that in our professional judgment may reasonably be thought to bear on independence.

Since our appointment as independent auditors we discussed a variety of accounting and auditing matters with management in the normal course of our professional relationship. No such matters were discussed as a condition of our appointment.

Notes to Financial Statements

At December 31, 2023 and 2022 and For the Year Ended December 31, 2023

(1) Description of Plan

The following description of the United Vein & Vascular Centers 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering all eligible employees of United Vein & Vascular Centers (the "Company"). The Plan was established on April 1, 2019. The Plan was amended and restated effective on December 1, 2023. Employees may enter the Plan after attaining age twenty-one and completing two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan's designated trustee is Reliance Trust Company.

Contributions. Each year, participants may contribute up to 90% of their eligible compensation, as defined in the Plan, subject to the limitations provided by the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Effective as of December 1, 2023, the Plan includes an automatic salary deferral feature. The automatic deferral provisions apply to all participants, except those who have a salary deferral agreement in effect on the automatic deferral provisions effective date. The amount to be automatically withheld from each payroll period will be set at 2% of eligible compensation. The Company's matching contribution is discretionary at the option of the Company's management. Also, the Company may make a discretionary profit-sharing contribution at an amount determined annually. Participants direct the investment of their contributions into various investment options offered by the Plan. All employer contributions are invested ratably in the investment options selected by the participants and are subject to the vesting guidelines discussed below. These options may be changed at any time. Participant and employer contributions are also subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts. Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are immediately vested in their voluntary contributions, including amounts transferred into the Plan from other qualified employee benefit plans, plus actual earnings thereon.

Vesting in any additional employer profit sharing contributions and earnings thereon is based on years of continuous service as defined in the Plan. A participant is 20% vested after two years of service, increasing by an additional 20% each year thereafter. A participant is 100% vested in the entire account after six years of credited service.

(1) Description of Plan, Continued

Vesting, Continued. Vesting in any employer matching contributions, and earnings thereon, a participant is 25% vested after one year of service, increasing by an additional 25% each year thereafter. A participant is 100% vested in the entire account after four years of credited service.

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$500 up to a maximum of \$50,000. The amount is subject to a limit of 50% of their vested account balance less any existing loan balance or \$50,000. Loan terms can be up to five years, unless the loan was used for the purchase of a primary residence. A participant may have no more than one loan outstanding at any one time. The loans are secured by the balance in the participant's account and bear interest at two percentage points above the prime rate. The loan administrator periodically reviews these interest rates with the intention of providing the Plan with a return commensurate with the interest rates that a commercial lender would charge for a similar loan. Principal and interest are paid ratably through semimonthly payroll deductions.

Payment of Benefits. On termination of service due to death, disability or retirement, a participant will receive a lump sum amount equal to the value of the participant's vested interest in his or her account.

Forfeited Accounts. Forfeited accounts, at the option of the Plan, are used to pay administrative expenses and reduce employer contributions or are reallocated to remaining participants based on their salary. At December 31, 2023 and 2022 and for the year ended December 31, 2023, there were no forfeited accounts.

(2) Summary of Accounting Policies

Basis of Presentation. The Plan's financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America ("GAAP"). The following is a summary of the significant accounting policies:

Use of Estimates. The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events. Management has evaluated all significant events occurring subsequent to the balance sheet date through September 12, 2024, which is the date the financial statements were available to be issued, determining no events require additional disclosure in the financial statements.

(2) Summary of Accounting Policies, Continued

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value. Fair value is the exchange price that would be received for an asset or paid to transfer a liability (at exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

Excess Contributions Payable. Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. Excess contributions payable to participants at December 31, 2023 and 2022 were \$85,484 and \$60,899, respectively. The Plan distributed the 2022 excess contributions to the applicable participants prior to March 15, 2023. For the 2023 excess contribution the Plan has elected to make a qualified nonelective contribution ("QNEC") to the Plan for non-highly compensated employees. QNEC is an employer contribution that is 100% vested and subject to the same distribution restrictions as elective deferrals.

Contributions. Contributions are accrued and credited to participants' accounts as of each pay period.

Payment of Benefits. Benefits are recorded when paid.

Expenses. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

(3) Fair Value Measurements

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. The fair value hierarchy requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy describes three levels of inputs that may be used to measure fair value:

Level 1: Observable inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities.

(3) Fair Value Measurements, Continued

Level 2: Inputs other than quoted prices that are observable for the asset or liability, either directly or indirectly. These include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities that are not active; and model-driven valuations whose inputs are observable or whose significant value drivers are observable. Valuations may be obtained from, or corroborated by, third-party pricing services.

Level 3: Unobservable inputs to measure fair value of assets and liabilities for which there is little, if any market activity at the measurement date, using reasonable inputs and assumptions based upon the best information at the time, to the extent that inputs are available without undue cost and effort.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value-

Mutual Funds. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by Level, within the fair value hierarchy, the Plan investments at fair value:

(4) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(5) Tax Status

The Company adopted a prototype plan document that was approved by the IRS on June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has not applied for an individual determination letter from the IRS. The Company believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC and that the Plan has satisfied the qualification requirements of the IRC Section 401(a) in operation and, therefore, the related trust is exempt from federal income taxes under the provisions of IRC Section 501(a). Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Company has analyzed the tax positions taken by the Plan, and has concluded that at December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Information Certified by Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Reliance Trust Company held the Plan's investment assets and executed investment transactions from January 1, 2022 to December 31, 2023. Accordingly, Reliance Trust Company the trustee of the Plan, have certified that the information regarding the value of investments, notes receivable from participants, the related investment income, interest income on notes receivable from participants, and appreciation in fair value of investments as of December 31, 2023 and 2022 and for the year ended December 31, 2023 is complete and accurate.

(7) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(8) Related-Party Transactions and Party-In-Interest Transactions

Certain Plan investments include investment funds managed by the Trustee, as defined by the Plan, and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan participants for the investment management services were included as a reduction of the return earned on each fund.
