### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2022 Financial Statements**

## Notes to Financial Statements

December 31, 2022

### **1. Description of the Plan**

The following brief description of the Burrows 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for complete information.

#### **General**

The Plan was established by Cabinet Specialists, LLC (the “Company”). Effective January 2021, the Company changed its name to Burrows Millworks Inc. Effective November 2022, the Company merged with Burrows Manufacturing, LLC and changed its name to Burrows Cabinet, LLC. The Plan is a defined contribution 401(k) plan covering all eligible employees of the Company. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and qualifies under Section 401(a) of the Internal Revenue Code (the “IRC”). During 2022, the custodian of the Plan changed from Mass Mutual Life Insurance Company (“Mass Mutual”) to Empower Annuity Insurance Company of America and Empower Trust Company, LLC (“Empower”).

#### **Eligibility**

Employees are eligible to participate in the Plan upon attainment of age twenty-one after one year of service. The entry date is on the first day of the Plan year or first day of the 7<sup>th</sup> month of the Plan year coincident with or next upon meeting eligibility requirements. Union and leased employees are excluded from participation in the Plan.

#### **Contributions**

Each year, participants may contribute a percentage of their eligible compensation, as defined in the Plan, on both a pre-tax basis and after-tax (“Roth”) basis, not to exceed the annual limit established by the IRC. Participants may also contribute amounts representing distributions from other qualified plans. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions.

The Company may make discretionary employer matching or profit sharing contributions. The Company did not make any discretionary contributions during the year ended December 31, 2022. The Company may also elect to make an operational qualified nonelective contribution (QNEC) for a plan year for the correction of test failures. The Plan had certain test failures for Plan year 2022 that were corrected through a QNEC funding. Participants direct the investment of their contributions into various investment options offered by the Plan.

## Burrows 401(k) Plan

### Notes to Financial Statements (continued)

#### 1. Description of the Plan (continued)

##### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings and losses, and is charged with withdrawals and applicable administrative expenses. Plan earnings are allocated based on the participant's share of the net earnings or losses of their respective elected investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

##### Administrative Expenses

All reasonable expenses of administration of the Plan may be paid from the assets of the Plan. The Company may, at its discretion, pay such expenses.

##### Vesting

Participants are immediately 100% vested in their salary deferrals, rollover contributions plus actual earnings thereon. Vesting in the Company's matching and profit sharing contributions plus earnings thereon is based on continuous service, as defined. Vesting is according to the following schedule:

##### Payment of Benefits

Vested benefits are paid to participants upon death, disability, retirement or termination of employment by either arranging for a rollover to another plan, lump sum payment or installments. Hardship withdrawals are also available. For terminated participants' account balances that are less than \$5,000, the plan administrator may distribute the entire amount in a lump sum without the participant's consent. If the participant's vested portion is greater than \$5,000, the participant may elect to maintain the vested portion in the Plan.

## Burrows 401(k) Plan

### Notes to Financial Statements (continued)

#### **1. Description of the Plan (continued)**

##### **Forfeitures**

Forfeitures are used to reduce future employer contributions or pay administrative expenses. During 2023, \$16,885 of forfeited unvested account balances was used to pay administrative expense. At December 31, 2022 and 2021, forfeited account balances totaled \$1,444 and \$16,805, respectively.

##### **Notes Receivable From Participants**

Participants are permitted to borrow the lesser of \$50,000 or 50% of their vested account balance. The minimum that can be borrowed is \$1,000 and one loan can be outstanding at a time. Notes receivable from participants are secured by the balance in the participant's account and bear interest at a rate of 1 percentage points above the prime rate. Notes receivable from participants' terms range from one to five years or a reasonable amount of time for the purchase of a primary residence. Principal and interest is paid through payroll deductions with equal installments made each pay period.

##### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the balances of all individual accounts will be distributed as soon as administratively practicable after the Plan terminates.

#### **2. Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The Plan's financial statements are reported on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States. Benefits are recorded when paid to participants.

##### **Contributions and contributions receivable**

Contributions from the employer and the participants are due to the Plan in the period the contributions are earned and deducted from the paycheck. Contributions receivables are contributions earned and withheld as of December 31 which were transferred to the Plan subsequent to year end.

## Burrows 401(k) Plan

### Notes to Financial Statements (continued)

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Risks and Uncertainties**

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participant account balances.

##### **Accounting Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect certain amounts reported in the financial statements and the accompanying notes and schedules. Accordingly, actual results could differ from these estimates.

##### **Valuation of Investments and Income Recognition**

Investments held by the Plan are stated at fair value, except for fully benefit responsive investment contracts. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

##### **Reclassifications**

Certain prior year amounts have been reclassified to conform to the current year presentation.

### Notes to Financial Statements (continued)

#### 3. Investments

All investment information disclosed in the accompanying financial statements, notes and schedule, including investments and notes receivable from participants held at December 31, 2022 and 2021, and net depreciation in fair value of investments, interest and dividend income and interest income from notes receivable from participants for the year ended December 31, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mass Mutual and Empower, the custodians.

The Plan is in a benefit-responsive group annuity contract with Empower where the contributions are maintained in a general account. The contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

#### 4. Fair Value Measurements

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2—Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liabilities;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

## Burrows 401(k) Plan

### Notes to Financial Statements (continued)

#### 4. Fair Value Measurements (continued)

The asset or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Pooled separate accounts are valued based on the NAV of the underlying securities that make up the fund, which are traded on an active market. The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumption to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. Party-in-Interest Transactions

Plan investments are managed by Empower. Transactions such as these qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules.

#### 6. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability. The Plan distributed the excess contributions to the applicable participants during the subsequent year.

## Burrows 401(k) Plan

### Notes to Financial Statements (continued)

#### **7. Income Tax Status**

The underlying non-standardized prototype plan has received an opinion letter from the IRS dated November 30, 2020, stating that the form of the plan is qualified under Section 401(a) of the IRC, and therefore, the related trust is tax exempt. The plan administrator has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Subsequent to receiving the IRS opinion letter, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax exempt.

#### **8. Delinquent Participant Contributions**

During the year ended December 31, 2022, the Company did not remit to the Plan's custodian certain employee contributions totaling approximately \$2,688 within the required timeframe prescribed by the Department of Labor Regulation 29 CFR 2510.3-102. The delayed contributions are considered prohibited, or nonexempt, transactions. The Plan administrator is in the process of taking corrective action, including payment of lost interest and related taxes and penalties.

#### **9. Subsequent Events**

The Plan has evaluated subsequent events through October 10, 2024, the date the financial statements were available to be issued. Effective January 2023, Burrow Millworks Inc., a participating employer of the Plan was dissolved. All of the employees of Burrow Millworks Inc. were transferred to either Burrows Cabinet LLC or TaylorCraft Cabinet Doors LP. Effective January 2023, TaylorCraft Cabinet Door LP was added as a participating employer of the Plan. Effective April 1, 2023, the custodian changed from Empower to Fidelity Management Trust Company.
