Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of CEMCO 401 (K) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

NOTE A -- DESCRIPTION OF THE PLAN

The following description of the CEMCO 401(k) Retirement Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Plan sponsor is CEMCO, LLC (CEMCO - the “Company”). The custodian of the Plan is Fidelity Investments (“Fidelity”).

General. The Plan is a defined contribution plan covering substantially all full-time employees of the Company who have one month of service and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Open enrollment occurs on the first day of each month.

Contributions. Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options for offered by the Plan. Contributions are automatically invested in a designated balanced fund until changed by the participant. The Plan provides for a Safe Harbor employer matching contribution. The Company will match 100% up to the first 3% of a participant’s salary contributed to the plan and will match 50% of the next 4% of the participant’s contributions. Contributions are subject to certain statutory limitations.

Participant Accounts. Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s matching contribution and, (b) Plan earnings (losses), and charged with allocation of any administrative expenses paid by the plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting. Participants are 100% vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching contributions plus actual earnings thereon is based on each participant’s years of continuous service with the Company. A participant vests at the rate of 20% per plan year, beginning with completion of their second year of service. A participant is 100% vested after six years of credited service.

Fidelity Bond. The Plan sponsor obtained a fidelity bond in the amount of \$500,000 that became effective on June 24, 1997.

Notes Receivable from Participants. Participant loans are permitted under the Plan. Loans must be approved by the Plan Administrator and are subject to a strict set of rules established by law. Loans may not exceed the lesser of \$50,000 or 50% of the participant's vested account balance. The notes are secured by the balance in the participant's account. All loans bear a reasonable rate of interest as determined by the Plan Administrator which shall remain fixed and, generally, are re-paid over a five-year period or up to 15 years if the money is used to purchase a primary residence. Principal and interest is paid ratably through after-tax weekly payroll deductions.

Payment of Benefits. On termination of service due to death, disability or retirement, participants may elect to receive either a lump-sum amount or an installment or annuity payment. If the amount in the participant's account is \$5,000 or less, the amount will be paid in one lump sum. For the plan year ended December 31, 2023, benefits paid to participants amounted to \$2,667,065.

Forfeited Accounts. Termination of employment for reasons other than retirement, disability or death results in forfeiture of the non-vested portion of the participant's Plan account balance. Forfeited funds, including earnings thereon may be used at the Company's discretion to reduce the Company's future matching contributions to the Plan. Forfeitures for the Plan for the year ended December 31, 2023 were \$0.00. As of December 31, 2023 and December 31, 2022, there were no forfeiture funds held by the Plan.

Administrative Expenses. Administrative expenses in some cases are covered by investment fees that are deducted directly from the investment returns. In other cases, the administrative fees are either paid directly by the employer or passed through to the participants in the plan and directly deducted from the participant's account.

Investment Options. Upon enrollment in the Plan, participants may direct their contributions to be invested in a number of investment options offered by Fidelity Investments. The investment options offered to participants through Fidelity Investments are categorized as follows:

Target Date Funds. This category of funds invests in a mix of mutual funds. The fifteen categories range from aggressive to conservative. Neither the principal nor the investment earnings are guaranteed under these funds. (Pooled Separate Accounts);

International/Global Funds. This category of funds consists of three mutual funds. Each invests primarily in international equities with the objective to achieve long-term growth. Neither the principal nor investment earnings are guaranteed under these funds. (Pooled Separate Accounts);

NOTE A -- DESCRIPTION OF THE PLAN (Continued)

Fixed Interest Funds. These funds invest primarily in guaranteed investment contracts issued by Invesco. It is managed by Fidelity Investments (Pooled Separate Accounts);

Domestic Equity Funds. This category consists of eight mutual funds whose primary objective is long term growth. Neither the principal nor the investment earnings are guaranteed under these funds. (Pooled Separate Accounts);

Balanced/Hybrid Fund. This category consists of one mutual fund whose primary objective is long-term growth of income and sustainable level of current income. Neither the principal nor the investment earnings are guaranteed under these funds. (Pooled Separate Accounts);

Bond Funds. This category consists of three mutual funds whose primary objective is high current income and preservation of capital. Neither the principal nor the investment earnings are guaranteed under these funds. (Pooled Separate Accounts);

NOTE B -- SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2023 and 2022, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Transfer of Assets

The CEMCO 401(k) Retirement Plan merged with JFE Group 401(k) Plan (EIN# 84-2757527) effective January 1, 2024. All assets were transferred from the CEMCO 401(k) Plan to JFE Group 401(k) Plan on 11:59p.m. December 31, 2023.

Date of Management's Review of Subsequent Events

Subsequent events were evaluated through October 14, 2024, which is the date the financial statements were available to be issued.

NOTE C – INFORMATION CERTIFIED BY THE TRUSTEE

All investment information, including notes receivable from participants, disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2023 and 2022 and net change in fair value of investments and interest and dividend income for the year ended December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Plan's trustees.

NOTE D – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2023 and 2022.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net assets values of the shares held by the Plan at year-end.

Level 2 Fair Value Measurements

The fair value of the fixed interest funds is based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

The fair value of collective trust funds is generally obtained directly from the fund house or other investment provider.

The Plan's investments are held by the Plan's trustee, an insurance company. The following tables set forth, by level within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2023 and 2022:

Gains and losses included in changes in net assets available for benefits for the year ended December 31, 2023 are reported in net depreciation in fair value of investments.

NOTE E – GROUP ANNUITY CONTRACT

The Plan has a benefit-responsive group annuity contract with Fidelity Investments. Fidelity Investments maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. As a general account product offered through the group annuity contract, participant principal and interest are fully guaranteed by the entire general account assets of Fidelity Investments.

The Invesco Stable Fund are general account products. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. The average yield earned by the plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The average for 2023 is 2.66% and for 2022 is 1.60%.

NOTE F – RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$56,791 for the year ended December 31, 2023.

While these transactions are party-in-interest transactions they are not prohibited transactions under ERISA.

NOTE G – SUBSEQUENT EVENTS

There were 15 employee participants that have been terminated as of December 31, 2023. These terminated participants have balances in the plan that total \$447,486.28 which may be disbursed in 2024 to these terminated participants. Since their accounts are pooled separate accounts, there will be no effect to the other participants in the plan when the terminated employees' accounts are disbursed.

NOTE H – TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2020.

NOTE I – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE J - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
