Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Platinum Home Mortgage Corporation 401(k) Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Platinum Home Mortgage Corporation 401(k) Plan and Trust to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Termination of Plan

As discussed in Note 1 to the financial statements, Platinum Home Mortgage Corporation approved a plan of liquidation and termination effective September 15, 2023. As a result, the Plan has prepared the December 27, 2023, financial statements using the liquidation basis of accounting.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Platinum Home Mortgage Corporation 401(k) Plan and Trust's internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter

Supplemental Schedule Required by ERISA

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

Note 1 – Description of Plan

The following description of the Platinum Home Mortgage Corporation 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of plan provisions.

General – The Plan was a 401(k) salary deferral and profit sharing plan covering substantially all employees of Platinum Home Management Corporation and participating affiliates, and was subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Platinum Home Mortgage Corporation (the Company) was the Plan's sponsor and served as plan administrator. The original plan was established effective February 1, 1995, by the Company for the benefit of its employees and the employees of any affiliated employer to qualify under Section 401(k) of the Internal Revenue Code (IRC). The Plan was amended and restated October 1, 2014, and amended March 23, 2018, May 13, 2019, and January 14, 2022. The Plan's management is responsible for oversight of the Plan. The investment committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's management.

Effective May 31, 2023, the Company began the process of winding down its mortgage origination business by selling its mortgage origination branches to Planet Home Lending, leaving behind a small servicing portfolio to be sold and a small team of personnel to wind down the remaining operations. As part of the wind down, the Company approved a plan of liquidation and terminated the Plan effective September 15, 2023, with final participant contributions made with payroll on August 31, 2023. Upon termination of the Plan, participants were treated as fully vested in their total account balance, including employee and employer contributions. Participants that were employees of Freedom Title Corporation, a participating employer of the Plan, establish a qualified plan and directed the Company to transfer their account balances to this qualified plan. All other participants were given the option to withdraw their account balance prior to December 1, 2023, or have the balance rolled to an IRA at Millennium Trust Company. All distributions related to the Plan termination and liquidation were completed as of December 27, 2023.

Eligibility – Employees of the Company were eligible to participate in the Plan upon completion of six months of service and being age 21 or older. Effective March 23, 2018, the Plan was amended to allow all initially hired employees at the Great Lakes branches to participate within 30 days of hire. Plan entry dates were the first day of the plan year and the date six months later following the date eligibility was met.

Contributions

Participant contributions – Prior to Plan termination, each year, participants could have contributed before tax and qualified Roth deferrals to the Plan, up to 100% of annual compensation, as defined in the Plan. Participants who attained age 50 before the end of the plan year were eligible to make catch-up contributions. Prior to Plan termination, Participants could have also contributed amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants could have changed their elective deferral percentages and were able to terminate their elective deferrals at any time.

Employer discretionary match and nonelective contributions – Prior to Plan termination, the Company could have elected to make discretionary matching and discretionary nonelective contributions each year. During 2023, the Company matched 15% of the participant's deferred compensation that is not in excess of 6% of the participant's compensation. The Company did not make any discretionary nonelective contributions for the period from January 1, 2023, through December 27, 2023. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Contributions were subject to regulatory limitations.

Participant accounts – Prior to Plan termination, each participant's account was credited with the participant's contributions and the Company's discretionary matching and discretionary nonelective contributions, as well as allocations of the Plan's earnings and losses. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could have been provided from the participant's vested account. Participants directed the investment of their contributions into various investment options offered by the Plan.

Vesting – Prior to Plan termination, participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and discretionary nonelective contribution portion of their accounts were based on continuous years of service. A year of service was defined as 1,000 hours of service during a plan year. Company discretionary matching and discretionary nonelective contributions were vested over a six-year period pursuant to the following schedule:

2 years but less than 3 years	20%
3 years but less than 4 years	40%
4 years but less than 5 years	60%
5 years but less than 6 years	80%
6 years or more	100%

Notes receivable from participants – Prior to Plan termination, Participants were allowed to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were issued by the Plan and secured by the balance in the participant's account. All loans were required to be repaid within a period of five years, unless the loan was used to purchase a principal residence, in which case, the loan was required to be repaid within a reasonable period of time not to exceed 15 years. Under the terms of the Plan Agreement, the Plan loans interest rate was based on the rates available for similar notes from commercial lending institutions.

Principal and interest was paid ratably through monthly payroll deductions. As of the Plan termination date, September 15, 2023, the rates of interest on outstanding loans ranged from 4.25% to 8.00% with various maturities through December 2027. Participants were not allowed to borrow against their vested account balances after the Plan termination date.

Payment of benefits – On termination for any reason, a participant may have elected to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or have the payment paid as a direct rollover to an Individual Retirement Account (IRA). If a participant's account balance was less than \$5,000, the participant may have elected to receive a lump-sum payment or to have the balance rolled over to an IRA. If the participant did not make a distribution election and the balance was greater than \$1,000, the balance was automatically rolled over to an IRA. However, if the balance was less than \$1,000, it was automatically distributed as a lump sum.

Forfeited accounts – Forfeitures are the non-vested portion of a participants account that is lost upon termination of employment. At December 27, 2023, there were no forfeited non-vested accounts. Forfeited non-vested accounts totaled \$10,522 at December 31, 2022. During 2023, the Plan's expenses were reduced by approximately \$21,200 from forfeited non-vested accounts.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – As a result of the Plan termination, the 2023 Plan financial statements are prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP). The 2022 financial statements have been prepared in accordance with GAAP, using the accrual method of accounting.

Use of estimates – The preparation of financial statements in accordance with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments are reported at fair value. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the "exit price") in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consisted of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Note 2 – Summary of Significant Accounting Policies (continued)

Notes receivable from participants – Notes receivable from participants were measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants were reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement. No allowance for credit losses has been recorded as of December 27, 2023, and December 31, 2022.

Payment of benefits – Benefits were recorded when paid.

Expenses – Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses were included in net appreciation of fair value of investments.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statements of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statements of net assets available for benefits, but arose after the statements of net assets available for benefits date and before the financial statements are issued.

The Plan has evaluated subsequent events through October 14, 2024, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Note 3 – Fair Value Measurements (continued)

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the techniques used at December 27, 2023, and December 31, 2022. The following is a description of the valuation methodologies used for assets measured at fair value.

Registered investment companies (mutual funds) – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trusts – Units held in collective trusts (CTs) are valued using the net asset value practical expedient (NAV practical expedient) of the CTs as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTs, minus its liabilities, and then divided by the number of units outstanding.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no Plan assets recorded at fair value as of December 27, 2023. The following table discloses the fair value hierarchy of the Plan's assets by level as of December 31, 2022:

Note 4 – Tax Status

The Plan has adopted a prototype volume submitter defined contribution plan that received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. Prior to Plan termination, the Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Information Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 27, 2023, and December 31, 2022.
- Net appreciation in fair value of investments, dividends, and interest income from notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the period from January 1, 2023 through December 27, 2023.

Note 6 – Party-in-Interest Transactions

Prior to Plan termination, the Plan paid expenses related to plan operations and investment management to various service providers. Certain plan investments were managed by Fidelity Investments Institutional Operations Company, Inc. (FIIOC). Fees paid to FIIOC for recordkeeping services during the period from January 1, 2023 through December 27, 2023, total \$22,973. Fidelity Management Trust Company was the trustee of the Plan and an affiliate of FIIOC and, therefore, transactions with these entities qualify as exempt party-in-interest transactions.

Note 7 – Delinquent Participant Contributions

As disclosed in the accompanying supplemental schedule, certain employee deferrals were not remitted to the Plan within the timeframe required by the Department of Labor. The Company is in the process of determining the amount of related lost earnings and will remit these amounts to participants' accounts subsequent to period end.

Note 8 – Reconciliation to Form 5500

The Form 5500 has certain items that differ from amounts shown in the accompanying financial statements. These differences relate to classification only and have no effect upon net assets available for benefits for either period.
