### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Thomas Health System 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

## 1. Description of Plan

The following description of the Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### General

The Plan which was established January 1, 2007, is a defined contribution 401(k) safe harbor plan covering all employees who have attained the age of 18 excluding leased employees. The Plan allows participation of all employees of Thomas Health System, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, (ERISA).

The Plan was most recently amended and restated January 1, 2021, to comply with the requirements for Cycle 3 Pre-Approved Plans, pursuant to Revenue Procedure 2017-41 of the Internal Revenue Service (IRS).

### Contributions

Participants may elect to defer a portion of their compensation, as defined in the Plan document, limited to the maximum allowed under the Internal Revenue Code for such Plan year. The employer's matching contribution is an Enhanced Safe Harbor Matching Contribution which is an amount equal to 100% of the participant's deferral contributions up to 4% of the participant's compensation and an additional 50% of the participant's elective deferrals from 4% to 6% of the participant's compensation.

The plan has an automatic enrollment feature where once an employee becomes eligible for the plan, 3% of their eligible compensation is deferred.

### Participant Investment Options

Each Plan participant has the right to direct contributions and earnings of their account among alternative investment funds provided under the Plan. Participants should refer to the most recent annual report of each investment fund for information on risk factors, asset concentrations, use of derivative financial instruments and other financial data. Participants may transfer funds between investment options at any time.

### Participant Accounts

Each participant account is credited with the participant's elective deferrals, participant rollover contributions and any employer contributions. In addition, each participant's account is credited with their share of appreciation/depreciation in the value of investments and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

### Vesting

Participants are immediately vested in their elective deferral and employer contributions and actual earnings thereon which are credited to their respective account.

## Notes Receivable From Participants

Participants may borrow from their account balances attributable to their pre-tax and Roth elected deferrals, subject to a maximum amount which is the lesser of one-half of a participant's elective deferral account balance or \$50,000. The participant's elective deferral account balance serves as collateral for the loan. The minimum request for a loan is \$1,000 and not more than one loan can be outstanding for a participant at a time. Loans bear interest of 1% above the prime rate. Loan payments shall be repaid up to five years; however, if the loan is for the purchase of a principal residence, a longer term may be permitted.

## Payment of Benefits

Upon retirement (normal retirement age is 65), attainment of age 59½, death, disability or other termination of employment, as defined in the Plan document, participants or their spouses and/or beneficiaries receive their account as a lump sum cash payment. If the participant's account balance has never exceeded \$5,000, the entire vested balance will be paid in a lump sum. Early retirement is permitted if the participant has attained age 60 and has completed five years of service. Further, upon termination of employment, the participant may elect to transfer his or her account balances to another qualified plan or individual retirement account. Minimum distributions for a participant must begin the later of April 1 of the calendar year after a participant attains age 70½ or when the participant actually retires.

The Plan allows for hardship withdrawals for certain participant needs as defined in the Plan document from participant elective contributions, Roth deferrals and related earnings. The employer has sole authority to authorize hardship withdrawals, pursuant to the Plan specifications.

## Plan Merger and Subsequent Event

Effective January 1, 2023, the Plan Sponsor combined with West Virginia University Health System (WVUHS). Consequent to the transaction, the Plan sponsor elected to merge the Plan into the frozen West Virginia University Medicine 401(k) plan effective January 1, 2024, which resulted in all accounts in the Plan rolling over to the WVUHS's frozen 401k plan. Participants in the Plan that were employees of WVUHS as of January 1, 2024, are now eligible to participate in the West Virginia University 403b Plan.

## 2. Summary of Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value, except for investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The specific valuation policy for the Plan's investments follow:

*Mutual fund investments:* The Plan's investments in mutual funds are stated at fair value which equals the quoted market price as of the last day of the Plan year. Transactions are recorded on the trade date but are reported on the settlement date. All gains/losses are unrealized and based on changes in the unit value or share value during the reporting period.

*Insurance company investment contract:* The Plan's investment in a fully benefit-responsive insurance company group annuity fixed interest option investment contract is stated at contract value which represents contributions made, less withdrawals and administrative expenses plus interest credited.

The Plan does not require collateral to secure investment instruments.

## Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

## Payment of Benefits

Benefits are recorded upon distribution.

## Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

## Subsequent Events

Subsequent events were evaluated through October 14, 2024, the date the financial statements were available to be issued.

## 3. Tax Status

Effective July 1, 2012, the Plan adopted the Variable Annuity Life Insurance Company (VALIC) Retirement Services Company Non-Standardized 401(k) Profit Sharing Plan with CODA. VALIC Retirement Services Company has received a determination letter dated June 30, 2020, that the prototype plan and related amendments qualify under Internal Revenue Code Section 401(a). An employer who has adopted the prototype plan will also be considered to have a plan qualified under Section 401(a) provided all of the terms of the plan are followed, and the eligibility requirements and contribution or benefit provisions are not more favorable for highly compensated employees than other employees. The Plan has been restated since the date of the determination letter; however, the Plan Administrator believes that the Thomas Health System 401(k) Plan is currently being operated in compliance with the aforementioned prototype plan and applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2020.

## 4. Related-Party and Party in Interest Transactions

Parties in interest are defined under United States Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, and certain others. The Plan Sponsor has contracted with the Variable Annuity Life Insurance Company to administer the Plan's assets. Administrative functions performed by The Variable Annuity Life Insurance Company include participant account maintenance and custodial services. During the year ended December 31, 2023, fees for these services amounted to \$315,723. Certain other administrative expenses for legal, auditing, and other professional services are paid directly by the Plan Sponsor and certain administrative functions are performed by officers or employees of the Plan Sponsor at no cost to the Plan.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

## 5. Information Certified by Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2023 and 2022. Accordingly, Variable Annuity Life Insurance Company, the Custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2023 and 2022, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2023, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2023.

## 6. Investment Contract With Insurance Company

Assets of the Plan include amounts held in a Fixed Interest Option during the years ended December 31, 2023 and 2022. This investment option is a general fund group fixed unallocated annuity contract (GFUA) with VALIC which is a fully benefit responsive contract featuring a current crediting interest rate.

A participant can make transfers out of the Fixed Interest Option to mutual fund options at any time or indirectly to a "competing fixed option" (subject to a 90-day equity wash provision). Plan sponsor-directed or induced transfers from the Fixed Interest Option to another investment option under the plan would be restricted to 20% per year or would be subject to the value adjustments of the surrender provisions of the contract.

The interest rate for the Fixed Interest Option is declared monthly with interest credited on a daily basis at an annual effective rate. The GFUA offers an annual minimum crediting rate set at the beginning of each year, as well as a contract minimum rate guaranteed. It is credited with interest under a portfolio interest crediting method in which all deposits receive the same return regardless of date of deposit. For the years ended December 31, 2023 and 2022, the rates were as follows:

### 7. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

## 8. Concentrations

As of December 31, 2023, the Plan had concentrations in the Fidelity 500 Index Fund and the T. Rowe Price Retirement 2025 fund, which represented 12.1% and 10.4%, respectively, of net assets available for benefits.

As of December 31, 2022, the Plan had concentrations in the T. Rowe Price Retirement 2025 fund and the Valic Fixed Interest Option, which represented 12.0% and 10.0%, respectively, of net assets available for benefits.

## 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

## 10. Plan Termination

Prior to the merger, in the event the plan had terminated, Thomas Health System, Inc. had the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.
