### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of FieldTurf USA 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2023 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

**Note 1. Plan Merger**

During the year ending December 31, 2023, the Plan sponsor, FieldTurf USA, Inc. "FieldTurf" passed a resolution transfer the assets of the Plan to a plan sponsored by an affiliate company, Tarkett Finance, Inc., effective December 29, 2023. FieldTurf USA, Inc., Beynon Sports Surfaces, Inc. and L.E.R. all become participating employers in the Tarkett 401(k) Plan effective January 1, 2024. Nationwide Trust Company, FSB was removed as the trustee of the Plan's assets and Fidelity Management Trust Company become the successor trustee of the merged assets. All benefits paid to participants after the date of merger will be paid to participants by the Tarkett 401(k) Plan.

At the date of the Plan merger, \$36,693,292 of investments and participant loan balances of \$696,152 were transferred to the Tarkett 401(k) Plan.

**Note 2. Description of the Plan**

The following description of the FieldTurf USA 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General.** Prior to merger, the Plan covered eligible employees of FieldTurf USA, Inc. as well as its subsidiaries who are participating employers; Beynon Sports Surfaces, Inc. and L.E.R., Inc. (collectively referred to as "the Company").

The Plan is a defined contribution plan that covers all employees of the Company, except (i) members of a collective bargaining unit unless the collective bargaining agreement provides to the contrary; and (ii) nonresident aliens with no U.S. source income; (iii) independent contractors; and (iv) part-time employees, temporary employees and seasonal employees unless they complete at least 1,000 hours of service in a 12 consecutive month period. Eligible employees participate in the Plan on the first day of the month coincident with or next following their completion of two consecutive months of service. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investments, monitors investment performance, and reports to the Plan's Board of Trustees.

**Plan Amendments.** On June 1, 2020 the Plan was amended to eliminate the Plan's safe harbor match contribution. On January 1, 2021 the Plan was amended to reinstate the Plan's safe harbor match contribution and to comply with IRS Notice 2017-37 cumulative changes in plan qualification requirements.

**Note 2. Description of the Plan (continued)**

**Contributions.** Prior to its merger, each year, participants could contribute up to 100% of their eligible pre-tax annual compensation, as defined by the Plan. This deduction could not exceed the maximum amount allowed under the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified plans. Participants directed the investment of their contributions into various investment options offered by the Plan. The Company offered mutual funds and an insurance investment contract as investment options for participants prior to the plan merger.

The Plan provided for a safe harbor match contribution in an amount equal to 100% of salary deferrals that do not exceed 3% of eligible compensation plus 50% of salary deferrals between 3% and 5% of eligible compensation (“safe harbor match”).

Contributions were subject to certain Internal Revenue Service limitations.

**Participant Accounts.** Prior to plan merger, each participant's account was credited with the participant's contribution and an allocation of (a) the Company's contribution, (b) Plan earnings (losses) and is reduced for loans, withdrawals, benefit distributions and an allocation of any administrative expenses paid by the plan. All of the Plan's investment options were fully participant directed. Upon enrollment in the Plan, a participant could direct contributions into any of the Plan's investment options. Participant accounts were further credited or charged with their pro rata share of earnings or losses of the total investments in each investment account and their share of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

**Vesting.** Prior to plan merger, participants were immediately vested in their contributions plus actual earnings thereon. The safe harbor match contributions were always 100% vested as well as the earnings on those accounts.

**Notes Receivable from Participants.** Participants could borrow from their account up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, prior to plan merger. The notes receivable were secured by the balance in the participant's account and bore interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest were paid ratably through payroll deductions.

**Note 3. Summary of Significant Accounting Policies**

**Payment of Benefits.** Prior to the plan merger, on termination of service due to death, disability or retirement, or Company termination of the Plan, the participant or designated beneficiary could elect to receive a lump-sum amount equal to the value of the participant's interest in his or her account. For termination of service for other reasons, a participant could receive the value of the interest in his or her account as a lump sum distribution, including a rollover to an individual retirement account.

**Basis of Accounting.** The financial statements of the Plan were prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

**Investment Valuation and Income Recognition.** Investments were reported at contract value prior to the plan merger. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Use of Estimates.** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Plan Expenses.** Prior to the plan merger, investment expenses and commissions were paid by the Plan. A portion of other administrative expenses and professional fees were typically paid by the Plan sponsor. Expenses that were paid by the Plan sponsor were excluded from these financial statements. Most investment related expenses are included in the net appreciation (depreciation) of fair value of investments. The other expenses paid by the Plan were included in Administrative and professional fees on the Statement of Changes in Net Assets Available for Benefits.

**Note 3. Summary of Significant Accounting Policies (continued)**

**Payment of Benefits.** Benefits were recorded when paid.

**Notes Receivable From Participants.** Notes receivable from participants were measured at their unpaid principal balances plus any accrued but unpaid interest prior to the merger. Interest income was recorded on the accrual basis. Related fees were charged directly to the borrowing participant's account and were included in administrative expenses when incurred. As of December 31, 2023 and 2022, no allowance for credit losses was recorded. If a participant did not make loan repayments and the plan administrator considered the participant loan to be in default, the loan balance was reduced, and the delinquent participant note receivable was recorded as a benefit payment based on the terms of the Plan document.

**Subsequent Events.** The Plan has evaluated subsequent events through October 14, 2024, the date which the financial statements were available to be issued.

**Note 4. Investment in Insurance Contract**

At December 31, 2022 and prior to the plan merger, the Plan had invested in a fully benefit-responsive guaranteed investment contract investment option, the Fixed Select Contract issued by Nationwide Financial Services, Inc. and Subsidiaries ("NFS").

NFS maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract met the criteria to be considered fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. The investment contract was presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the plan by NFS, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**Note 5. Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority.

**Note 5. Fair Value Measurements**

The Plan used appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measured fair value using Level 1 inputs because they generally provided the most reliable evidence of fair value. Level 2 inputs were used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There were no changes in the methods used to measure fair value at December 29, 2023, prior to merger or at December 31, 2022.

*Mutual funds:* At December 29, 2023, prior to merger, and on December, 31, 2022, mutual funds were valued based on quoted market prices. Shares of mutual funds were valued at quoted market prices as of the last trading day of the Plan year. Participant loans were valued at amortized cost, which represents fair value.

**Note 7. Tax Status**

The Plan, prior to its merger, was a tax-qualified retirement plan under Code Section 401(a), with a qualified cash or deferred arrangement under Code Section 401(k). The Plan was an adopted form of the Non-Standardized Prototype Profit Sharing Plan with CODA (“Non-Standardized Plan”). The Non-Standardized Plan received an opinion letter from the IRS dated June 20, 2020, which stated that the language of the Non-Standardized Plan was in compliance with the applicable requirements of the Code. Although the Plan was amended since receiving the opinion letter, the Plan administrator believes that the Plan was designed, and was being operated in compliance with, the applicable requirements of the IRC and, therefore, believed that the Plan was qualified, and the related trust was tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Related Party Transactions**

The Plan held certain investments in a guaranteed investment contract that is managed by an affiliate of the Plan trustee. This affiliate is considered a party-in-interest (as defined in ERISA) to the Plan. As of December 31, 2023 and 2022, funds of \$0 and \$953,675 respectively, were held in such investments and are considered party-in-interest transactions.
