Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Exelco Leasing, Inc 401(k) Employee Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements

NOTE 1 — DESCRIPTION OF PLAN

The following description of the Exelco Leasing, Inc 401(k) Employee Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of PECL, Inc. (the Company) and participating employers, who are eighteen or older and have completed three consecutive months of employment. Employees are eligible to enter the Plan on the first day of the month following the date the eligibility requirements have been met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Matrix Trust Company is the custodian for the Plan and CUNA Mutual Group is the third party administrator (TPA), with Fidelity National Information Solutions providing recordkeeping services. The Company is the plan administrator and has overall responsibility for the operation and administration of the Plan. The plan administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance. A managing director of the Company serves as the trustee of the Plan investments.

Contributions

Participants may contribute up to 100% of annual eligible compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan provides automatic enrollment of 3% (pre-tax) for employees who meet the eligibility requirements. Pre-tax contributions for automatic enrollments are increased annually by 1%, up to 10% of eligible compensation. Employees have the option to decline enrollment.

The Plan provides for safe harbor matching contributions which is determined as a percentage of participant elected deferrals. The Company contributes an amount equal to the sum of 100% of the amount of the participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the amount of the participant's elective deferrals that exceed 3% of the participant's Compensation but do not exceed 5% of the participant's compensation.

Discretionary profit-sharing contributions are determined annually by the Company. Profit sharing contributions are allocated to each participant grouping, and based upon the ratio of the participant's compensation to the total compensation for the Company. Employees must be employed on the last day of the plan year to be eligible for the profit-sharing contribution. There were no Company profit sharing contributions during the year ended December 31, 2023.

Contributions are subject to certain IRS limitations. Participants may also transfer funds to the Plan from other qualified retirement plans.

Investment Options

Participants of the Plan elect investment accounts in which their contributions, as well as Company contributions, are invested. The investment account options comprise various degrees of risk and return.

Participant Accounts

Each participant's account is credited with the participant's contribution and Company contributions, and investment earnings based on their selected investments. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and employer safe harbor contributions, plus earnings thereon. Vesting in the Company's discretionary profit sharing contribution portion of their accounts is based on years of service, as follows:

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of the participant's vested account balance, whichever is less. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits

On termination of service, death, disability and attainment of normal retirement age, participants may elect to receive an amount equal to the value of the vested interest in their accounts in either a lump-sum amount or in installments, depending on the size of the participant's account balance at the time of termination.

In-service distributions are allowed when a participant reaches age 59½. Rollover contributions may be withdrawn at any time. The Company may authorize certain withdrawals from a participant's account in the event of proven financial hardship. Hardship withdrawals are subject to specific statutory and regulatory requirements.

Forfeited Accounts

Forfeited balances of terminated participants' nonvested accounts may be used to reduce Company contributions or pay administrative expenses. For the year ending December 31, 2023, forfeitures of \$334 were used to pay plan expenses and \$292 were used to reduce Company contributions. There were no unallocated forfeitures at December 31, 2023 and 2022.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Contributions

Contributions from participants are recorded in the period in which they are withheld from the participant's wages. Contributions from the Company are recorded in the period in which the related participant's wages are paid.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Fees related to the administration of notes receivable from participants and benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

Subsequent Events

Subsequent events were evaluated through October 10, 2024, which is the date the financial statements were available to be issued.

NOTE 3 — CERTIFIED INFORMATION

Information related to investments and notes receivable from participants at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2023, disclosed in the accompanying financial statements and supplemental schedules, was obtained or derived from data provided to the plan administrator and certified to as complete and accurate by the Matrix Trust Company and CMFG Life Insurance Company.

NOTE 4 — FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the SEC. The funds must publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Common/Collective trust: Valued at the NAV of units of the fund, the practical expedient to estimate fair value, which is based on the estimated market value of the underlying investments less its liabilities.

NOTE 5 — FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan has a traditional fully benefit-responsive unallocated Deposit Administration Group Annuity Contract (DAGA) with CMFG Life Insurance Company (CMFG). CMFG maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The DAGA issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract value of the investment contract at December 31, 2023 and 2022 was \$346,596 and \$753,868, respectively. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The crediting rate is reviewed on a quarterly basis for resetting. The DAGA does not permit the insurance company to terminate the agreement under normal circumstances.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by CMFG, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 — PARTY-IN-INTEREST TRANSACTIONS

The Plan holds a group annuity contract managed by affiliates of CUNA Mutual Group. Onedigital Investment Advisors LLC and Mutual Advisors are the investment advisors of the Plan. Total fees paid from the Plan to these entities for the year ended December 31, 2023 was \$38,743. These transactions qualify as party-in-interest transactions.

NOTE 7 — PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their company contributions.

NOTE 8 — TAX STATUS

As this Plan is a pre-approved defined contribution plan, the Internal Revenue Service issued a letter dated June 30, 2020, stating that while they do not issue a determination as to whether a specific employer’s plan is qualified, any employer who adopts this Plan will be considered to have a plan qualified under code Section 401(a) provided all the terms are not more favorable for officers, owners, or highly compensated employees than for other employees. Management believes that the Plan is operating in compliance with all the terms provided in the nonstandardized plan agreement.

The plan is subject to examination by the IRS for the statutory period.

NOTE 9 — RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 — DELINQUENT CONTRIBUTIONS

During the years ended December 31, 2023 and 2022, the Company failed to remit to the Plan’s custodian certain participant contributions within the period prescribed by the Department of Labor’s regulations. Delinquent employee contributions totaled \$49,400 and \$306,112 for the years ended December 31, 2023 and 2022, respectively. The Company intends to restore the affected participants’ accounts for potential lost income due to the delays during the 2024 plan year.

NOTE 13 — SUBSEQUENT EVENT

The plan document was amended and restated effective August 1, 2024. The significant changes are as follows:

- The Plan name was changed to HUB, Inc. 401(k) Employee Retirement Plan.
- The Plan sponsor changed to HUB, Inc., with Exelco Leasing, Inc. as a member of a controlled group.
- Eligible compensation for safe harbor matching contribution was changed to remove the exclusion of bonuses for highly compensated employees.
- Leased employees were removed as an excluded class for the purposes of determining eligibility to enter the Plan.
