### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Datron World Communications, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). #### 1. Description of the Plan

The following description of the Datron World Communications, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

##### *General*

The Plan is a defined contribution plan established and sponsored by Datron World Communications, Inc. (the “Company”), covering substantially all employees of the Company and its affiliate entities, Datron Holdings, Inc. and Servant Leadership Institute, Inc., except for employees covered by collective bargaining agreements, nonresident aliens, leased employees and residents of Puerto Rico. Employees are immediately eligible after 3 months of service. There is no age or hours of service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective September 8, 2023, the Company was acquired by Cyberlux Corporation, which resulted in a change in ownership of the Company. See Note 9.

The Plan provides participants with a salary deferral option pursuant to Section 401(k) of the Internal Revenue Code (“IRC”). The Company is the administrator of the Plan and is the Plan’s named fiduciary for purposes of Section 402(a) of ERISA. As administrator, the Company has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. The Plan’s trustee, Fidelity Management Trust Company (“Trustee”), has the authority and responsibility for the management and investment of Plan assets.

##### *Contributions*

Participants may elect to contribute up to 90% of annual compensation as pre-tax or Roth contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions, as defined in the Plan document. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The automatic deferral percentage will increase by 1% per year up to a maximum of 15% of eligible compensation.

The Company, at its sole discretion, may elect to make discretionary matching contributions. For 2023, the Company elected not to make any matching contributions. Contributions are subject to certain IRC limitations.

#### *Participant investment account options*

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds, one money market fund, one pooled separate account and two common collective trust funds as investment options for participants.

#### *Participant accounts*

Each participant's account is credited with the participant's contributions, Company contributions, investment earnings and an allocation of certain Plan administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

#### *Vesting*

Participants are immediately 100% vested in their contributions plus actual earnings thereon. Participants hired prior to January 1, 2016 are 100% vested in the Company's discretionary matching contributions plus actual earnings thereon. For participants hired after January 1, 2016, vesting in the Company's discretionary matching contributions plus actual earnings thereon vest according to the following schedule:

3	100%

Participants are fully vested upon retirement, death, disability, or termination of the Plan.

#### *Forfeitures*

Unvested amounts forfeited by terminated employees may be used to reduce expenses related to the administration of the Plan or to reduce the Company's discretionary matching contributions. During 2023, no forfeited funds were used to reduce expenses related to the administration of the Plan or to reduce the Company's discretionary matching contributions. At December 31, 2023 and 2022, unvested forfeited accounts totaled \$12,429 and \$10,338, respectively.

#### *Notes receivable from participants*

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with the rate charged by other lenders for notes made under similar circumstances. Note repayment periods may not exceed five years, except for notes used to purchase or improve the participant's primary residence, which have a repayment term not to exceed 15 years. Principal and interest are paid through payroll

deductions. A participant may have a maximum of two notes outstanding at any time. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

### *Benefit payments*

Upon termination of service due to death, disability, retirement or other reasons, a participant will receive a lump sum distribution equal to the value of the participant's vested interest in his or her account if the participant's account does not exceed \$1,000. Any distribution greater than \$1,000 but less than \$5,000 that is made before the participant's normal retirement age (or age 62, if later) will be rolled over to an individual retirement account (IRA) designated by the Plan administrator, unless the participant consents to receive a lump sum payment. Pre-retirement distributions are allowed upon either attaining the age of 59-1/2 or experiencing a financial hardship, as defined by the IRC. Such withdrawals are subject to applicable excise and income taxes and may only be made with the approval of the Plan administrator. Benefits are recorded when paid.

### *Administrative expenses*

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

### *Plan termination*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the ERISA. In the event of such termination, the Plan document provides that participants would become fully vested in their accounts.

## **2. Summary of Significant Accounting Policies**

### *Basis of accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with standards generally accepted in the United States of America ("GAAP").

### *Use of estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of income and expenses during the reporting period. Actual results could differ from estimates.

#### 3. Information Certified by the Plan's Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments:

- Investments at fair value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### 4. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described below:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Mutual funds and money market fund:* Valued at the daily closing price as reported by the fund. Mutual funds and the money market fund held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Pooled separate account:* Valued at the NAV of units of the separate account. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Common collective trust funds:* Valued at the NAV of units held by the Plan at year end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### *Investment valuation and earnings*

The Plan presents in the statement of changes in net assets available for benefits the net appreciation in the fair value of its investments, which consisted of the realized gains or losses on sales of investments and the unrealized appreciation or depreciation of those investments.

### 5. Tax Status

The Plan administrator has adopted a Fidelity Volume Submitter Plan ("volume submitter plan"). The volume submitter plan received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the volume submitter plan is qualified under the

applicable sections of the IRC. Although the volume submitter plan and the Plan have been amended since receiving the IRS opinion letter, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management of the Plan is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The tax positions taken by the Plan have been analyzed and, as of December 31, 2023, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability, asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 6. Party-In-Interest Transactions

Certain Plan assets are invested in Trustee accounts. Certain officers of the Company are current participants in the Plan. The Plan has notes receivable from certain of its participants. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

#### 7. Risks, Uncertainties and Concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2023 and 2022, approximately 16% and 17% of the Plan's investments were invested in the State Street Target Retirement 2020 Fund Class K, respectively.

#### 8. Reconciliation of Financial Statements to Schedule H of Form 5500

Net assets available for benefits and the net decrease in net assets available for benefits, as reported in the accompanying financial statements, are consistent with amounts reported in Schedule H of the Form 5500.

#### 9. Subsequent Events

Effective March 29, 2024, substantially all employees of Cyberlux Corporation and its affiliate entity, Catalyst Machineworks, are eligible to participate in the Plan.

The date through which subsequent events have been considered for these financial statements is October 10, 2024, the date the financial statements were available to be issued.
