We have performed audits of the accompanying financial statements of Aloha Auto Group, Ltd., 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 (liquidation basis) and 2022 (ongoing modified cash basis), and the related statement of changes in net assets available for benefits for the year ended December 31, 2023 (liquidation basis), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Aloha Auto Group, Ltd., 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in liquidation, in accordance with accounting principles generally accepted in the United States of America (2023) and in accordance with the modified cash basis of accounting (2022).
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Aloha Auto Group, Ltd., 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As further discussed in Notes 1 and 8 to the financial statements, the Plan Sponsor and Administrator of the Aloha Auto Group, Ltd., 401(k) Plan approved a plan of liquidation on July 31, 2023, and management determined liquidation is imminent. As a result, Aloha Auto Group, Ltd., 401(k) Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan’s transactions that are presented and disclosed in the financial statements are in conformity with the plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Aloha Auto Group, Ltd., 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the liquidation basis of accounting (2023) and the modified cash basis of accounting (2022).

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the liquidation basis of accounting (2023) and the modified cash basis of accounting (2022).

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Plan Description

The following description of Aloha Auto Group, Ltd. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan was established on January 1, 2014, and restated January 1, 2018, as a defined contribution plan covering all eligible employees of Aloha Auto Group, Ltd. (the “Company”). All employees, excluding non-resident aliens, and part-time, temporary or seasonal employees, who have completed six months of service were eligible to participate in the Plan. An employee entry date into the Plan was the first day of the month following completion of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

In July of 2022, the Plan was formally amended for the Coronavirus Aid, Relief, and Economic Security Act (“CARES Act”) provisions, as well as to implement the SECURE Act and other applicable law changes. The CARES Act provisions were applicable only to the extent of Coronavirus-related distributions, participant loan relief and the waiver of the 2020 required minimum distributions.

Plan Termination and Liquidation

On May 8, 2023, the Plan Sponsor entered into an asset purchase agreement to sell the assets of the Plan Sponsor. The agreement closed on July 31, 2023. The Company has discontinued all contributions as of August 15, 2023. The Plan Sponsor announced the termination of the Plan and on November 22, 2023, transferred existing account balances into successor plans.

Contributions

Participant Salary Deferral

Prior to the plan termination, participants in the Plan were able to make contributes of a discretionary amount of their annual compensation and bonus provided that the participant’s contribution did not exceed the maximum dollar amount determined by the Internal Revenue Service (“IRS”) each year, which was \$22,500 and \$20,500 for the years ended December 31, 2023 and 2022, respectively. Employees over the age of 50 were eligible to elect to contribute an additional \$7,500 and \$6,500, for the years ended December 31, 2023 and 2022. Participants were also able to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 1% of eligible compensation and their contributions invested in the default investment alternatives until changed by the participant. The amount to be automatically withheld increased by 1% each plan year until the amount withheld reached 6% of compensation or the deferral election was changed by the participant.

Employer Discretionary Matching and Nonelective Contributions

Prior to the Plan termination, the Company was able to make a discretionary matching and nonelective contribution to the Plan, although the Company was not required to do so. The amount of the contributions were determined by the Company and allocated to participants at the end of the Plan year. Company contributions are subject to certain limitations. During 2023, the Company made a matching contribution of \$125,000, for the year ended December 31, 2022.

Vesting

Prior to the Plan termination, participants were immediately vested in their contributions plus actual earnings thereon. Participants vested in the Company's discretionary profit sharing and matching contributions plus actual earnings thereon based on the following schedule:

Participant Accounts

Prior to the Plan termination, individual participant accounts were credited with applicable participant contributions and the Company's contributions; plus an allocation based on each participant's compensation and account balance of the Company's profit-sharing contribution, forfeitures of terminated participants' nonvested benefits, and the Plan's net earnings. Allocations were based upon participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures

Prior to the Plan termination, a participant who terminated employment and is less than 100% vested forfeits the non-vested portion of their account. Forfeitures were used to pay administrative expenses of the Plan with any remaining amounts to be used to reduce the employer contributions. There were approximately \$3,116 in forfeitures used to reduce fees during the year ended December 31, 2023. The forfeiture account totaled approximately \$1,841 and \$3,225 for the years ended December 31, 2023 and 2022, respectively.

Investment Options

Prior to the Plan termination, participants were able to direct the investment of their contributions into various investment options offered by the Plan. The Plan offered various mutual funds as investment options for participants. For participants who did not make an investment election, the accounts were invested in accordance with the default investment alternatives established by the Plan.

Distributions

Prior to the Plan termination, distributions from the Plan were permitted under the following circumstances: (i) normal retirement age (59 ½ for in-service distributions), (ii) termination of employment, (iii) death or permanent disability, (iv) a proven hardship, and (v) qualified birth or adoption. Distributions from a participant's account were made in the form of a lump-sum payment, installment payments or partial distributions. If a participant's account balance did not exceed \$5,000, the distributions could only be made in the form of a lump-sum payment and could be distributed to a terminated participant without consent.

Notes Receivable from Participants

Prior to the Plan termination, in general, the plan administrator may permit participants to borrow from their fund accounts, up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance, which is the amount limited under the Internal Revenue Code ("IRC").

Prior to the Plan termination, loans were secured by the balance in the participant's account and bear interest at 2% above the prime interest rate and carry a maximum maturity of five years. In cases where the loan was used to acquire principal residences, the maturity may exceed five years. Loans were repaid through payroll deductions. At December 31, 2023, and 2022, participant loans were \$- and \$122,425, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

As a result of the termination of the Plan, the December 31, 2023 financial statements of the Plan are prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America. For the year ended December 31, 2022, the financial statements of the Plan are prepared on the modified cash basis of accounting (ongoing). The liquidation basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable and the net realizable value of assets is reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realizable cash value and liabilities are stated at their anticipated settlement amounts. The estimated net realizable cash value for investments as of December 31, 2023 would be fair value. Management determined that the liquidation value of the Plan's investments approximated their fair value and did not result in any material changes to the December 31, 2023 financial statements as a result of the change under the liquidation basis of accounting.

The financial statements, for the year ended December 31, 2022 prepared on the modified cash-basis of accounting, have been modified to record assets or liabilities with respect to cash transactions and events that provide a benefit or result in an obligation that covers a period greater than the period in which the cash transaction or event occurred. The modifications result in the recording of investments and related short-term obligations on the Statements of Net Assets Available for Benefits (Modified Cash Basis). This method of accounting represents a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America ("U.S. GAAP"). This basis of accounting differs from U.S. GAAP primarily because contributions are recorded when received, investment income is recorded as it is collected, and benefit payments and expenses are recorded when paid.

Investment Valuation and Income Recognition

Investments in registered investment companies are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is included in income when earned, based on the terms of the investments and the periods during which the investments are owned. Dividends are recorded on the ex-dividend date.

The Plan presents, in the Statement of Changes in Net Assets Available for Benefits, the net change in the fair value of its investments which consists of realized gains or losses, and unrealized appreciation or depreciation on those investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the cash basis. Related fees are recorded as administrative expenses and expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with the liquidation basis of accounting as of December 31, 2023 and the ongoing modified cash basis of accounting as of December 31, 2022, requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities, at the date of the financial statements and the reported amounts of the Plan income and expenses during the reporting period. Actual results could differ from those estimates.

Administrative Fees

The Plan is sponsored and administered by the Company. Certain administrative functions are performed by officers or employees of the Company, who receive no compensation from the Plan. All administrative expenses are the responsibility of the Plan; however the Company at its discretion may pay such expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative fees. Investment related expenses are included in net appreciation (depreciation) of fair value of investments. As of December 31, 2023 and 2022, investments are in the custody of Empower Trust Company, LLC ("Empower"), which also provides recordkeeping services to the Plan.

CARES Act

In March 2020, the COVID-19 outbreak was declared a pandemic by the World Health Organization. The COVID-19 pandemic has led to increased volatility in financial markets. The extent to which such increased volatility will impact the value of the Plan assets will depend on future developments that are highly uncertain and cannot be predicted.

The outbreak of the coronavirus ("COVID-19") pandemic has adversely affected, and may continue to adversely affect, economic activity globally, nationally, and locally. Following the COVID-19 outbreak in March 2020, the values of investment securities have experienced significant volatility. These economic and market conditions and other effects of the COVID-19 pandemic may continue to adversely affect the Plan. The extent of the adverse impact to the amounts reported in the 2023 Statement of Net Assets Available for Benefits will depend on future developments that are highly uncertain and cannot be accurately predicted.

3. Information Prepared and Certified by the Trustee of the Plan as Complete and Accurate

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Empower Trust Company, LLC ("Empower"), the trustee of the Plan has certified that the following data included in the accompanying financial statements is complete and accurate.

During the year ended December 31, 2023, the Plan's investments (including gains and losses on investments bought and sold, as well as held, during the period) appreciated in fair value by \$235,112.

4. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification ("ASC") No. 820, *Fair Value Measurements and Disclosures* ("ASC 820"), provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

- **Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

- Common collective trusts: Valued by the determination of the trustee of the common collective trust based on the underlying assets, which represents the net asset value. Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

There have been no changes in the methodologies used at December 31, 2023 and 2022.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

Management evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2023, there were no transfers.

5. Related Party Transactions

The Company administered the Plan from its office. Certain Plan investments were managed by Empower Trust Company, LLC (“Empower”), the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to approximately \$59,500, for the year ended December 31, 2023, are included in administrative fees, on the Statement of Changes in Net Assets Available for Benefits.

6. Tax Status

The Internal Revenue Service (“IRS”) has determined by a determination letter dated November 14, 2022, stating that the underlying non-standardized pre-approved profit sharing/money purchase/CODA plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan administrator has determined the Plan is eligible to and has chosen to rely on the current IRS prototype plan letter. The Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and related trust is tax-exempt.

Plan management evaluates tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of both December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that it is no longer subject to income tax examinations for years prior to 2020.

7. Risk and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities may occur in the near term and those changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

8. Plan Termination

On July 31, 2023, the Plan Administrator approved the termination of the Plan. At that time, participants became 100% vested in their accounts. Subsequent to the August 15, 2023 pay date, no contributions, loan repayments or new loans were allowed into or out of the Plan. Participants were notified that they may elect either a distribution of their account balance or a direct rollover to another eligible retirement plan. As of November 22, 2023, all participants have received distributions or rolled over their account balance to another qualified plan.

9. Subsequent Events

The Plan has evaluated subsequent events for possible recognition or disclosure in the financial statements through October 14, 2024, the date the financial statements were available to be issued.
