Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of MacFarms of Hawaii, LLC 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of MacFarms of Hawaii, LLC 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

1. Description of the Plan

A brief description of the MacFarms of Hawaii 401(k) Profit Sharing Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for vesting and benefit provisions and for more complete information concerning the Plan.

General – The Plan is a trusted contributory and self-directed plan which covers substantially all employees of MacFarms LLC dba MacFarms of Hawaii (Company) who have completed one year of service (during which time the employee performs at least 1,000 hours of service) and are at least 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Eligible participants may make voluntary contributions to the Plan of up to the maximum amount allowable under the applicable provisions of the Internal Revenue Code. Such contributions are nonforfeitable and are credited to the individual account of the participant.

At its discretion, the Company may provide matching contributions and may also contribute to the Plan from its earnings and profits. The contributions by the Company are subject to certain limitations.

Participant Accounts – Each participant's account is credited with the participant's contribution, the Company's contribution, and Plan earnings, and is charged for expenses related to the administration of the participant's account to the extent not paid by the Company.

Vesting – Participants are immediately vested in their voluntary rollover, elective employee salary deferral, and employer contributions and actual earnings thereon.

Notes Receivable from Participants – Participants may borrow a minimum of \$1,000 from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 5.75% to 9.50%, which are commensurate with local prevailing rates as determined by the custodian of the Plan. Principal and interest are paid ratably through monthly payroll deductions.

1. Description of Plan, continued

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant’s vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Plan Termination – Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions set forth in ERISA. In the event of termination of the Plan, the rights of all employees to benefits accrued to the date of such termination are fully vested and nonforfeitable. After satisfying its obligations, the assets of the Plan will be allocated among the participating employees on a pro-rata basis.

2. Summary of Significant Accounting Policies

Basis of Accounting – The statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition – Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s trustees determine the Plan’s valuation policies utilizing information provided by the custodian. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year. See Note 4 for a discussion of fair value measurements.

Notes Receivables from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits – Benefits are recorded when paid.

Use of Estimates – The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Subsequent Events – The Plan’s management has considered subsequent events through the date of the independent auditors’ report, which is the date the financial statements were available to be issued.

3. Information Certified by the Custodian

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator obtained certifications from the custodians of the Plan that all information provided by the custodian is complete and accurate. Information included in the accompanying financial statements as to investment assets, transactions and income, and all information in the supplemental schedule is presented solely in reliance upon the certification.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs that are unobservable, including the Plan’s own assumptions in determining that fair value of assets.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds – Valued using the net asset value (NAV) that are generally obtained from a file feed from the National Securities Clearing Corporation, and/or directly from the fund house, or a secondary pricing source, such as Interactive Data Corporation (IDC).

Collective Trust Funds – In 2022, these funds were valued using the NAV per share that are generally obtained directly from the fund house or other investment provider.

Guaranteed Interest Accounts – The guaranteed interest accounts earn guaranteed interest at specified rates compounded annually. Contributions to these accounts are invested in the general funds of, and are guaranteed by Great-West Life & Annuity Insurance Company (GWL&A). In 2022, guaranteed interest accounts are valued at the closing price reported on the active market on which the individual investments are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

During 2023, the valuation method for the collective trust funds and the guaranteed interest accounts were reevaluated. The collective trust funds were valued using the NAV per share as a practical expedient and therefore not included in the fair value hierarchy. The guaranteed interest account was considered a fully benefit responsive investment contract and valued at contract value.

5. Fair Value of Investments at Net Asset Value

As of December 31, 2023, the collective trust funds' fair value was \$4,325,692. These investments file a Form 5500 as direct filing entities. The plan is permitted to redeem daily at the net asset value and under unusual circumstances, withdrawals may be suspended or deferred if, in its discretion, such action is necessary.

6. Guaranteed Interest Accounts

The Plan has a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America with a contract value of \$12,341 as of December 31, 2023. The contributions made into this contract are maintained in a general account. The contract credits interest daily to the group contract holder on a portfolio basis. The crediting interest rate may change or stay the same each quarter. The quarterly crediting rate applies to all money deposited in the group contract holder's account regardless of when it was deposited. Contributions made and interest are fully guaranteed by the entire general account assets.

A participant can lose money in this fund if the plan sponsor selects a termination option in which there is a market value adjustment or the payout is at market value; initiates one or more events that result in significant withdrawals from the fund; or engages in activities or direct or indirect communications that encourage participants to withdraw from the fund. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

7. Related Party Transactions

Investments are managed by GWL&A, the custodian of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Total administrative expenses paid by the Plan to GWL&A amounted to approximately \$35,000 for the year ended December 31, 2023.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

9. Tax Status

The prototype plan sponsor has obtained an opinion letter dated March 31, 2014, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The plan administrator timely adopted the restated prototype plan. The plan administrator believes that the plan is currently being operated in accordance with the IRC.
