Please be advised that per ERISA, IRS, and Department of Labor regulations all pension plans that file Form 5500 are required to obtain a fidelity bond covering the person(s) who handle the plan funds. For your profit sharing plan this amount would be a bond in the amount of \$100,000 which will cover the 10% of plan assets minimum and allow for growth within the plan's account. Please contact your insurance carrier to purchase this fidelity bond in the amount of \$100,000.

Please review the return for completeness and accuracy. We prepared the return from information you furnished to us, without verifying the data. After examining the return, government authorities may request supporting data. We therefore recommend that you preserve all records that you would be required to produce in the event such an examination were to occur.

Also enclosed is the Summary Annual Report for the plan. The Employee Retirement Income Security Act of 1974 (ERISA) and Department of Labor regulations require the information enclosed herein to be given to each participant and beneficiary receiving benefits after the close of the plan year. As a trustee of your retirement plan, there are fiduciary responsibilities that you need to be aware of. Contributions and loan repayments need to be submitted within 7 days for

small plans (under 100 participants) from the payroll date. We recommend that you remit these amounts on the same date as the associated payroll taxes are paid. Failure to make timely deposits can result in civil penalty by the department of labor against the fiduciary.

You are also responsible for selecting investment providers and investment options and monitoring their performance. This includes scheduling an annual benefits meeting with your investment provider and your employees to review investment choices made by employees and advising them of necessary changes. If your employee accounts are self-directed, you do not need to schedule a benefits meeting, but please remind them annually to meet their individual advisor.



Summary Annual Report

for

KOSCOVE METAL, INC. 401(K) PLAN

This is a summary of the annual report for the KOSCOVE METAL, INC. 401(K) PLAN, (Employer Identification No. 01-0799789, Plan No. 001) for the period January 1, 2023 to December 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$1,949. These expenses included \$1,949 in benefits paid to participants and beneficiaries. A total of 9 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$560,060 as of December 31, 2023 compared to \$426,501 as of January 1, 2023. During the plan year the plan experienced an increase in its net assets of \$133,559. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$135,508, including employer contributions of \$15,055, employee contributions of \$37,844, and other income of \$82,609.

MINIMUM FUNDING STANDARDS

Enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.
