Independent Auditor's Report

To the Plan Administrator and Trustees
Ozark Striping 401(k) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Ozark Striping 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Ozark Striping 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Ozark Striping 401(k) Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Subsequent Event

As discussed in Note 4 to the financial statements, on January 1, 2023, the Plan Committee of Ozark Striping 401(k) Retirement Plan voted to merge into the Frontline Road Safety 401(k) Plan as of January 1, 2024. The Ozark Striping 401(k) Retirement Plan transferred its net assets into the Frontline Road Safety 401(k) Plan and ceased operations as of that date. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Ozark Striping 401(k) Retirement Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users made on the basis of these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgement and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Ozark Striping 401(k) Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Ozark Striping 401(k) Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Note 1. Description of Plan

The following description of the Ozark Striping 401(k) Retirement Plan ("Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for more detailed information.

General: The Plan is a defined contribution plan covering substantially all employees of Ozark Striping Company, LLC ("The Company") who have at least 12 months of service and are at least 18 years old. Non-resident aliens and union members are excluded. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employee Contributions: Eligible employees can elect to contribute an amount starting at 2% of compensation up to 100% of their compensation, as defined in the Plan, subject to certain limitations under the Internal Revenue Code. Participants who have attained the age of 50 before the end of the Plan year are eligible for catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Employer Contributions: The Company can contribute the following: (1) a discretionary matching contribution equal to a percentage of compensation and (2) a discretionary nonelective contribution. For the years ended December 31, 2023 and 2022, the Company made discretionary matching contributions of \$185,829 and \$190,505, respectively. There were no discretionary nonelective contributions for 2023 or 2022.

Participants' Accounts: Each participant's account is credited with the participant's contributions, the allocations of the Company's contribution, and allocations of Plan earnings. Earnings allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contributions portion of their accounts plus earnings thereon is based on years of continuous service.

Payment of Benefits: On termination of service, death, disability or retirement (age 65), a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in the form of a lump sum. In the case of a distribution due to death, the beneficiary may elect to pay out the entire account balance over five years. If a participant has been terminated and his or her account balance is less than \$5,000, the Plan Administrator may elect the cash out distribution feature where the participant's vested interest in his or her account is rolled over into an IRA. Hardship distributions are allowed under the Plan.

Forfeitures: At December 31, 2023 and 2022, forfeited nonvested accounts totaled \$-0- and \$12,461, respectively. These accounts will be used to reduce future employer contributions or to pay administrative expenses. Also, for the years ended December 31, 2023 and 2022, employer contributions were reduced by \$25,864 and \$9,558, from forfeited nonvested accounts, respectively. No forfeitures were used to pay administrative expenses for the years ended December 31, 2023 and 2022.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting: The financial statements of the Plan are prepared using the accrual method of accounting.

Payment of Benefits: Benefits are recorded when paid.

Expenses: During the years ended December 31, 2023 and 2022 the employer absorbed certain costs of managing the Plan.

Note 2. Summary of Significant Accounting Policies, Continued

Subsequent Events: The Plan has evaluated the need for disclosures and/or adjustments resulting from subsequent events through October 15, 2024, the date the financial statements were available to be issued.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2022 excess contributions to the applicable participants after March 15, 2023. For 2022, the Plan will file Form 5330 and the Plan Sponsor will pay the applicable excise tax due to distributing the excess contributions after the deadline. There were no excess contributions payable in 2023.

Note 3. Investment Contract with Insurance Company

The Plan has an investment contract with Voya Retirement Insurance & Annuity (Voya). Voya maintains contributions in a general account. The accounts are credited with their pro rata share of earnings on the underlying investments and charged for plan withdrawals and administrative expenses, if any, by Voya. The contract is included in the financial statements at December 31, 2023 and 2022 at contract value which is determined and is reported to the Plan by Voya. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is credited to the Plan.

Note 4. Plan Merger and Transfer of Plan Assets

On June 2, 2022, Frontline Road Safety acquired the Company. Employees continued participating in the Plan until December 31, 2023. The Plan was merged into the Frontline Road Safety 401(k) Plan effective January 1, 2024, and, on December 31, 2023, the accounts of all Company employees were transferred out of the Plan to the Frontline Road Safety 401(k) Plan (and existing plan controlled by the acquiring company).

Note 5. Tax Status

The Plan obtained its latest determination letter dated June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan Administrator believes that the Plan is qualified and the related trust is tax exempt as of the financial statement date.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Related Party and Party-in-Interest Transactions

Certain plan investments are shares of funds managed by Voya Retirement Insurance and Annuity Company (Voya), the Custodian, as defined by the Plan. Therefore, these transactions qualify as party-in-interest. Fees paid by the Plan to Voya for services rendered amount to \$9,300 and \$8,550 for the years ended December 31, 2023 and 2022, respectively.

Note 9. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data or correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be relevant observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Pooled Separate Account: Valued at the net asset value of shares held by the Plan at year-end. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. The net asset value is based on the market value of the underlying investments. The net asset value of these accounts is not a publicly quoted price in an active market. There are currently no significant redemption restrictions on these investments.

All investments of the Plan that are presented at fair value are measured at net asset value as a practical expedient. Therefore, in accordance with Subtopic 820-10, investments that were measured at net asset value per share (or its equivalent) that have not been classified in the fair value hierarchy.


