### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Heartland Cardiology, LLC Profit Sharing 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

**1. Description of Plan**

The following brief description of Heartland Cardiology, LLC Profit Sharing 401(k) Plan (the Plan) provides general information only. Participants should refer to the Plan agreement for a more complete description of the Plan provisions.

***General***

The Plan was established on April 1, 1995, restated effective January 1, 2022, to incorporate recent legislative and regulatory changes. The Plan was amended effective April 3, 2023 for a change in Trustees. The Plan is a defined contribution plan sponsored by Heartland Cardiology, LLC (Company) for the benefit of its employees who have completed at least one year of service and 1,000 hours. Eligible employees may make pre-tax salary deferral and after-tax Roth salary contributions to the Plan. Employees may enter the Plan the first day of the Plan Year or the first day of the seventh month of the Plan Year coinciding with or next following the date they satisfy the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Trustees determine the appropriateness of the Plan's investment offerings and monitor investment performance.

In December 2022, the Company partnered with US Heart and Vascular (USHV) to be part of a physician-led initiative of independent cardiovascular providers to improve patient care delivery and reduce costs to the healthcare system. In conjunction with this partnership, the Plan's assets will be transferred to the USHV Employee Savings Plan beginning in March, 2024 and is estimated to be completed in 2025.

***Contributions***

The Plan permits eligible employees, through a salary deferral election, to have the Company make annual pre-tax or Roth contributions of up to 100% of their eligible compensation but not exceeding the maximum amount allowed by law. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan Year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes matching contributions of 50% of employees' salary deferral amounts on the first 4% of employees' compensation, and may choose to make a discretionary profit sharing contribution. In order to share in the match and profit sharing, the participant must be employed on the last day of the Plan Year. If employment is terminated, the participant is still eligible for both the match and profit share if they have completed a year of service during the Plan Year. The match and profit share contributions are paid in a lump sum once a year. Contributions are subject to certain IRS limitations.

***Participant Accounts***

Each participant has the option of directing his contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Each participant's account is credited with the participant's contributions and earnings on their participant-directed investments, and are charged with an allocation of administrative expenses. Each participant's account is also credited with the Company match and profit sharing contributions at the end of the year allocated to the same participant-directed investments and earnings on those investments. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their participant contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service as follows:

***Notes receivable from participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. A participant may not have more than one loan outstanding at any time. Loan terms may not exceed 5 years, except for loans used for the purchase of a principal residence, and must provide for payments to be made not less frequently than bi-weekly. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate of local prevailing rates. Participants are charged for any related loan fees.

***Payment of Benefits***

Upon termination of service for reasons other than death, disability or normal retirement, a participant will be entitled to receive only the vested percentage of their account balance. They may elect to have their vested account balance distributed as soon as administratively feasible after the last day of the Plan year coinciding with or next following the date on which they terminated employment. However, if the value of the vested account balance does not exceed \$5,000, then a distribution will be made regardless of whether they consent to receive it. If a participant reaches normal retirement age of 59 ½ or is terminated due to disability, they will

automatically become fully vested in all their accounts. If a participant dies while still employed by the Employer, then their vested account balance will be used to provide their beneficiary with a death benefit. The Plan also allows for in-service distributions when a participant reaches age 59 ½, which is the Plan's normal retirement age.

***Forfeited Accounts***

Forfeitures occur when an employee is terminated and is not fully vested in their plan account. Forfeitures of terminated participant's non-vested accounts in the employer match and profit sharing portion of the Plan may be used to pay administrative expenses or applied to reduce Company contributions. For the year ended December 31, 2023, forfeited nonvested accounts totaled \$30,500 and \$11,111 of prior year forfeitures were used to pay Plan expenses. The forfeiture account balance as of December 31, 2023 and 2022, was \$62,588 and \$34,173, respectively.

***Administration of the Plan***

The Plan's assets are held in a group annuity contract provided and administered by Principal Life Insurance Company and its affiliated entities (Principal) or in self-directed brokerage accounts managed by Wells Fargo and Charles Schwab. Recordkeeping services are provided by Principal and third-party administration services are provided by Compensation Benefit Planning, Inc. Compensation Benefit Planning, Inc was acquired by ERP Retirement Services in April, 2023. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians and recordkeeper. See Note 4 for discussion of fair value measurements.

*Investment Valuation and Income Recognition (continued)*

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022.

*Payment of Benefits*

Benefits are recorded when paid. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not been paid, as of December 31, 2023.

*Administrative Expenses*

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants, benefit payments, and other recordkeeping functions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses for self-directed brokerage accounts are included in administrative expenses. Investment-related expenses for other investments are included in net appreciation (depreciation) of fair value of investments.

**3. Information Certified by Asset Custodians (Unaudited)**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the asset custodians have certified that the following data included in the financial statements and supplemental schedule is complete and accurate.

The following information was certified by Principal Life Insurance Company and Principal Trust Company, the asset custodians, as of December 31, 2023 and 2022, and for the year ended December 31, 2023:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2023 and 2022, excluding self-directed brokerage accounts of \$6,191,705 and \$10,596,989, respectively.
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2023, excluding income from self-directed brokerage accounts of \$872,254.
- Investments presented in Schedule H, Line 4i – schedule of assets (held at end of year) as of December 31, 2023, excluding self-directed brokerage accounts of \$6,191,705.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in an active market for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices available in active markets for identical assets or liabilities as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts and Common/collective trusts:* Valued at the net asset value (NAV) of units held by the Plan at year end based on the market value of its underlying investments. As the pooled separate accounts and common/collective trusts are not available in an active market, the NAV of the units are approximated based on the quoted prices of the underlying investments that are traded in an active market which is available to current investors and is the basis for current transactions.

*Self-directed brokerage accounts:* Accounts primarily consist of interest-bearing cash, common stocks and mutual funds that are valued on the basis of readily determinable market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

The Plan entered into this traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a semi-annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**5. Fully Benefit-Responsive Investment Contract (Continued)**

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

**6. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan has a number of service providers as described under Administration of the Plan in Note 1. Transactions with these parties qualify as exempt party-in-interest transactions under ERISA. The Plan paid fees totaling \$144,961 to these parties during the year ended December 31, 2023.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100 percent vested in their accounts.

As discussed in Note 1, the Plan's assets will be transferred to the USHV Employee Savings Plan beginning in March, 2024 and is estimated to be completed in 2025. In conjunction with the transfer, participants will retain their previous vesting schedule.

**8. Tax Status**

The Company has adopted a non-standardized prototype plan sponsored by Compensation Benefit Planning, Inc. The IRS determined and informed the prototype plan by letter dated June 30, 2020 that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
