## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Parks-Village Nashville, LLC 401(K) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Key Rehabilitation, Inc. 401(K) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. **NOTE A - DESCRIPTION OF PLAN**

The following description of the Parks-Village Nashville, LLC 401(K) Plan (“the Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a multiple employer defined contribution plan that provides retirement benefits for employees of the following employers (collectively the “Plan Sponsor”):

Carney Title, LLC and Hale Title & Escrow, LLC became participating employers effective January 1, 2022. Regal Title became a participating employer effective August 1, 2022. 310 Property Management, LLC dba Evergreen Real Estate became a participating employer effective September 1, 2022. The Plan covers most employees who are age twenty-one or older (“participants”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was originally January 1, 2019.

Contributions

Participants may voluntarily make qualified retirement contributions to the Plan which are deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code (“IRC”). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants may make a minimum contribution of 1% to a maximum of 92% of their total annual compensation, as defined in the plan agreement, subject to certain IRC limits. Participants may designate all or a portion of their contributions as Roth deferral contributions at the time their deferral election is made.

The Plan is a safe harbor 401K plan requiring the Plan Sponsor to make matching contributions in an amount equal to 100% of the first 3% and 50% of the next 2% of the of a participant’s contributions.

The Plan also provides that the Plan Sponsor may contribute each year a discretionary contribution in an amount authorized by the Plan Sponsor’s Board of Directors; however, an annual discretionary contribution is not required. Participants must be employed on the last day of the plan year to be eligible to receive an allocation of the employer discretionary contribution. During 2023 and 2022, the Plan Sponsor did not make a discretionary contribution.

Plan Sponsor and participant contributions may not exceed the maximum amount allowable for federal income tax purposes.

Participant Accounts

Each participant's account is credited or charged with the participant's contributions, allocations Plan Sponsor contributions, investment earnings or losses, and administrative expenses. Allocations are based on participant compensation or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their elective salary deferral contributions and the Plan Sponsor's matching contributions plus actual earnings or losses thereon. Vesting in the Plan Sponsor's discretionary contributions plus earnings or losses thereon is based on years of continuous service. Participants vest ratably at approximately 20% after the second year of service and each year thereafter until fully vested after 6 years of service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balances in the participants' accounts and bear interest at the prime rate plus 2%. Interest rates range from 5.25% to 10.50% at December 31, 2023, which is commensurate with local prevailing rates as determined periodically by the plan administrator at the time the notes were taken. Principal and interest are collected ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, permanent disability, or retirement, a participant with an account balance that exceeds \$5,000 may elect to receive either a lump-sum payment or annual installments over a specified period equal to his or her entire account. For termination of service due to other reasons, a participant with an account balance that exceeds \$5,000 will be entitled to receive only the vested interest in his or her account. If the vested value of a participant's account is less than \$5,000, the total vested balance is distributed as an automatic lump-sum payment in cash.

Hardship Withdrawals

The Plan permits distributions in the event of a financial hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59 1/2. Hardship withdrawals are limited to the participant's elective account balance.

**NOTE A - DESCRIPTION OF PLAN (CONTINUED)**

Administrative expenses

Certain expenses for maintaining the Plan are paid by the Plan or the Plan Sponsor. Fees incurred for investment management services are netted within the net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than as a direct payment. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments in pooled separate accounts are stated at fair value. The investment contract is stated at contract value, which approximates fair value. Refer to Note D for additional information about fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America which requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTE D – FAIR VALUE MEASUREMENTS**

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE D – FAIR VALUE MEASUREMENTS (CONTINUED)**

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2023 and 2022.

- (i) *Pooled separate accounts:* Valued at net asset value, which is based on the market value of the underlying investments held by the pooled separate accounts at year end. The net asset value is not a publicly-quoted price in an active market. The accounts provide for daily redemptions by the Plan at reported net asset values per share with no advance notice required or restrictions on redemptions.
- (ii) *Investment contract:* Valued at contract value, which approximates fair value, based on the amount the Plan Sponsor would receive if they terminated the contract at the reporting date, which is book value less an early withdrawal charge, discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. The investment contract provides for daily redemptions. See Note F for additional contract provisions of the investment contract.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E – INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan is party to an investment contract with the custodian, the VOYA Fixed Account. The contract underlying this investment option is considered to be fully benefit-responsive. The custodian maintains the Plan's contributions in a general account which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by the custodian. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment without restrictions.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. As of December 31, 2023, the contract value of this investment was \$10,875. As of December 31, 2022, the fair value of the contract approximated fair value. The average yield and interest rate credited to participants was approximately 1% for the years ended December 31, 2023 and 2022. The custodian guarantees the credit rate will never fall below the lifetime guaranteed minimum of 1%. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on an annual basis for resetting.

**NOTE F - TAX STATUS**

The Plan Sponsor amended and restated its plan June 1, 2021 by adopting a prototype 401(k) profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service ("IRS") on November 30, 2020, which stated that the prototype plan was designed in accordance with applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. The Plan has been amended since the opinion letter was obtained. However, the plan administrator believes that the adopted prototype plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G – RELATED PARTY TRANSACTIONS**

Certain expenses for maintaining the Plan are paid by the Plan or the Plan Sponsor. Fees incurred for investment management services are netted within the net appreciation (depreciation) in fair value of the investments, as they are paid through revenue sharing, rather than as a direct payment. During 2023 and 2022, administrative fees of \$25,977 and \$13,674, respectively, were paid by the Plan to parties-in-interest. The Plan also holds notes receivable from participants totaling \$49,642 and \$33,364 as of December 31, 2023 and 2022, respectively.

**NOTE H – RISKS AND UNCERTAINTIES**

The Plan invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE I – SUBSEQUENT EVENTS**

The Plan's management has evaluated events and transactions that occurred between December 31, 2023 and October 15, 2024, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.
