INDEPENDENT AUDITOR'S REPORT

To the Partners of
Atalanta Variable Fund, L.P.:

Opinion

We have audited the financial statements of Atalanta Variable Fund, L.P., which comprise the statement of assets and liabilities – in liquidation, including the condensed schedule of investments – in liquidation, as of July 31, 2023, the related statements of operations and changes in partners' capital for the period January 1, 2023 through March 28, 2023 and statement of changes in partners' capital – in liquidation for the period March 29, 2023 through July 31, 2023, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of Atalanta Variable Fund, L.P. as of July 31, 2023, and the results of its operations for the period then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Atalanta Variable Fund, L.P. and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter

Effective March 28, 2023, the General Partner approved a plan of liquidation to liquidate the fund in an orderly manner.

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Atalanta Variable Fund, L.P.'s ability to continue as a going concern for one year after the date that the financial statements are issued.

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion.
