Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Tritech Healthcare Management, LLC 401(k) P/S Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets in liquidation available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets in liquidation available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Tritech Healthcare Management, LLC 401(k) P/S Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the liquidation basis of accounting.
- The information in the financial statements related to assets held by Empower Trust Company, LLC and certified to by the qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Tritech Healthcare Management, LLC 401(k) P/S Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

We draw attention to Note 2a of the financial statements, which describes the basis of accounting. The Plan has changed its basis of accounting from the modified cash basis of accounting to the liquidation basis of accounting effective starting with the 2023 financial statement. Our opinion is not modified with respect to this matter.

Responsibilities of management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the liquidation basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Tritech Healthcare Management, LLC 401(k) P/S Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

NOTES TO FINANCIAL STATEMENTS YEAR ENDED DECEMBER 31, 2023

1. Description of Plan

Plan Sponsor Merger – The plan sponsor, Tritech Healthcare Management LLC entered into a merger agreement with Med-Metrix LLC on May 31, 2023. Under that agreement, Tritech Healthcare Management merged with and into Med-Metrix LLC.

Plan Termination – The plan sponsor adopted a resolution effective October 6, 2023 to merge the plan into the Med-Metrix 401(k) retirement plan. All employer and employee contributions ceased with the transfer of employment to Med-Metrix, and all plan investments were transferred to the Med-Metrix 401(k) plan by December 31, 2023.

The following description of Tritech Healthcare Management, LLC 401(k) P/S Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

a. General

Prior to terminating, the Plan was a defined contribution plan covering all employees of the Company. These employees must have one year of service and are at least 21 years of age. The Plan's sponsor is Tritech Healthcare Management, LLC. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Contributions

Prior to terminating, each year, participants were able to contribute a maximum of 100% of their pre-tax compensation, as defined by the Plan, including a catch-up amount if the participant is age 50 or over. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled into the Plan, unless the affirmatively elect not to participate, with a default rate set at 4% of eligible compensation. Contributions are automatically invested in a designated balance fund until changed by the participant. The Company contributes 25% of the first 3%. The matching Company contribution is invested directly in mutual funds directed by the participants.

c. Participant Accounts

Each participant's account is credited with the employer's contributions and allocations of (a) the Company's contribution and, (b) the Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balance, as defined. The benefit to which a participant is entitled, is the benefit that can be provided from the participant's vested account.

d. Vesting

Participants are immediately vested in the contributions plus actual earnings thereon. Participants shall have a vested percentage in their employer contribution accounts according to a vesting schedule based on years of service. A participant is 100% vested after six years of credited service or if the participant becomes disabled or dies during employment.

1. Description of Plan (Continued)

e. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of 50% of their vested account balance or \$50,000. Loans will be subject to interest charges equal to the annual effective prime rate plus 1%. Loans must normally be repaid within such period as agreed to between the participant and the Plan, up to a maximum of five years. Repayment will normally be made through payroll deductions. Any outstanding loans must be repaid when employment terminates. At December 31, 2023, interest rate was 4.25% – 7.25% per annum, with loans having various maturity dates. Defaulted loans are loans resulting from the failure of a participant to make the required loan payments on an outstanding loan and are considered deemed distributed loans.

f. Payment of Benefits

Participants are eligible to receive benefit payments when they terminate service or reach age 65. On termination of service, a participant may elect to receive an annuity, installment payments or a lump sum amount equal to the participant's account. Benefit payments are also permitted for death, disability or hardship.

g. Forfeited Accounts

Forfeited non-vested accounts may be used to offset future administrative expenses.

2. Summary of Significant Accounting Policies

a. Basis of Accounting

The plan transactions are reported on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America (US GAAP).

b. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

c. Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded if the participant has been terminated. If the participant has not been terminated, the defaulted loan amount remains classified as a Note Receivable. Delinquent loans are considered "in default" and are treated as distributions (taxable to participant) on Form 5500.

2. Summary of Significant Accounting Policies (Continued)

d. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

e. Payments of Benefits

Benefits are recorded when paid.

f. Subsequent Events

Management has evaluated subsequent events through September 12, 2024, the date that the financial statements were available to be issued. No significant material events have been identified that would require adjustment of or disclosure in the accompanying financial statements.

g. Plan Expenses

Expenses other than administrative fees of \$39,337 are paid directly by the Plan sponsor. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. 5. Fair Value Measurements

FASB Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurements and Disclosures* provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs

Mutual Funds:

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively trading.

Money Market Funds:

Valued at \$1 per share. Money market funds held by the Plan are invested in short-term, or less than one year, securities representing high-quality, liquid debt and monetary instruments. The money market funds held by the Plan are deemed to be of high quality and are maintaining a net asset value (NAV) of \$1 per share.

6. Tax Status

The Plan is a prototype plan that has received a determination letter dated March 31, 2008 issued by the National Office of the Internal Revenue Service that the Plan is qualified under Code Section 401. The Plan has been amended since receiving the determination letter; however, the Sponsor believes that the Plan is correctly designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that at December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. Generally, tax authorities can examine tax returns filed for the last 3 years. Currently there are no ongoing tax examinations or pending examinations that the Plan is aware of.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying Statements of Net Assets in Liquidation Available for Benefits and Statement of Changes in Net Assets in Liquidation Available for Benefits.

8. Party-in-Interest Transactions

Certain services are rendered to the Plan by the Company at no cost to the Plan. Investment management fees, paid to Empower Trust Company, LLC, were included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. Empower Trust Company, LLC, is the trustee and record-keeper; therefore, these transactions qualify as party-in-interest transactions.
