## **INDEPENDENT AUDITORS' REPORT**

To the Participants and Plan Administrator  
Goodwill Industries of Santa Clara County  
Defined Benefit Pension Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Goodwill Industries of Santa Clara County Defined Benefit Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 (in liquidation) and 2022 (ongoing), and the related statements of changes in net assets available for benefits for the years ended December 31, 2023 (in liquidation) and 2022 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2023 (in liquidation) and 2022 (ongoing), stating that the certified investment information, as described in Note G to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter – Terminating Plan and Liquidation Basis of Accounting**

As further discussed in Note C to the financial statements, the Board of Directors of Goodwill of Silicon Valley, Inc., the Plan's sponsor, voted to terminate the Plan effective December 31, 2021, and management determined liquidation became imminent on June 16, 2023. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE A – DESCRIPTION OF THE PLAN**

General: The following description of the Goodwill Industries of Santa Clara County Defined Benefit Pension Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a noncontributory defined benefit pension plan that was established in 1988 by Goodwill of Silicon Valley, Inc. (the Organization) to provide benefits to eligible employees, as defined in the Plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (the Code), as amended, and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective March 31, 2009, the Plan was amended to freeze participation in the Plan. On this date, no new participants were eligible to enter the Plan, and no participants accrued further benefits based on pay and service rendered on or after March 31, 2009. The Organization continues to fund the Plan, and benefits accrued prior to March 31, 2009 continue to vest and be distributed.

Administration: The Organization is the administrator of the Plan, and as such, carries out the duties imposed under ERISA. The Organization has appointed a group of designated officers within the Organization to act as the trustees of the Plan. The Plan Administrative Committee controls the operation and administration of the Plan. A third-party administrator, USI Consulting Group (USI), processes and maintains certain participant data records and acts as the actuary as of and for the years ended December 31, 2023 and 2022. Nicolay Consulting Group (Nicolay) processed and maintained certain participant records in 2023 and 2022. The Organization contracts with Enterprise Trust & Investment Company (Enterprise) to act as the custodian.

Funding Policy: It is the policy of the Organization to fund pension costs as accrued. Annual contributions are determined by the Plan's actuary to meet the requirements of the Funding Standard Account prescribed by ERISA and the Code. The Organization contributed \$690,930 and \$0 for the 2023 and 2022 plan years, respectively.

Pension Benefits: Employees are entitled to monthly pension benefits beginning the later of normal retirement age (65) or the fifth anniversary of Plan participation, equal to 30% of their highest average compensation during the measurement period, adjusted by the appropriate factors for years of service as provided by the Plan. Participants or beneficiaries can also elect to receive benefits in a single lump sum. Participants who are married at their distribution date may elect to receive benefit payments in joint and survivor annuity form. Annuities from benefit obligations are satisfied by the purchase of annuity contracts from insurance companies at the time distributions are to begin. Plan liabilities covered by purchased annuity contracts are excluded from net assets available for plan benefits and accumulated plan benefits. During 2023, as part of the Plan termination, the Plan purchased annuity contracts totaling \$2,242,881 (see Note C). The Plan did not purchase any annuity contracts in 2022.

**NOTE A – DESCRIPTION OF THE PLAN (CONTINUED)**

*Pension Benefits (continued):* The Plan permits early retirement, at ages ranging from 55 years to 64 years, for participants with at least ten years of service. The Plan also permits participants who remain employed past their normal retirement date to begin receiving retirement benefits at age 65 or postpone benefit payments to a later date as provided by the Plan. Effective July 1, 2017, for terminated employees, the Plan provides for lump sum distributions to be paid to participants whose vested benefits are less than \$25,000. Effective August 20, 2020, for non-highly compensated participants whose employment was involuntarily terminated during April 2020, the Plan provides for lump sum distributions equal to the actuarial equivalent of the vested accrued benefit payable at normal retirement.

*Death and Disability Benefits:* Death benefits are generally paid in a single lump sum. If a married participant dies, the surviving spouse may elect to receive benefits in the form of a survivor annuity equal to the actuarial equivalent of the participant's accrued benefit at the time of death. Death benefits must generally be paid within five years of death. Active participants who become totally and permanently disabled prior to retirement or termination and such disability continues for a period of six consecutive months and by reason thereof such participant's status as an employee ceases may be entitled to receive a benefit equal to the actuarial equivalent of vested accrued benefit as though the participant had retired. The benefit payable shall be computed as of the anniversary date after termination of employment. Terminated participants who become totally and permanently disabled may be entitled to receive a distribution of the actuarial equivalent of such terminated participant's vested account.

*Vesting:* The Plan provides that benefits vest to participants based on years of service. The value of each participant's account is zero percent vested and forfeitable until after three years of service, at which point their balance vests at a rate of 20% per year over a period of five years. Participants are fully vested after seven years of service. All participants became fully vested when the Plan terminated effective December 31, 2021 (see Note C).

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting:* The financial statements of the Plan are prepared on the liquidation basis of accounting as of and for the year ended December 31, 2023, and the accrual method of accounting as of and for the year ended December 31, 2022, in accordance with accounting principles generally accepted in the United States of America (GAAP). There were no material changes to the actuarial calculations related to the change to liquidation basis of accounting from the accrual method of accounting. Organization contributions are recorded in the valuation period for which they are declared by the Board of Directors.

*Use of Estimates:* The preparation of financial statements in accordance with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note E for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought or sold as well as held during the year.

Actuarial Present Value of Accumulated Plan Benefits: Accumulated plan benefits represent the estimated future periodic payments, including lump sum distributions, under the Plan's provisions that are attributable to services rendered by employees through the valuation date. Accumulated plan benefits include benefits expected to be paid to: a) retired or terminated employees or their beneficiaries, b) beneficiaries of employees who have died, and c) present employees or their beneficiaries. Benefits under the Plan are based on 30 percent of an employee's compensation during the three consecutive years with the highest compensation, divided by 12. The accumulated plan benefits for active employees are based on their average compensation during the three years ending on the date of which the benefit information is presented. Benefits payable under all circumstances (retirement, death and termination of employment) are included, to the extent they are deemed attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits is determined by the Plan's actuary, USI, and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as for death, withdrawal or retirement) between the valuation date and the expected date of payment.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

Payment of Benefits: Benefit payments to participants are recorded upon distribution.

Administrative Expenses: The Plan's expenses are paid by either the Plan or the Organization, as provided by the plan document. Expenses that are paid directly by the Organization are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. Administrative costs and investment advisory fees paid by the Plan were \$33,856 and \$140,385 for the years ended December 31, 2023 and 2022, respectively. Included in the administrative costs paid by the Plan were \$21,472 for insurance premiums, for the year ended December 31, 2022. The Plan's sponsor paid the cost of the insurance premiums plus other administrative expenses totaling \$89,746 for the year ended December 31, 2023.

Subsequent Events: Accounting Standards Codification (ASC) 855-10, *Subsequent Events*, requires additional disclosure for events or transactions that occur after the statements of net assets available for benefits date. The Plan had no subsequent events as of October 14, 2024, which is the date these financial statements were available to be issued.

**NOTE C – PLAN TERMINATION**

The Organization has the right under the Plan to discontinue its contributions at any time and to terminate or modify the Plan. The Organization voted to terminate the Plan during the year ended December 31, 2021. The Organization submitted the standard termination notice to the PBGC in June 2022. On June 16, 2023, the Plan received a favorable determination letter from the IRS regarding the termination. At that time, management determined the liquidation of the Plan became imminent. The Organization completed the remaining termination and liquidation steps in 2023. All assets of the Plan have been distributed to participants and beneficiaries, used to purchase annuity contracts for retirees and those not yet at retirement age, or remitted to the PBGC.

The net assets of the Plan were allocated as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- To the portion of participant's accrued benefits which are derived from the participant's contributions made to the Plan, if any.
- Equally among:
  - 1) Retired participants and their beneficiaries to whom payment commenced at least three years prior to the date of termination and
  - 2) Participants who could have retired and received payment of their benefits at least three years prior to the date of termination.

- To all benefits guaranteed and insured by the Pension Benefit Guarantee Corporation (the PBGC).
- To all other vested accrued benefits not insured by the PBGC.
- To all other accrued benefits provided under the Plan.

Certain benefits under the Plan are insured by the PBGC. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits and certain disability and survivor's benefits. However, the PBGC does not guarantee all types of benefits under the Plan and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of termination. There is a statutory ceiling, which is adjusted periodically, on the amount of a participant's monthly benefit that the PBGC guarantees. Whether all participants receive their benefits when the Plan terminates will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Plan's sponsor and the level of benefits guaranteed by the PBGC.

The Organization contributed \$690,930 to the Plan in 2023 to fund the accumulated plan benefits. During 2023, the Plan made lump sum and annuity benefit payments to participants and beneficiaries totaling \$907,052 and purchased annuity contracts totaling \$2,242,881 for those participants that did not elect lump sum payments. The Organization also made a payment of \$231,632 directly to the Pension Benefit Guarantee Corporation (PBGC) on behalf of participants that the Plan could not locate after exhaustive efforts. This payment is reported as employer contributions and benefits paid to Pension Benefit Guarantee Corporation on the statements of changes in net assets available or benefits.

**NOTE D – INCOME TAX STATUS**

The Organization received a determination letter from the Internal Revenue Service (IRS) dated March 30, 2018, that the Plan qualifies under Sections 401(a) and 401(k) of the Internal Revenue Code (IRC) and is therefore exempt from federal income taxes under Section 401(a) of the IRC. The Plan is also exempt from state income taxes. See Note C regarding the updated determination letter received June 16, 2023. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

**NOTE D – INCOME TAX STATUS (CONTINUED)**

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. No uncertain positions have been identified that would require recognition of a liability (or asset) or disclosure in the financial statements as of December 31, 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2020.

**NOTE E – FAIR VALUE MEASUREMENTS**

The fair value measurements standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under the standard are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted market prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE E – FAIR VALUE MEASUREMENTS (CONTINUED)**

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Mutual Funds and Money Market Fund:* Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Common Stocks:* Valued at the daily closing price reported on the active market on which the individual securities are traded.

*Corporate Bonds:* Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings. When quoted prices are not available for identical or similar bonds, the bond is valued under a discounted cash flows approach that maximizes observable inputs, such as current yields of similar instruments, but includes adjustments for certain risks that may not be observable, such as credit and liquidity risks or a broker quote if available.

*Municipal Bonds and U.S. Government Securities:* Valued using pricing models maximizing the use of observable inputs for similar bonds and securities.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All assets of the Plan had been distributed in liquidation and thus there were no assets at fair value as of December 31, 2023 (In Liquidation).

**NOTE F – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported on the statements of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

**NOTE G – INFORMATION PREPARED AND CERTIFIED BY CUSTODIANS**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2023 (in liquidation) and 2022 (ongoing), and net appreciation (depreciation) in investments at fair value, interest and dividends, and administrative expenses for the years ended December 31, 2023 (in liquidation) and 2022 (ongoing), was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Enterprise (the Trustee of the Plan).

**NOTE H – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

USI and Nicolay are the Plan's actuaries and third-party administrators. Certain Plan investments are shares of a non-interest-bearing cash account managed by Enterprise, the Plan's trustee. These transactions qualify as party-in-interest transactions. The Plan paid USI \$6,847 and \$47,933 in administrative expenses for 2023 (in liquidation) and 2022 (ongoing), respectively. Administrative expenses paid to Nicolay were \$4,370 and \$44,644 for 2023 (in liquidation) and 2022 (ongoing), respectively. The Plan paid Enterprise \$22,004 and \$26,336 in administrative expenses for 2023 (in liquidation) and 2022 (ongoing), respectively.
