NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Datwyler Pharma Packaging USA, Inc. 401(k) Plan are prepared under the accrual basis of accounting using accounting principles generally accepted in the United States of America ("GAAP").

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

Benefit Payments

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the plan document.

Related Party Transactions/Expenses

Certain administrative functions are performed by the officers or employees of Datwyler Pharma Packaging USA, Inc. (the "Plan Sponsor" and "Company"). These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Plan Sponsor for the services of the employees to the Plan. All fees and expenses of the Plan, to the extent not paid by the Company, are paid by the Plan. Certain investment related expenses are included in the net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated events subsequent to the balance sheet date through October 15, 2024, which is the date the financial statements were available to be issued.

NOTE 2 DESCRIPTION OF PLAN

The following description of the Plan is provided for general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Datwyler Pharma Packaging USA, Inc. (the Sponsor or Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan trustees oversee the governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's trustees. Participation in the Plan is entirely voluntary. There are no age or service requirements to become eligible to defer into the Plan as well as receiving Company safe harbor qualified nonelective contributions and profit sharing contributions.

The Trustee is responsible for the oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance. LPL Financial, LLC serves as a fiduciary investment advisor to the Plan under an ERISA 3(38) service agreement. Ascensus Trust Company serves as the trustee of the Plan assets as well as the third-party administrator and record keeper.

Contributions

Each year, participants may elect to contribute up to 100% of pre-tax or after-tax compensation, as defined in the Plan. However, contributions may not exceed limitations established under 402(g) of the Internal Revenue Code of 1986 as amended (\$22,500 for 2023). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (\$7,500 for 2023). Participants may also contribute amounts representing distributions from other qualified defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan has a safe harbor provision that requires the Company to make a qualified nonelective contribution of 5% of compensation for all eligible employees. Required safe harbor contributions made by the Company were \$32,954 in 2023. The Plan also allows the Company to make a profit sharing contribution of a discretionary amount. The Company did not make a profit sharing contribution in 2023. Contributions are subject to certain statutory limitations.

Rollover Contributions

Participants may rollover their taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

Notes to Financial Statements (Continued)

NOTE 2 DESCRIPTION OF PLAN (CONTINUED)

Participant's Account

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings and expenses. The pro-rata allocation is based upon each participant's earnings or account balances, as defined. Each participant's account is reduced by participant withdrawals, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the Sponsor's safe harbor contributions plus earnings thereon. Participants' vested interests in Sponsor nonelective profit sharing contributions increase from 20% after the first year of service to 100% after the fifth year.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of their total vested account balance, not to exceed \$50,000. Transactions are treated as transfers between an investment fund and notes receivable. Notes receivable must be repaid within five years unless the purpose is to acquire, construct or reconstruct a principal residence. Each note is secured by 50% of the participants' vested account balance and bears a fixed rate of interest at the prime rate plus one percent. Note payments are made by automatic payroll deduction. The balance of notes receivable from participants at January 31, 2023 was \$-0-.

Payment of Benefits

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company, or termination of the Plan, the participant's account is distributed under several options. Participants may elect to receive their benefit in a lump sum or partial withdrawals.

In-service distributions are permissible for participants that have attained the age of 59½. Participants electing in-service distributions may elect to receive all or a portion of their vested benefits. Rollovers are also eligible for distribution at any time.

In conditions of "financial hardship", a participant may apply to the Plan administrator for approval to withdraw that portion of their vested balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Forfeiture Accounts

Forfeitures may be used to reduce the amount of any legally permitted expenses incurred in connection with the administration of the Plan which are not otherwise paid by the Sponsor or to reduce the Sponsor's future contributions. Forfeitures used to reduce the employer matching contribution were \$6,520 in 2023. Forfeitures used to reduce administrative expenses were \$-0- in 2023. Forfeited nonvested accounts at January 31, 2023 and December 31, 2022 were \$-0- and \$4,285 respectively.

NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board *Accounting Standards Codification 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2022 and 2021.

Mutual funds: Valued using quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Common collective trust: Valued based on the NAV of units of a collective trust as published by the trustee.

NOTE 3 FAIR VALUE MEASUREMENTS (CONTINUED)

The Plan invests in the MetLife Series 25053 Stable Value Fund which is a common collective trust. Common collective trusts are investment funds formed by the pooling of investments by institutional investors, such as a group of not necessarily affiliated pension or retirement plans, typically with the intention of achieving cost savings over similar investment options such as mutual funds. Common collective trusts are similar to mutual funds, with a named investment manager and documented investment objective. These investments, however, are not registered with the SEC (unlike mutual funds, which are registered) and participation is not open to the public. As described above, the fair value of the common collective trust is based on the trust's NAV. The NAV is measured by the trustee or investment manager as of the close of regular daily trading. These investments are classified within Level 2 of the fair value hierarchy. In certain instances, NAV's may require adjustments to reflect the fair value more appropriately. No adjustments to NAV's were required.

The existence of certain conditions can limit the ability of the Plan to transact with participants at fair value of the common collective trust. Specifically, any event outside normal operation of the trust which causes a withdrawal from an investment contract may result in a negative market value adjustment with respect to such withdrawal. Examples of such events include, but are not limited to:

- The Plan's failure to qualify under Section 401(a) or Section 401(k) of the Internal Revenue Code.
- The establishment of a defined contribution plan that competes with the plan for employee contributions.
- Any substantive modifications of the Portfolio or the administration of the Portfolio that is not consented by the wrap issuer.
- Any change in law, regulation or administrative ruling applicable to the plan that could have a material adverse effect on the Portfolio's cash flow.
- Any communication given to unitholders by the plan sponsor, any other plan fiduciary or Ascensus Trust Company that is designed to induce or influence unitholders not to invest in the Portfolio or to transfer assets out of the Portfolio.
- Any transfer of assets from the Portfolio directly to a competing investment option.

As of January 31, 2023, the occurrence of an event outside the normal operation of the fund which would cause a withdrawal from an investment contract is not considered to be probable.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 TAX STATUS

The Plan Sponsor has adopted a prototype plan which has received an opinion from the Internal Revenue Service ("IRS") dated January 1, 2018, which states the provider's prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan itself has not received a determination letter from the IRS. Both the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related Plan was tax exempt as of the financial statement date.

NOTE 7 RELATED PARTY AND PARTY-IN-INTEREST

Certain Plan investments are mutual funds managed by the trustee (or affiliates of the trustee) of the Plan. The mutual funds sell shares to the trustee (or affiliates of the trustee) separate accounts offered by the Plan. Therefore, these transactions qualify as party-in-interest transactions.

NOTE 8 PLAN MERGER

On January 31, 2023, the Plan merged into a related employer's plan. They terminated their services with Ascensus Trust Company effective January 31, 2023 and transferred the assets on that date to the Datwyler Parco Holdings, Inc. 401(k) Plan.
