### Report on the Audits of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Omni Savings Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 (in liquidation) and 2022 (ongoing), and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2023 (in liquidation) and 2022 (ongoing), stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion***

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

***Emphasis of Matter***

As discussed in Note 1 and 2 to the financial statements, the Board of Directors authorized the termination of the Plan and liquidation was deemed imminent during 2023. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing plan basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of Omni Savings Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan was a defined contribution plan covering substantially all employees of Omni Savings Plan (the Company) on the later of their date of employment or upon turning 21 years of age. The Plan was subject to the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Directors adopted a resolution to terminate the Plan effective December 31, 2022 (also see Note 6). Contributions to the Plan ceased effective December 31, 2022 and all participants became 100% vested on December 31, 2022. Participants were given notice of their distribution options in August 2023. During 2023, the Plan assets were distributed to the participants pursuant to the participants elections.

**Eligibility**

Employees of the Company were eligible to participate in the deferral and match components of the Plan on the later of turning 21 years of age or upon being employed for 12 consecutive months and working a minimum of 1,000 hours. Participants were eligible for the discretionary profit sharing and qualified non-elective contributions upon being employed for 12 consecutive months and working a minimum of 1,000 hours.

**Contributions**

Eligible participants were permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pretax 401(k) or Roth contributions to the Plan. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions.

In 2023, the Company did not make safe harbor matching contributions. In 2022, the Company made safe harbor matching contributions of 100% up to 6% of the participants' voluntary contributions. Safe harbor matching contributions totaled \$494,199 for the year ended December 31, 2022. Each year, the Company could, at its discretion, elect to make discretionary profit sharing contributions and qualified non-elective contributions to each participant. In 2023, the Company did not make discretionary profit sharing contributions. Discretionary profit sharing contributions totaled \$690,797 for the year ended December 31, 2022. There were no qualified non-elective contributions during the years ended December 31, 2023 and 2022.

Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of contributions into various investment options offered by the Plan. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account was credited with the participant's contributions, the Company's matching contribution, an allocation of the Company's profit sharing contribution, and an allocation of Plan earnings or losses. Participant accounts were charged with an allocation of administrative expenses that are paid by the Plan. Allocations were based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled was the benefit that could be provided by the participant's vested account.

**Vesting**

Participants were immediately vested in their voluntary contributions, rollover contributions, and safe harbor matching contributions plus actual earnings thereon. Vesting in the discretionary profit sharing contribution and qualified non-elective contribution portion of their accounts, plus actual earnings thereon, was based on number of years of continuous service according to the schedule that follows:

Upon death or disability, the participant became 100% vested in the company discretionary contributions and qualified non-elective contributions. The Board of Directors adopted a resolution to terminate the Plan effective December 31, 2022 making all participants 100% vested as of December 31, 2022 (see Note 1 and Note 6).

**Benefit Payments**

Upon termination of service due to death, disability, or retirement, a participant could elect to receive the value of the vested interest in their account in the form of a lump sum distribution or installments. The Plan allowed for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If the balance of the terminated participant's account is \$5,000 or less, the Plan Sponsor could authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

**Forfeited Accounts**

Forfeited nonvested accounts could be used to pay administrative expenses and to reduce future Company contributions. There was no remaining balance in the forfeited nonvested account as of December 31, 2023. Forfeited nonvested accounts as of December 31, 2022, totaled \$78,328. There were \$106,869 and \$10,981 of forfeitures used to reduce Company contributions for the years ended December 31, 2023 and 2022, respectively. There was \$193 of forfeitures used to pay administrative expenses for the year ended December 31, 2023. There was no forfeitures used to pay administrative expenses for the year ended December 31, 2022.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The board of directors authorized the termination of the Plan effective December 31, 2022 and management deemed liquidation was imminent during 2023 when distributions commenced. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing plan basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements.

Under the liquidation basis of accounting, assets were stated at their estimate net realized cash value expected to be collected in settling or disposing of assets during the liquidation process and liabilities were stated at their anticipated settlement amounts. Investments were stated at fair value which approximates the amount the plan expects to collect.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefit Payments**

Benefits were recorded when paid.

**Administrative Expenses**

The Plan's expenses were paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company were excluded from these financial statements. Investment-related expenses were included in net appreciation (depreciation) in fair value investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 15, 2024, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Empower Annuity Insurance Company of America, and Empower Trust Company, LLC (Empower) the qualified institutions, have supplied the Plan administrator with a certifications as to the completeness and accuracy of all investment information (other than investments in self-directed brokerage accounts) reflected on the accompanying statements of net assets available for benefits as of December 31, 2023 (in liquidation) and 2022 (ongoing) and the statements of changes in net assets available for benefits for the years ended December 31, 2023 (in liquidation) and 2022 (ongoing). The self-directed brokerage interest and dividends was \$224,573 and \$414,747 as of December 31, 2023 and 2022, respectively. The self-directed brokerage net appreciation (depreciation) was \$1,416,198 and (\$3,898,542) as of December 31, 2023 and 2022, respectively.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)**

Following was a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2023 and 2022.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trusts*: Valued at the net asset value (“NAV”) of shares held by the Plan at year end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable and that the fund will sell the investment for an amount different than the reported NAV.

*Guaranteed Investment Contract*: Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations and considering the creditworthiness of the issuer.

*Exchange Traded Funds*: Investments in exchange traded funds are valued at the daily closing price as reported by the fund. Exchange traded funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV). The exchange traded funds held by the Plan are deemed to be actively traded.

*Common Stocks*: Valued at the closing price reported on the New York Stock Exchange.

*Real Estate Income Trust*: The real estate income trust is valued monthly based on the net asset value per unit, which is based on the fair value of underlying investments, plus the addition of any other assets (such as cash on hand) and the deduction of liabilities. The underlying investments largely comprise of real estate properties valued using a combination of a discounted cash flow analysis and valuations by a third-party appraiser. The asset is a level 3 investment due to the limited trading market for the security and its underlying holdings.

*Money Market Funds*: Valued at cash value; these are bank deposits.

*Government Securities*: Valued based on unadjusted quoted market prices for identical assets or liabilities for similar securities. Valuation based on quoted prices that are readily and regularly available in the active market.

*Certificates of Deposit:* Valued at cost adjusted for accreted original issue discount (a noncash payment of interest, reflecting interest earned while the investment is owned) on long-term (more than one year) CDs.

*Self-directed Brokerage Accounts* – Assets in these accounts consist of mutual funds, exchange trade funds, common stocks, money market funds, certificate deposits, government securities, and real estate income trust (valued as noted above).

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of the investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

As discussed in Note 1, the Board of Directors adopted a resolution to terminate the Plan effective December 31, 2022, subject to provisions of ERISA. Upon the plan termination effective on December 31, 2022, all participants became 100% vested in their Company contributions. The Plan Sponsor was required to distribute assets as soon as administratively feasible. As of December 13, 2023, the assets were fully distributed.

**NOTE 7 PLAN TAX STATUS**

The Plan was placing reliance on an opinion letter from the IRS on the prototype plan indicating that the Plan was designed in accordance with the applicable section of the IRC. The Plan was amended since receiving the opinion letter. However, the Plan administrator believed that the Plan was designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believed that the Plan was qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments were managed by Empower Annuity Insurance Company of America, and Empower Trust Company, LLC the qualified institutions; therefore, the investment transactions qualified as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
