Notes to Financial Statements

Note 1. Description of Plan

The following description of the Regency Health Care Inc. 401(k) Retirement Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions, which is available from Plan management.

General

The Plan is a defined contribution plan covering all eligible employees of Regency Healthcare Inc. (the "Plan Sponsor"). All employees are eligible except union employees and highly compensated employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Administrative Committee.

In February 2022, the Plan Sponsor announced that it had decided to terminate the Plan, effective March 31, 2022. All contributions are discontinued, including elective deferral contributions made on behalf of participants. All participants in the Plan became 100% vested in their respective Company contribution account, balances and sources. The Plan assets were distributed to participants and was fully liquidated in 2023.

Employee Contributions

Contributions are made to the Plan by participants who may elect to defer either a fixed amount or a percentage of their annual compensation by a salary reduction election, subject to certain Internal Revenue Code imposed limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan previously offered various mutual funds as investment options for participants. There were no employee contributions made to the Plan in 2023 or 2022.

Employer Contributions

Employer discretionary contributions are allocated using the grouping method. Under this method, participants will be assigned to a group which will share in the contribution that the company makes for that group. The amount contributed for each group will be allocated in the ratio that the compensation of each participant who is a member of that group bears to the total compensation of all participants who are members of that group. The amount allocated to the employer discretionary contributions account of each participant who is a member of that group will, as a percentage of compensation, be the same.

The Plan Sponsor did not make contributions to the Plan for benefits earned during 2023 and 2022 by eligible employees. The Plan Sponsor chose to fund other available benefit programs instead.

Participant Accounts

Each participant's account is credited with the employer's contribution, the participant's contribution, an allocation of the plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, as well as the employer matching contribution, plus actual earnings thereon.

Payment of Benefits

Upon termination of service due to death, disability, retirement or for reasons other than the preceding, a participant may elect to receive a distribution of his or her vested balance under one of the following methods: (1) a lump sum payment, (2) a partial distribution, or (3) a direct rollover equal to the value of the participant's vested interest in his or her account. For termination of services for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

In-Service Distributions

The Plan allows for in-service distribution from the participant's account once the participant has reached normal retirement age, or earlier once the participant has 100% vested interest in the account and has reached age 18. Distributions from a participant's rollover contribution account can be made at any time.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared using the liquidation basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses are paid by either the Company or the Plan, as provided in the plan document.

Subsequent Events

The Plan has evaluated subsequent events and transactions through October 11, 2024, the date that the financial statements were available to be issued.

Note 3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments held at December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments, and interest and dividends for the years ended December 31, 2023 and 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Nationwide Trust Company, the trustee of the Plan.

Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022:

Mutual funds: The mutual funds are valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5. Party-in-Interest Transactions

Certain plan investments are shares of mutual funds managed by Nationwide Trust Company at year end. Nationwide Trust Company was the trustee in 2023 and 2022, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid by the Plan to Nationwide Trust Company amounted to \$5,343 and \$20,597 for the years ended December 31, 2023 and 2022, respectively.

Note 6. Tax Status

Effective January 1, 2020, the Plan adopted a nonstandardized prototype defined contribution profit sharing plan with Internal Revenue Code Section 401(k) Cash or Deferred Arrangement (CODA) which received a favorable opinion letter from the Internal Revenue Service (IRS) dated March 31, 2014. The Plan has been amended since the date of the last amendment covered by the above mentioned determination letter. However, Plan management believes that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.


