**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Outwest Express, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

### **Basis for Opinion**

1. DESCRIPTION OF PLAN

The following description of the Outwest Express, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, available from the plan administrator, for a more complete description of the Plan's provisions.

General

The Plan was established and adopted on January 1, 2019 by Outwest Express, LLC (the Company or Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator is the Plan Sponsor. The Plan is available to all employees over the age of 21 who have obtained one year of eligible service with a minimum of 1,000 hours of service with the Company.

Transfer of assets

The Plan Sponsor was purchased by TFA Logistics in 2023. Substantially all of the Plan's assets were transferred out of the Plan and into a new plan as of December 31, 2023. At December 31, 2023, \$98 of investments remained in the plan. The remaining investments have been transferred out of the Plan as of the date of the financial statements.

Contributions

Eligible participants may make contributions to the Plan through payroll withholdings. Participants may defer from 1 percent up to 90 percent of their annual compensation each year, including ROTH deferrals, subject to limitations imposed by the Internal Revenue Code of 1986, as amended (IRC). Transfers from other qualified plans are allowed under the provisions of the Plan.

For the year ended December 31, 2023 and 2022, the Plan Sponsor made safe harbor matching contributions, as required, in amounts equal to 100 percent of each participant's total elective deferral up to the first 3 percent of the participant's compensation and 50 percent of each participant's total elective deferral on the next 2 percent of the participant's compensation. The Plan Sponsor has the option to make nonelective contributions of which there were none made for the years ended December 31, 2023 and 2022.

1. DESCRIPTION OF PLAN (CONTINUED)

Investment Options

All contributions under the Plan are currently invested and are participant directed. Upon enrollment in the Plan, a participant may direct employee and match contributions in a number of investment options offered by Reliance Trust Company.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with the participant's elective contributions and a matching contribution from the Plan Sponsor (if applicable). Allocations of plan earnings and administrative expenses are based on participant account balances as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500, up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances. Loan terms range from one year to five years. The loans are secured by the balance in the participant's account and bear interest at current prime rate plus two percentage points. The Plan Custodian establishes the interest rate that will provide a return comparable to the rates being charged by lending institutions in the same geographic locale as the employee. Principal and interest are paid through payroll deductions.

1. DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are immediately vested in their voluntary contributions plus earnings or losses thereon, rollover contributions, transfer contributions and related earnings or losses. Participants are 100 percent vested in Plan Sponsor Safe Harbor contributions and earnings thereon.

The Plan utilizes a graded-vesting schedule for nonelective contributions as follows:

Payment of Benefits

On termination of service due to death, disability, retirement, or upon reaching normal retirement age, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Withdrawals from the Plan may also be made upon circumstances of financial hardship experienced by the participant, in accordance with provisions specified in the Plan Agreement. Further, participants may elect to receive their applicable benefit either in cash or as a direct rollover to a qualified IRA or another tax-qualified plan.

Forfeited Accounts

Forfeitures resulting from termination distributions are used to restore participant forfeitures, offset Plan expenses, and reduce future Plan Sponsor contributions (both non-elective and matching). There were no forfeitures during the year ended December 31, 2023 and 2022.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan Agreement to terminate the Plan or reduce or suspend Plan Sponsor contributions subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Plan Tax Status

The Plan Sponsor adopted a Volume Submitter Profit Sharing Plan with a cash or deferral arrangement; this received a favorable opinion letter from the Internal Revenue Service, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not been amended since receiving the determination letter. The plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax.

Administrative Expenses

The Plan expenses incurred by, or attributable to a particular participant are assessed against that participant's account.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements presented have been prepared in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates in Preparing Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan management to make estimates and assumptions that affect the reported amount of assets, liabilities, and changes therein, and in disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

In compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure Under ERISA, the Plan values its investments at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Realized and unrealized gains and losses on investments are reflected in the statement of changes in net assets available for benefits. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Investments held are stated at fair market value and, as such, their reported value for financial statements purposes is subject to market fluctuations. Accordingly, the price which may be realized upon the sale of the respective investment may not be equal to its value as currently presented.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Subsequent Events

The plan administrator has evaluated subsequent events through October 14, 2024, the date the financial statements were available to be issued.

- (e) Interest income from notes receivable from participants as shown in the accompanying statement of changes in net assets available for benefits was \$11,363 for the year ended December 31, 2023.

5. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Reliance Trust Company. Reliance Trust Company is the current Custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

7. LEGISLATIVE CHANGES

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. The SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan documents accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Accordingly, there is no material impact on the Plan's 2023 financial statements.

8. REQUIRED COMPLIANCE TESTING

During the audit of the year ended December 31, 2023 it was determined that the required compliance testing was performed on an incomplete census. The Plan administrator is having the required compliance testing performed using the complete census, however, the results of that testing was not available as of the date these financial statements were available to be issued. Therefore, these financial statements do not include any changes that might be required if any of the compliance tests were to fail.
