### INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Governance of the

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Robinson Paving Company, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements (collectively, the "financial statements").

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

## 1. DESCRIPTION OF PLAN

The following description of the Robinson Paving Company, Inc., 401(K) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established effective February 1, 2006, and covers all eligible employees of Robinson Paving Company, Inc., (the "Company" or "Employer"). The Plan has been amended from time to time, with the most recent amendment, effective January 1, 2020, excluding certain bonuses from eligible compensation.

Eligibility - Employees are eligible to participate in the Plan after attaining age 19 and completing one year of qualified service. An employee will earn a year of qualified service if they complete at least 1,000 hours of service with the employer during a plan year.

Contributions - Each year, participants may contribute, on a tax-deferred basis, a portion of their compensation in accordance with Section 401(k) of the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified plans. The plan is designed to be a safe harbor plan. The Company matches 100% of employee contributions up to 3% of eligible compensation and then matches 50% of employee contributions from 3% - 5% of compensation. The Company may also make annual discretionary contributions into the Plan.

Vesting - Participants are fully and immediately vested in elective deferral contributions, rollover contributions and employer contributions upon entering the Plan.

Benefits - An account is maintained for each participant in the Plan. The accounts are credited with the participants' contributions, the allocated portion of the employer matching contributions, and investment earnings. Distributions, withdrawals and allocated expenses are subtracted from the account balances. Participants' vested account balances represent the benefits available to the participants upon retirement, disability, death or termination from the Company.

Participant Loans - Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum of \$50,000 as long as the total of all outstanding loans to the participant does not exceed 50% of their vested account balances. Loan terms range from 1 to 5 years. The loans are collateralized by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the plan administrator. Interest rates on outstanding loans typically range from 4.25% to 9.5%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits - Upon termination of service, death, disability, or retirement, participants may elect to receive a lump-sum amount equal to the value of the vested account balance.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are maintained on the accrual basis and have been prepared in conformity with accounting principles generally accepted in the United States of America.

Investments - The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. The shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date.

The Plan presents, in the statement of changes in net assets available for plan benefits, the net appreciation (depreciation) in the fair value of investments, which consists of the realized gains and losses and the unrealized appreciation (depreciation) on those investments.

Participant Loans - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. As of December 31, 2023, and 2022, no allowance for credit losses has been recorded.

Contributions - Contributions from employees are recorded in the period in which the Employer makes the deductions from the employees' payroll. Discretionary matching contributions are accrued based on amounts declared by the Employer's Board of Directors. Rollover contributions are recorded as plan contributions during the period in which funds are received by the Plan.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - The Employer provides certain administrative and account services to the Plan at no cost and also pays certain other administrative expenses on behalf of the Plan. The Plan began paying its own contract administrator fees in the 2011 plan year. Expenses paid by the Plan for the year ended December 31, 2023 totaled \$45,969.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein. Actual results could differ from those estimates.

Risks and Uncertainties - The Plan provides for various investment options which, in turn, invest in any combination of stocks, mutual funds, and other investment securities. Generally, all investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Concentration of Credit Risk - Financial instruments that potentially subject the Plan to concentrations of credit risk are part of the holdings in the Plan's investments. Management believes that the Custodian maintains the Plan's investments with high credit quality institutions and attempts to limit the credit exposure to any particular investment.

Uncertain Tax Positions - The Plan adopted the provisions of Accounting for Uncertainty in Income Taxes. The standard clarifies the accounting for uncertainty in income taxes recognized in an enterprises' financial statements and prescribes a threshold of more-likely-than-not for recognition of tax benefits of uncertain tax positions taken or expected to be taken in a tax return. The standard also provides related guidance on measurement, de-recognition, classification, interest and penalties, and disclosure. The adoption of this standard did not have an impact on the financial statements. Informational tax returns filed for the Plan for the years subsequent to 2019 are still open for examination.

Reclassifications - Certain prior year amounts may have been reclassified for consistency with the current year presentation. These reclassifications, if any, had no effect on the reported results of operations.

Subsequent Events - Subsequent events have been evaluated by management through September 3, 2024, which is the date the financial statements were available to be issued. See Note 5.

### **3. INVESTMENTS**

The Plan's investments (including gains and losses on investments bought and sold, as held during the year) appreciated in value by \$531,299 during the year ended December 31, 2023.

### **4. INFORMATION CERTIFIED BY THE TRUSTEE**

Certain information related to investments and participant loans receivable disclosed in the accompanying financial statements and supplemental schedule, including investments and participant loans receivable held at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln Financial Group Trust Company, Inc. (the trustee of the Plan).

### **5. PLAN TERMINATION**

After December 31, 2023 but before the financial statements were available to be issued, the Plan Sponsor adopted a resolution to terminate the plan effective August 1, 2024. At the time of the Plan termination, outstanding loan balances will be considered deemed distributions, and all employees will have the option to take full distributions of their vested account balances or consider rolling their account balances into a new account.

### **6. TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated March 31, 2008, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

### **7. PARTY IN INTEREST TRANSACTIONS**

Certain plan investments are managed by Lincoln National Insurance Company, who is the Plan's custodian. Transactions involving these investments, including fees paid by the Plan for administration, are considered party-in-interest transactions. These transactions are not, however, considered prohibited transactions under CFR 408(b) of the ERISA regulations.

### **8. FAIR VALUE MEASUREMENTS**

The Plan complies with FASB ASC 820, *Fair Value Measurements and Disclosures* which defines fair value under U.S. generally accepted accounting principles, establishes a framework for measuring fair value and enhances disclosures about fair value measurements. This standard defines fair value at the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy, which requires an entity to maximize the use of observable inputs when measuring fair value.

The following provides a description of the three levels of inputs that may be used to measure fair value under the standard, the types of plan investments that fall under each category, and the valuation methodologies used to measure these investments at fair value.

Level 1 - Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date.

Level 2 - Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies.

Level 3 - Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

*Stable Value Account:*

The stable value account is a fixed annuity contract issued by The Lincoln National Life Insurance Company and is secured by the general account of the issuer. Interest is credited daily on an actual basis. The guaranteed minimum interest rate at December 31, 2023 was 1.70%. Management believes that fair value of the stable value account approximates contract value. Contract value is defined as the value of the contract owner's account and is the sum of contributions plus interest credited, minus withdrawals.

The issuer can terminate the contract, resulting in the Plan not being able to receive immediate contract value, if any of the following events occur:

- The Plan ceases to meet the requirements of the Internal Revenue Code for purchasers of the contract.
- The contract owner fails to furnish requested information or other documentation.
- The issuer discovers any misrepresentation of material information.
- The issuer discontinues offering this contract form to the public; and/or
- The Plan terminates its recordkeeping agreement with the issuer.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The table below segregates all financial assets and liabilities as of December 31, 2023, and 2022 that are measured at fair value on a recurring basis (at least annually) into the most appropriate level within the fair value hierarchy based on the inputs used to determine the fair value at the measurement date:
