- 1. Description of the Plan** The following description of the G+D 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Giesecke+Devrient Mobile Security America Inc. who are at least 18 years old, except employees covered by a collective bargaining agreement, leased employees, residents of Puerto Rico, and summer interns or temporary employees hired for a specific project or a period of limited duration. Employees may enter the Plan on the same day the eligibility requirements are satisfied. The Plan includes G+D Currency Technology America Inc., E-Seek Incorporated, Veridos America, Inc., and Giesecke+Devrient ePayments America Inc. as participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective December 1, 2022, the Company acquired certain business of Valid USA, Inc. Affected employees who participated in Valid USA's retirement plan were given the option to roll their funds into the Plan. Approximately \$5 million of such balances are included in rollovers in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2023.

Notes to Financial Statements

Contributions: Each year, participants may contribute up to 90 percent of pretax annual compensation, as defined in the Plan. Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Newly eligible employees who do not affirmatively elect to contribute to the Plan or do not affirmatively decline to participate in the Plan are automatically enrolled in the Plan with a six percent withholding of pretax annual compensation. This withholding will increase by one percent each subsequent year until the automatic election reaches a maximum withholding contribution of 10 percent of compensation. Effective February 21, 2023, the Plan was amended to change the automatic escalation provisions to provide for an increase in the percentage cap from 10% to 15%.

The Plan allows for a discretionary non-safe harbor matching contribution. During 2023, the Company contributed 50% of the first six percent of compensation that a participant contributed to the Plan. Non-safe harbor non-elective contributions may also be contributed at the discretion of the Company. In 2023, the Company did not make any non-safe harbor non-elective contributions. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions, the Company's discretionary non-safe harbor matching contributions, if any, as well as allocations of the Company's discretionary non-safe harbor non-elective contribution, if any, and investment earnings and losses. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to thirty years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate in effect at inception of the loan plus one percent. Principal and interest are paid through payroll deductions.

Notes to Financial Statements

Payment of benefits: Benefits are payable upon retirement at age 65, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time. Benefits are payable in lump sum, installment or partial payments.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in Company contributions is based on years of continuous service of at least 1,000 hours per year. A participant is 50 percent vested after two years of service is completed, and vests an additional 50 percent per year until full vesting after three years. Different vesting schedules may apply to account balances of participants due to prior Plan provisions as described in the Plan document.

Forfeited accounts: At December 31, 2023 and 2022, forfeited nonvested accounts totaled \$95,415 and \$128,294, respectively. These accounts may be used to pay Plan expenses and reduce future Company contributions. During 2023, \$130,713 of forfeited nonvested accounts were used to reduce Company contributions and no forfeited nonvested accounts were used to pay Plan expenses.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as loan administration fees, are charged directly to the participant's account and are included in administrative expenses.

2. Significant accounting policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Contributions: Participant contributions and the related Company discretionary non-safe harbor matching contributions are recognized in the period the participant contribution is withheld from compensation. The Company non-safe harbor non elective contributions are recognized when the related compensation is paid to the participant.

Payment of benefits: Benefits are recorded when paid.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: The Plan has evaluated subsequent events for disclosure in these financial statements through October 7, 2024, which is the date the financial statements were available to be issued.

3. Certified information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividend income, and interest income from notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by T. Rowe Price Trust Company, the trustee of the Plan.

4. Fair value measurements The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

The fair value of the shares of mutual funds owned by the Plan is based on quoted net asset values on the last business day of the Plan year.

The fair value of equity securities, mutual funds, exchange traded funds, and other investment funds in the self directed brokerage accounts are based on quoted market prices.

The fair value of the common trust funds is based on the net asset value ("NAV") on the last business day of the Plan year provided by the entity holding the trust fund. The NAV of the common trust is used as a practical expedient to estimate fair value and is determined by the fund trustee based on the fair value of underlying assets in the trust, less its liabilities.

(a) In accordance with ASC 820, certain investments that were measured at net asset value per share (or its equivalent) as of December 31, 2023 and 2022 have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the Statements of Net Assets Available for Benefits.

Units of the TRP Stable Value Fund can be redeemed immediately at the current net asset value to meet participant initiated withdrawals. Up to thirty months advance written notice may be required prior to sponsor redemption, determined by T. Rowe Price. Up to thirty days advance written notice may be required to redeem units of the T. Rowe Price Retire Funds, at the discretion of T. Rowe Price. Withdrawals from the Great Gray Europacific Growth Fund initiated by the Company require five business days notice for any withdrawals exceeding \$1,000,000. There are no other withdrawal limits, redemption frequency limits or redemption notice periods. There were no unfunded commitments for these investments as of December 31, 2023 and 2022.

- 5. Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
- 6. Risks and uncertainties**

The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.
- 7. Tax status**

The Plan is a pre-approved plan of T. Rowe Price Retirement Plan Services Inc., which received an opinion letter on August 19, 2020, in which the Internal Revenue Service ("IRS") stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

- 8. Party-in-interest transactions** Certain Plan investments are managed by affiliates of T. Rowe Price Trust Company. T. Rowe Price Trust Company is the trustee as defined by the Plan. These transactions qualify as exempt party-in-interest transactions.
- 9. Administrative budget account** The Company has a service agreement with T. Rowe Price Retirement Plan Services, Inc. ("TRP"), the recordkeeper, that provides for an "Administrative Budget Account" for the Plan. Under the agreement, any revenue earned by TRP on the investments in the Plan in excess of TRP's fees will be deposited into the Administrative Budget Account. The amounts in the Administrative Budget Account may be used to pay administrative expenses of the Plan. In 2023, approximately \$17,000 of other income was earned by the Plan related to this agreement and approximately \$80,000 was used to pay investment advisory and other fees for the Plan. The balance in the Administrative Budget Account as of December 31, 2023 and 2022 was \$92,558 and \$149,462, respectively, and was included in investments in the Statements of Net Assets Available for Benefits.
- 10. Subsequent events** Effective January 1, 2024 the Plan was amended to change the plan sponsor to Giesecke+Devrient ePayments America, Inc. Giesecke+Devrient ePayments America, Inc. was removed as a participating employer and Giesecke+Devrient Mobile Security America, Inc., the previous plan sponsor, was added as a participating employer.
