## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the Watchbox Employees' Savings and Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Watchbox Employees' Savings and Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Plan management, having determined it is permissible in the circumstances, has elected to have the audits of the Watchbox Employees' Savings and Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### Responsibilities of Plan Management for the Financial Statements

Plan management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that

are free from material misstatement, whether due to fraud or error. Plan management's election of the ERISA Section 103(a)(3)(C) audit does not affect Plan management's responsibility for the financial statements.

In preparing the financial statements, Plan management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Watchbox Employees' Savings and Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Plan management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Watchbox Employees' Savings and Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedule Required by ERISA**

The supplemental Schedule H, Line 4(a) – Schedule of Delinquent Participant Contributions for the year ended December 31, 2023 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of Plan management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that Plan management determined meets the requirements of ERISA Section 103(a)(3)(C).

**1. Description of Plan**

The following description of the Watchbox Employees' Savings and Retirement Plan (the "Plan"), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution Plan covering substantially all employees of WBQ USA, LLC (the "Company", "Plan Sponsor" or "Employer"), as described in the Plan document. Employees who are nonresident aliens and leased employees are ineligible to participate in the Plan. Participants are immediately eligible to make salary deferral contributions and for discretionary matching contributions. Participants are eligible for profit-sharing contributions after completing 1 year of service and attaining age 18. Profit-sharing contributions commence on the first day of the quarter following on which the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

During November 2023, the Plan sponsor began the process of merging the Plan into the AdvisorTrust, Inc. 401(k) Simplified Pooled-Employer Plan to be effective January 1, 2024. As a result, net plan assets of \$7,151,723 were transferred from the Plan to the AdvisorTrust, Inc. 401(k) Simplified Pooled-Employer Plan. Due to the nature and timing of the transfer, the assets were still held in the Plan's trust at December 31, 2023 by AdvisorTrust, Inc., who served as trustee of the Plan, and were physically transferred subsequent to December 31, 2023. However, due to the merger of the Plan, all assets, liabilities and participants ceased to be part of the Plan; were considered to be due to the AdvisorTrust, Inc. 401(k) Simplified Pooled-Employer Plan on December 31, 2023; and are reflected in the accompanying financial statements as "Due to AdvisorTrust, Inc. 401(k) Simplified Pooled-Employer Plan" as of December 31, 2023. Management believes that there was no participant-initiated activity after December 31, 2023 and the Plan was merged into the AdvisorTrust, Inc. 401(k) Simplified Pooled-Employer Plan on December 31, 2023 for financial reporting purposes.

For Form 5500 purposes, all assets, liabilities and participants also ceased to be part of the Plan as of December 31, 2023 and such amounts are reported as zero on the December 31, 2023 Form 5500.

Subsequent to the merger, former Plan participants were subject to a "Black Out" period beginning January 8, 2024 and continued through February 9, 2024. During this period, participants' plan accounts were not available for investment fund exchanges, and distribution requests, including participant loan withdrawals.

**Contributions**

Each year, participants may contribute 1 to 100 percent of their pre-tax annual compensation, as defined in the Plan. Participants may designate their voluntary contributions as Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled into the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation.

The Company may elect to make discretionary matching contributions to the Plan equal to a uniform percentage of compensation that a participant contributes to the Plan. The employer declared discretionary matching contributions of 25% of the employee's contributions up to 6% of compensation for periods on or after April 1, 2019. In order to participate in the discretionary matching contributions, participants must complete one year of service.

The Plan also provides for discretionary profit-sharing contributions. No discretionary profit-sharing contributions were declared by the Company for the year ended December 31, 2023.

Contributions are subject to certain Internal Revenue Service ("IRS") limits. Participants direct the investment of their deferral contributions and Employer matching contributions into various investment options offered by the Plan. Participants may change their investment options at any time.

**Participant Accounts**

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions, the Employer's discretionary matching contributions, if any, as well as an allocation of the Employer's discretionary profit-sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account.

**Investment Options**

Participants direct the investment of their contributions into various mutual fund investment options offered by the Plan and maintained by the trustee of the Plan. Participants direct the investment of their contributions into various fund investment options offered by the Plan.

**Vesting**

Participants are vested immediately in their contributions, including their elective pre-tax deferral contributions, Roth 401(k) deferrals, and rollover contributions, plus actual earnings thereon.

Employer matching contributions and profit-sharing contributions are vested based on a six year graded vesting schedule as follows:

A year of service for vesting purposes is 1,000 hours of service. A participant is 100 percent vested upon death, disability, or early or normal retirement.

**Forfeited Amounts**

As of December 31, 2023 and 2022, the forfeited non-vested accounts were \$22,784 and \$1,307, respectively. Forfeitures may be applied to payment of administrative expenses and/or to reduce Employer matching contributions. During the year ended December 31, 2023, \$0 of forfeitures were used to offset employer contributions and approximately \$31,000 was used to pay administrative expenses. As part of the Plan merger (see Note 1), \$22,784 of forfeited non-vested accounts were transferred to the AdvisorTrust, Inc. 401(k) Simplified Pooled-Employer Plan.

**Payment of Benefits**

Upon termination of service, death, disability, retirement or separation from service, participants or their beneficiaries may elect to receive in a lump-sum payment, partial withdrawals, or installments an amount up to the value of the participant's vested interest in his or her account. If a participant's vested account balance is less than \$5,000 upon termination, a distribution of the participant's account may be made automatically in a single lump-sum cash distribution.

In-service withdrawals of all or a portion of a participant's vested account balance may be made by participants who have attained the age of 59-1/2. In-service withdrawals of all or a portion of a participant's rollover account balance may be withdrawn at any time.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the local prevailing interest rate at the time of borrowing. Principal and interest are repaid ratably through payroll deductions over a period of five years or less, with the exception of loans made for the purchase of a primary residence, where the repayment period may be up to and including ten years. The maximum number of loans that a participant may have outstanding at one time is limited to one. Interest rates on notes receivable from participants ranged from 4.25% to 9.50% with maturities dates through October 2028 as of December 31, 2023.

**2. Summary of Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). The Plan administrator determines the Plan's investment policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Contributions**

Contributions from Plan participants and discretionary matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation. Profit-sharing contributions, if any, are recorded in the year which the related participant compensation is earned.

**Notes Receivable from Participants**

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit distribution is recorded, based upon the terms of the Plan document.

**Payments of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable and other participant-specific fees are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in the net appreciation in fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 15, 2024, the date the financial statements were available to be issued.

**3. Information Certified by a Qualified Institution**

The Plan Sponsor having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by AdvisorTrust, Inc., a qualified institution, in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, noninterest-bearing cash and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2023 and 2022.
- Investment activity, including net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2023.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2023 and 2022.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Interest-bearing cash:* Interest-bearing cash is valued at cost, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Related Party and Party-in-Interest Transactions**

The Plan paid certain expenses related to Plan operations to various service providers, including AdvisorTrust, Inc., trustee of the Plan and PCS Retirement, LLC, recordkeeper of the Plan. Total administrative expenses paid by the Plan were \$64,803 for the year ended December 31, 2023. For participants who have elected to take a participant loan, the loans are secured by the respective participant's account balance. These transactions are party-in interest transactions under ERISA. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

During 2023 and 2022, the Company failed to remit to the Plan's trustee certain employee contributions and loan repayments totaling \$165,615 and \$144, respectively, within the period prescribed by the Department of Labor regulations. During 2023, the Plan Sponsor made contributions to the affected participants' accounts to compensate the participants for potential lost income due to the 2022 processing delays. During 2024, the Plan Sponsor plans to make contributions to the affected participants' accounts to compensate the participants for potential lost income due to the 2023 processing delays. The Plan Sponsor believes that these transactions do not affect the tax status of the Plan and has taken action prescribed by the regulations to remedy such errors.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their discretionary matching and profit-sharing contributions for which they were not already vested.

**7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**8. Tax Status**

Effective June 1, 2022, through the adoption of a FIS Business Systems LLC pre-approved plan, the Plan was amended and restated. The IRS issued an opinion letter dated June 30, 2020, stating that the pre-approved FIS Business Systems LLC plan document as then designed was in accordance with applicable Internal Revenue Code ("IRC") requirements.

Although the Plan has been amended since receiving the opinion letter, management of the Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

The Plan Sponsor believes that these transactions do not affect the tax status of the Plan and has taken action prescribed by the regulations to remedy such errors.
