INDEPENDENT AUDITORS' REPORT

To the Board of Trustees of
Arizona State Carpenters' Annuity Trust Fund

Opinion

We have audited the accompanying financial statements of Arizona State Carpenters' Annuity Trust Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2023 and 2022, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Arizona State Carpenters' Annuity Trust Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE A – DESCRIPTION OF PLAN

The following description of the Arizona State Carpenters' Annuity Trust Fund (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General – The Plan was established as a defined contribution plan effective January 1, 1984 as the successor retirement plan to the Arizona State Carpenters' Pension Trust Fund, a defined benefit plan (formerly the Arizona Basic Crafts Pension Trust Fund), which was established in 1965 under an agreement between the Contractors', Home Builders' Associations, and the Labor Unions. The collective bargaining agreement provided, among other things, for participating employers to make contributions to the Plan for each hour worked by covered employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Contributions for hours worked after September 2002 have been sent to the Southern California Carpenters' Defined Contribution Annuity Plan and this Plan was frozen for contributions.

Participant accounts – Each participant's account is credited with contributions made on behalf of the participant, plus investment earnings (loss), determined as of the preceding valuation date prior to the payment date, minus the participant's accumulated share of administrative expenses of the Plan.

Participants who have credited service in the Pension Trust Fund (defined benefit plan) prior to January 1, 1984 are also eligible for a share of the excess earnings, if any, from the Pension Trust Fund which the trustees determine to be allocable to individual accounts.

Vesting – Participants are immediately vested in their contributions and income thereon. Benefits are payable upon termination of employment, retirement, disability, or death. Upon death, the participant's accumulated share will be paid to the surviving spouse or designated beneficiaries.

Payment of benefits – The form in which benefits are paid depends on the manner by which the participants become eligible for benefits, his/her marital status, federal law, and in certain instances, how the participant chooses to receive it. Notwithstanding the foregoing, if the participants' accumulated share is less than \$5,000, it shall be paid out in a lump sum, and the other optional forms of payment shall not be available.

By an agreement dated June 22, 2023, the Plan has agreed to be merged in the Southwest Carpenters Annuity Fund effective 11:50 pm Pacific Standard time on December 31, 2023, and all assets were transferred.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan.

Basis of accounting – The accompanying financial statements are prepared on the accrual basis of accounting.

The Plan maintains its financial records using the modified cash method of accounting, under which additions and deductions to net assets available for benefits are recognized when measurable and available to financial expenditures of the current period. Expenditures are generally recorded when the liability is paid. Adjustments are prepared at each year end to adjust the financial records to the accrual method of accounting.

Use of estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein; disclosure of contingent assets and liabilities; and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by its investment advisers and custodian. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits – Benefit payments to participants are recorded upon distribution.

Subsequent events – The Plan's management has evaluated subsequent events through May 13, 2024, the date the financial statements were available to issued.

NOTE C – PLAN TERMINATION

The Board of Trustees intends that the Plan continue indefinitely. However, in the event of termination of the Plan, the assets remaining in the Plan, after providing for administrative expenses, shall be allocated among the participants in accordance with the Plan provisions, except that all individual accounts shall, to the extent funded, become non-forfeitable. No part of the assets will be returned to any employer.

As discussed in Note A, the Plan merged into the Southwest Carpenters Annuity Fund effective December 31, 2023, and all assets were transferred.

NOTE D – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include
- Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other mean
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

- *Cash and equivalents, corporate stocks* – Valued at the closing price reported on the active market on which the individual securities are traded.
- *Common, collective trusts* – Valued at the net asset value (NAV) per share (or its equivalent) of the trusts, which is based on the fair value of the trusts' underlying net assets.
- *Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Transfers between levels – The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

We evaluate the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

(a) *ASB Allegiance Real Estate Fund* is a common collective trust with an objective to provide employee benefit plans access to systematic investment in real property on a commingled basis with other such plans. The real estate investments of the fund may consist of debt or equity interest of any kind in or relating to real property as the Trustee (Chevy Chase Trust Company) may in its discretion select, including but not limited to: (1) interests in limited partnerships or other entity forms which invest in real property, (2) loans or debt obligations secured by mortgages or other interests in real property, (3) mortgages on the fee, leasehold, or other interests in real property, or (4) equity interests or equity participation in improved or unimproved real property, either in the form of direct ownership, or other forms of interest in the entity owning or developing such real property.

(b) *Harding Loevner Int'l Equity Collective Inv Fund* is a common collective trust whose objective is to seek long-term capital appreciation through investment in equity securities of companies based outside the United States that are growing, well managed, financially strong and possess clear competitive advantages.

NOTE E – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and, that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE F – TAX STATUS

The Plan obtained its latest determination letter on August 13, 2015, in which the Internal Revenue Service states that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G – TRANSACTIONS WITH PARTIES IN INTEREST

Certain Plan investments represented money market funds managed by Principal Life Insurance Company. Principal Life Insurance Company was the custodial agent as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions under ERISA. The Plan also contracts with a third-party administrator, consultants, attorneys, and auditors who are all known to be parties in interest.
