### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Whitcraft LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Whitcraft LLC 401(k) Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 1 — DESCRIPTION OF THE PLAN**

The following description of the Whitcraft LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established to provide retirement benefits for eligible employees of Whitcraft Holdings, Inc., and its wholly owned subsidiaries, Whitcraft LLC (Whitcraft) and BPP Holdings, Inc. (BPP), as well as Whitcraft's wholly owned subsidiaries, Connecticut Tool & Manufacturing, LLC (CT Tool), AcuCut, LLC (AcuCut), Multax, LLC (Multax), Form 3D LLC (Form 3D), Whitcraft Scarborough/Tempe LLC (Whitcraft Scarborough/Tempe) and Whitcraft South Windsor LLC (Whitcraft South Windsor), as well as BPP's wholly owned subsidiary, Berkshire Manufactured Products, Inc. (Berkshire) who have completed 1 hour of service and have attained the age of 21. On February 28, 2020, Whitcraft Holdings, Inc. acquired the stock of UCA Holdings, Inc., along with its wholly owned subsidiaries Turbine Engine Components Technologies Corporation and Turbine Engine Components Technologies – Utica Corporation (Collectively, TECT Power) (collectively, the Company). TECT Power employees who have completed 1 hour of service and have attained the age of 21. Exclusions of employees include union employees who are governed by a collective bargaining agreement, leased employees and residents of Puerto Rico. During 2023, a participant transferred to the Plan from the Whitcraft-Utica Bargained 401(k) Plan and assets were transferred in the amount of \$830.

**Contributions**

Participants may contribute between 1% and 70% of compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers), regardless of whether they have met the eligibility requirements for participation in the Plan. Participants may designate all or a portion of their deferrals as Roth contributions. Newly eligible participants are automatically enrolled in the Plan with a default deferral contribution rate of 6%, unless the participant elects otherwise. Participants who are automatically enrolled in the Plan have their deferral contribution increased by 1% annually up to a maximum of 10%.

The Company contributes matching contributions of 50% of participant's elective deferral which does not exceed 6% of eligible compensation for each payroll period. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participants accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's contributions, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their deferral, rollover and Company contributions, including the earnings on those amounts.

**Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of their vested account balance or \$50,000. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1% above the USA Today prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits**

Upon termination of service for any reason, participants with a vested account balance less than \$1,000 will receive a lump-sum payment. For terminated participants with a vested account balance between \$1,000 and \$5,000, the Plan administrator may roll the amount into an individual retirement account on behalf of the participant without the consent of the participant.

In-service distributions may also be made from the Plan, these distributions may be made from a participant's vested account balance. Withdrawals from a participant's salary deferral account (excluding earnings) may also be made in the event of financial hardship, in accordance with the provisions specified in the Plan. Withdrawals from a participant's account may also be made upon reaching age 55 with 5 years of service, in accordance with the provisions specified in the Plan.

**Forfeited accounts**

Forfeited accounts totaled \$8 and \$18 as of December 31, 2023 and 2022, respectively. Forfeited nonvested balances are used to reduce the Company's future matching contributions or plan expenses. There were \$2,295 and \$1,046 forfeitures used to reduce employer contributions and plan expenses for the year ended December 31, 2023, respectively.

**NOTE 2 — SIGNIFICANT ACCOUNTING POLICIES**

**Basis of accounting**

The financial statements are prepared on the accrual basis of accounting.

**Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and trustees. See Note 3 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of benefits**

Benefits are recorded when paid.

**Administrative expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in depreciation of fair value of investments.

**Subsequent events**

The Plan has evaluated subsequent events through October 8, 2024, the date the financial statements were available to be issued. On November 1, 2024, the Paradigm Precision 401(k) Retirement Plan will be merging into the Plan and all assets will be transferred into the Plan.

**NOTE 3 — FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;
- Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
  - Quoted prices for similar assets or liabilities in active markets.
  - Quoted prices for identical or similar assets or liabilities in inactive markets.

- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of valuation methodologies used for assets measured at fair values. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Mutual Funds:* Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. The net asset value of the mutual funds is based on quoted market prices in active markets.

*Stable value collective trust fund:* The Plan invests in a stable value collective trust fund for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the net asset value ("NAV") provided by the trustee as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the stable value collective trust fund, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations would be carried out in an orderly business manner. The stable value collective trust funds are not required to be classified within a level on the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 — CERTIFIED INVESTMENTS**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as of December 31, 2023, the Fidelity Management Trust Company (Fidelity) as trustee, and as of December 31, 2022, the Reliance Trust Company, the trustee of the Plan, respectively, furnished certain financial information to the Plan administrator and certified as to its completeness and accuracy. These certifications are as of December 31, 2023 and 2022 and for the year ended December 31, 2023, and include investment information related to fair value of investments, notes receivable from participants, net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants that are included in the Plan's financial statements and supplemental schedule.

**NOTE 5 — PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of a termination, participants will become fully vested in their accounts.

**NOTE 6 — INCOME TAX STATUS**

The underlying non-standardized prototype plan has received an opinion letter from the IRS dated June 30, 2020. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 — RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 8 — RELATED-PARTY TRANSACTIONS**

As of December 31, 2023, certain plan investments were managed by Fidelity, the trustee, and RBC Wealth Management as the financial advisor (RBC) and these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management and recordkeeping services amounted to \$148,660 for the year ended December 31, 2023.

Notes receivable from participants are considered exempt party-in-interest transactions.
