Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed an audit of the financial statements of HydroChemPSC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 29, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 through December 29, 2022 and the year then ended December 31, 2021, and the related notes to the financial statements (financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 29, 2022 and December 31, 2021 and for the period from January 1, 2022 through December 29, 2022 and the year then ended December 31, 2021, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter - Plan Merger

As discussed in Note 1 to the financial statements, the Board of Directors of Clean Harbors, the Plan's sponsor, elected to merge the Plan into the Clean Harbors Savings and Retirement Plan effective April 1, 2022. All plan assets were transferred to the Clean Harbors Savings and Retirement Plan on December 29, 2022. Our opinion has not been modified with respect to this matter.

INDEPENDENT AUDITOR'S REPORT, continued

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. The following description of the HydroChemPSC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established, effective December 1, 2002, as a defined contribution plan covering all salaried and hourly employees of HydroChem LLC dba HydroChemPSC (the "Company") who complete at least three months of service, except those employees covered by a collective bargaining agreement, leased employees, non-resident aliens who do not receive any earned income from the Company which constitutes United States source income and independent contractors. The Plan has been adopted by the following related employers: Aquilex HydroChem LLC, Aquilex HydroChem Industrial Cleaning LLC, Inland Waters Pollution Control Services, LLC, OmniChem, LLC, PMS Industrial Services, LLC, and Inland Waters of Ohio, Inc. The term "Company" used in the accompanying financial statements and notes hereto, refers collectively to HydroChem, LLC and the related employers listed above. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Effective October 1, 2019, the PSC 401(k) Plan merged into the HydroChem LLC 401(k) Plan (the "Original Plan"). Effective October 1, 2019, the Original Plan was amended and restated as the HydroChemPSC 401(k) Plan.

Plan Merger

On October 8, 2021, HydroChem LLC was acquired by Clean Harbors, Inc. and the Plan was subsequently merged into Clean Harbors Savings and Retirement Plan effective on April 1, 2022 with all assets transferred by December 29, 2022. The accounts of all of the Company's employees were transferred out of the Plan to this existing plan, and there were no remaining balances in the Plan. Effective on January 1, 2022, no additional contributions were allowed to the plan.

Administration

The Plan is administered by an administrator appointed by the Company. Employees of the Company serve as trustees of the Plan and Principal Life Insurance Company and Principal Trust Company (the "Custodian") serves as the custodian of the Plan.

Contributions

Eligible participants may contribute up to 75% of their pre-tax compensation, as defined in the Plan, not to exceed the limitation (\$19,500 in 2021 and \$20,500 in 2022) set forth in Section 402(g) of the IRC. Participants may make catch-up contributions, i.e., pre-tax contributions that exceed the annual elective deferral limit, during any calendar year ending on or after the participant's 50th birthday. Participants' total catch-up contributions during 2022 and 2021 cannot exceed \$6,500. Participants may also make rollover contributions from other qualified plans.

The Company may make discretionary matching contributions. The percentage of elective deferral match, if any, will be determined by the Company annually. Matching contributions will be made for all eligible employees who are active participants on the last day of the Plan year. For the period from January 1, 2022 through December 29, 2022 and the year then ended December 31, 2021, the Company made discretionary or qualified non-elective contributions of \$0 and \$861,924, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions, and earnings or losses on the investments in their account and is charged with specific transaction fees. Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers a guaranteed investment contract, pooled separate accounts, collective trusts, and mutual funds as investment options for participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants are allowed to change their investment options daily.

1. Description of Plan, continued

Vesting

Participants are vested immediately in their contributions, rollovers, plus actual earnings thereon. A participant becomes 100% vested in all Company contributions upon either death or disability while working for the Company, or upon attaining normal retirement at the age of 65. The vesting percentage will also be 100% for a participant who dies or becomes disabled while performing qualified military service. For all other purposes, a participant vests in their Company contributions as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than one year	0.00%
One year but less than two years	33.33%
Two years or more	100.00%

Forfeitures

Forfeitures are first used to pay for Plan administrative expenses and then to reduce future Company contributions. During the period from January 1, 2022 through December 29, 2022 and the year 2021, forfeitures of \$0 and \$81,989, respectively, were used to pay Plan administrative expenses. During the period from January 1, 2022 through December 29, 2022 and the year 2021, no forfeitures were used to reduce Company discretionary matching contributions. At December 29, 2022 and December 31, 2021, unused forfeitures of \$0 and \$10,755, respectively, were included in net assets available for benefits.

Payment of Benefits

At the time of retirement, death, or termination of service, a participant (or his or her beneficiary in the event of death) may receive the value of their account through a lump-sum distribution or installment payments. In-service withdrawals are also permitted for participants who have attained age 59½. If the account balance is \$1,000 or less, the Plan may, upon termination of service, pay the benefits owed in a lump-sum. Participants are eligible to receive hardship withdrawals when certain conditions are met.

Participant Notes Receivable

Participants may borrow from their account, a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Loan terms may not exceed five years, or ten years if used for the purchase of a residence. Principal and interest are paid through payroll deductions. At December 31, 2021, loans bore interest at rates ranging from 4.25% to 6.50%.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of participant notes receivable are charge directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued at quoted market prices which represent the net asset value ("NAV") of shares held by the Plan at year end. The Plan's interest in pooled separate accounts is valued based on the value of the underlying assets. The Plan's interest in the guaranteed investment contract is valued at contract value times 95%, or discounted value, which represents fair value. The Plan's interest in collective trusts is stated at the fair value as determined by the Custodian based upon the quoted market values of the underlying assets.

Purchases and sales of securities are recognized as of the settlement date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes realized gains and losses on investments sold during the year and unrealized appreciation (depreciation) of investments held at the end of the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as loan fees and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 29, 2022 or December 31, 2021. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments

Benefits are recorded when paid.

3. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification Topic 820 (“ASC 820”) *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

In determining fair value, the Plan uses two different approaches (the market approach and the income approach) depending on the nature of the assets and liabilities. The market approach uses prices and other relevant data based on market transactions involving identical or comparable assets and liabilities. The income approach uses valuation techniques to convert future amounts such as cash flows or earnings to a single present amount, with the measurement based on the value indicated by current market expectations about those future amounts.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2021.

Mutual funds: Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. (Market approach)

Common collective trusts: Valued at the NAV of units of a collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawals from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. (Market approach)

Pooled separate accounts: were valued at the net asset value (“NAV”) of shares held by the Plan at year-end, as determined by the Trustee. The NAV was used to estimate fair value as a practical expedient. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. This NAV was not used when it was determined to be probable that the fund would sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) might occur daily. Were the Plan to initiate a full redemption of the pooled separate accounts, the Trustee reserved the right to temporarily delay withdrawal from the Plan in order to ensure that securities liquidations would be carried out in an orderly business manner.

3. Fair Value Measurements, continued

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Fully Benefit-Responsive Investment Contracts

The Plan holds a traditional investment contract with Principal Life Insurance Company (the "issuer"). This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The Plan's guaranteed income fund contract investment, at contract value, as of December 31, 2021 was \$8,316,372.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

4. Fully Benefit-Responsive Investment Contracts, continued

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

5. Information Certified by the Custodian

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 29, 2022 and December 31, 2021, and net appreciation in fair value of investments and interest and dividends and interest income from notes receivable from participants for the period from January 1, 2022 through December 29, 2022 and the year then ended December 31, 2021, was obtained from the information supplied to the Plan administrator and certified as complete and accurate by the Custodian of the Plan.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. Tax Status

Under Section 401(a) of the IRC, the Plan is qualified as tax-exempt. The Plan is based on a prototype non-standardized profit-sharing plan offered by the Custodian. The Custodian received an opinion letter dated March 31, 2014, in which the Internal Revenue Service stated that the Plan, as it was designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan was designed and was operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 29, 2022 and December 31, 2021, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party-in-Interest Transactions

Certain Plan investments are in accounts managed by the Custodian, the Plan pays certain fees to the Custodian to operate the Plan and the Plan issues participant notes receivable. These transactions qualify as party-in-interest transactions, as defined by ERISA. However, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

8. Delinquent Participant Contributions

During the period from January 1, 2022 to December 29, 2022, the Company determined that certain employee deferrals aggregating \$425,444 had not been remitted to the Plan in a timely manner, according to DOL regulations. Although these remittances were made, they fell outside the normal processing time the Company allows. An investigation was held to determine the root cause of the delinquent contributions, and corrective measures will be taken. The lost earnings for 2022 contributions will be processed and paid during 2024 to the impacted participant accounts in the Clean Harbors Savings & Retirement Plan and if there are former employees who have no account balance, a corrective distribution will be provided directly from the participant accounts set up within such plan.

9. Subsequent Events

Plan management has evaluated subsequent events through September 24, 2024, which is the date the financial statements were issued, and has concluded that no other significant events have occurred.
