Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of REO Logistics 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and December 31, 2022, the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

Note 1 – Plan Description

The following description of the REO Logistics, Inc. 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Allied Realty dba REO Logistics and its affiliates, REO Processing, Inc., REO Processing Louisiana, Inc., REO Processing Texas, Inc., and REO Processing West Virginia, Inc. (the “Company”) upon the completion of 90 days of service, except those employees whose employment is governed by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year participants may contribute a percentage of annual compensation as defined in the Plan. The Plan permits catch-up contributions to be made by participants who have attained age 50 before the end of the year. The Plan has an auto-enrollment feature providing for automatic deferral of 3%, with automatic annual increases of 1% each year, up to a maximum of 5%. In addition, participants may also contribute amounts representing distributions from other qualified plans. Participants direct their contributions into various investments offered by the Plan. The Company makes a safe harbor matching contribution of up to 4% of the participant's eligible compensation. Additional amounts may be contributed at the discretion of the Company’s Board of Directors. For the year ended December 31, 2023, the Company made safe harbor matching contributions to eligible participants and did not elect to make an additional discretionary contribution. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s deferral contributions, the Company’s discretionary and safe harbor contributions, and an allocation of Plan earnings (losses), and is charged with benefit payments, transaction fees related to notes receivable from participants, and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions, and the Company’s safe harbor matching contributions plus earnings thereon. Vesting in the Company’s discretionary contribution portion of their accounts plus earnings thereon is based on years of continuous service. Participants vest on a graded schedule and are 100% vested after five years of credited service.

Notes Receivable from Participants

Participants may borrow from their pre-tax account balance a minimum of \$1,000 up to a maximum equal to or the lesser of \$50,000 or one-half of the participant’s vested account balance. Only one loan may be outstanding to a borrower at any time. Loan terms range from 1 to 5 years, unless the note is for purchase of a primary residence, in which case the term may exceed 5 years. The loans are secured by the balance in the participant’s account and bear interest based on

the Prime rate plus 2%. At December 31, 2023, interest rates on loans were 4.25% to 10.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service for any reason or attainment of age 59 1/2, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a specified period. If the vested account balance is below \$5,000 and the participant fails to specify a form of distribution, the vested account balance will be distributed as an automatic rollover payable to an individual retirement plan as directed by the Plan Administrator.

Forfeitures

Forfeited nonvested accounts were \$4,293 and \$-0- at December 31, 2023 and 2022. These accounts will be used to pay plan expenses or reduce employer contributions. During the year ended December 31, 2023, forfeited account balances totaling \$-0- were used to offset administrative expenses or reduce employer contributions.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) require the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent asset and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

Benefit Payments

Benefits paid to participants are recorded when paid.

Administrative Costs

Administrative expenses incurred by the Plan may be paid by either the Company or the Plan on a discretionary basis.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs consist of unobservable inputs and has the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2023 and 2022. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Level 1 Fair Value Measurements

The fair values of pooled separate accounts are based on quoted net asset values of the shares held by the Plan at year end.

Level 2 Fair Value Measurements

The fair value of the stable value fund is based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e., interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include quoted prices for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.

Note 4 – Investment Contracts

The Plan has investments in the John Hancock Stable Value Fund. Included in this fund are certain investment contracts issued by state regulated insurance companies and banks, including but not limited to John Hancock Life & Health Insurance Company. These contracts are considered to be benefit-responsive and presented at fair value. The average yields for the fund are as follows:

The objective of the John Hancock Stable Value Fund is to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term. The percentage of contributions allocated to the fund is determined by the participants.

Note 5 – Related-Party and Party-in-Interest Transactions

Certain administrative functions are performed by employees of the Company. These employees are also Plan participants. No such employee receives compensation from the Plan.

Plan participants invest in funds held or managed by the Plan Custodian, as well as other investment management companies and these are considered related-party transactions. Fees paid to service providers by the Plan for administrative services were \$50,737 for the year ended December 31, 2023.

Note 6 – Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

On September 30, 2024, the Plan Sponsor sold its operations. Employees of the Plan Sponsor will be eligible to participate in the plan of the acquiring company. Plan termination appears to be imminent but there has been no formal resolution to terminate the plan as of the date of this report.

Note 7 – Tax Status

The Plan adopted a non-standardized prototype plan sponsored by Definiti LLC and has not requested a determination letter but rather has relied upon the *Internal Revenue Service* opinion letter dated June 30, 2020 issued on the prototype plan stating the Plan and related trust are designed in accordance with applicable sections of the *Internal Revenue Code* (IRC).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the *Internal Revenue Service*. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 8 – Certification
