## INDEPENDENT AUDITORS' REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of The Arc Montgomery County Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 (in liquidation) and 2022 (ongoing), and the related statement of changes in net assets available for benefits for the year ended December 31, 2023 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the The Arc Montgomery County's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022 and for the year ended December 31, 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Arc Montgomery County Pension Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## ***Emphasis of Matter – Terminating Plan and Liquidation Basis of Accounting***

As further discussed in Note G to the financial statements, the Trustees of The Arc Montgomery County Pension Plan voted on August 14, 2023 to terminate the plan and management determined liquidation is imminent. As a result, the The Arc Montgomery County Pension Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

## ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE A – DESCRIPTION OF THE PLAN**

The following description of The Arc Montgomery County Pension Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**1. General**

The Plan is a money purchase pension plan covering substantially all employees of The Arc Montgomery County Inc. (the Sponsor). The Plan is non-contributory and allows employees to participate in the Plan if they are expected to work 20 hours or more per week on a regular basis and have attained age eighteen. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the trustee. As disclosed in Note G, the Sponsor has terminated the Plan effective August 14, 2023. As of the date these financial statements, the Plan has not been fully terminated.

**2. Contributions**

The Sponsor matched contributions made by participants to The Arc Montgomery County Tax Sheltered Annuity Plan, a related Plan (related Plan) up to 4% of compensation, that a participant contributed, after 6 months of service. These contributions ceased on August 14, 2023 in accordance with the Plan termination. Sponsor matching contributions are invested in the same investment options selected by the participant in the related Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**3. Participant Accounts**

Each participant's account is credited with the Plan Sponsor's contribution and allocations of Plan earnings and losses and are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

**4. Vesting**

Vesting in the Sponsor's matching contribution portion of each participant's account plus earnings is based on years of continuous service. Participant accounts vest one-third each year becoming 100% vested after 3 years of credited service. A year of credited service is a Plan year in which the participant is credited with at least 1,000 hours of service with the Sponsor. Participants became 100% vested on August 14, 2023, the date the Plan terminated.

**5. Payment of Benefits**

Upon termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in annual installments over a ten-year period. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Hardship withdrawals are permitted by the Plan.

## **NOTE A – DESCRIPTION OF PLAN – Continued**

### **6. Notes Receivable from Participants**

The Plan provisions do not allow for participant loans.

### **7. Forfeited Accounts**

At December 31, 2023 and 2022, forfeited non-vest accounts totaled \$-0- and \$3,716, respectively. These accounts will be used to reduce future Sponsor contributions. During the year ended December 31, 2023, Sponsor contributions were reduced by \$3,617 from forfeited non-vested accounts.

### **8. Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of benefits paid to participants are charged directly to the participant's accounts and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

## **NOTE B – SUMMARY OF ACCOUNTING POLICIES**

### **1. Basis of Accounting**

The financial statements of the Plan are prepared on the liquidation basis of accounting as of December 31, 2023 and for the year then ended. The financial statements of the Plan are prepared on the accrual basis of accounting as of December 31, 2022.

### **2. Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **3. Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, trustees and insurance companies. See Note D for discussion of fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## **NOTE B – SUMMARY OF ACCOUNTING POLICIES – Continued**

### **4. Payment of Benefits**

Benefits are recorded when paid. The Plan adopted the provisions of the CARES Act and SECURE Act in 2020, which allowed qualified individuals to receive payment of benefits up to \$100,000 without the 10% penalty for an early withdrawal. Individuals who received qualified distributions under the CARES Act can elect to pay the distribution back within three years. As of December 31, 2023, no participants elected to pay back their qualified distribution.

### **5. Subsequent Events**

The Plan has evaluated events and transactions for potential recognition or disclosure through October 15, 2024, the date the financial statements were available to be issued.

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee of the Plan.

## **NOTE D – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs that reflect unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2: Inputs other than quoted prices that are observable for the asset or liability either directly or indirectly, including inputs in markets that are not considered to be active.
- Level 3: Inputs that are unobservable and supported by little or no market activity and that are significant to the fair value of assets or liabilities.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan’s assets at fair value as of December 31, 2023 and 2022 consisted of mutual funds and totaled \$1,206,024 and \$3,385,502, respectively. All investments in mutual funds are considered Level 1 investments within the fair value hierarchy.

## **NOTE E – GUARANTEED INVESTMENT CONTRACT**

The Plan entered into a fully benefit-responsive investment contract with Principal Life Insurance Company (Principal) totaling \$360,510 and \$1,505,107, as of December 31, 2023 and 2022, respectively. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula agreed upon with the issuer. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. The Plan termination did not limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines (2) a breach of material obligation under the contract (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

## **NOTE F – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are mutual funds managed by Principal. Principal is the trustee as defined by the Plan, and therefore, transactions between the Plan and Principal qualify as party-in-interest transactions. Principal receives revenue from mutual fund service providers for services that Principal provides to the funds. This revenue is used to offset certain amounts owed to Principal for its administrative services and is paid through revenue sharing, rather than a direct payment, the amounts paid and received are included in net appreciation in fair value of investments. Principal Life Insurance Company (PLC) is the contract administrator for the investment contract held by the Plan, therefore, these transactions qualify as party-in-interest transactions. The amount paid to PLC for administrative fees was \$29,639 for the year ended December 31, 2023.

## **NOTE G – PLAN TERMINATION**

The Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their allocation of Sponsor contributions.

The Trustees of The Arc Montgomery County, Inc. Pension Plan voted effective August 14, 2023, to terminate the Plan. All participants are eligible to request their funds to be rolled over into another qualified plan or take a cash distribution. In connection with the termination date, Plan management considered liquidation of the Plan to be imminent as of and for the year ended December 31, 2023. As of October 15, 2024, the Plan termination is still in progress.

## **NOTE H – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **NOTE I – TAX STATUS**

The Internal Revenue Service (IRS) issued a non-standardized pre-approved money purchase pension plan opinion letter to Principal Life Insurance Company dated June 30, 2020, stating that its volume submitter defined contribution plan document was designed in accordance with applicable Internal Revenue Code (IRC) requirements as of that date. 401(a) plans currently are not required to submit plans to the IRS for determination. Although the Sponsor has not applied for a determination letter for the Plan and although the Plan has been amended since receiving the determination letter, the plan administrator and Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator and Plan's tax counsel believe that the Plan was qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
