Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the HVL Employee Retirement Savings Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of HVL Employee Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investments of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2023 and 2022, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

NOTE A DESCRIPTION OF THE PLAN

General

The following description of the HVL Employee Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan Document or *Summary Plan Description* for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by HVL, LLC (Company) for the benefit of its employees who have at least 60 days of service and are age 18 or older. HVL, LLC is a wholly-owned subsidiary of Atrium Biotech Investments, LLC. Participants must have one year of service and be employed on the last day of the Plan year to be eligible for employer profit-sharing contributions. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Certain members of management at the Company are the trustees of the Plan. Empower Trust Company, LLC and Empower Annuity Insurance Company of America serve as the Plan custodians (collectively, "Empower").

As discussed in Note H, the Plan merged with the Nestle 401(k) Savings Plan effective December 31, 2023. The Company was acquired by Nestle Heath Science, S.A (an affiliate of Nestle USA, Inc.) during 2023. The closure of the Company after this acquisition and the preceding wind down of its operations resulted in a partial plan termination during 2023 due to a significant number of employee terminations.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 100 percent of their eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company makes safe harbor matching contributions of 100 percent of employees' salary deferral amounts on the first 4 percent of employees' compensation and 50 percent of the amount of the participant's elective deferrals that exceed 4 percent of the participant's compensation, but do not exceed 6 percent of the participant's compensation. Company profit-sharing contributions are discretionary as determined by the Company's Board of Directors. Contributions are subject to certain limitations.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferral contributions plus earnings thereon. Vesting in the Company's contributions had been based on years of continuous service. Participants were fully vested in safe harbor matching contributions after two years of continuous service. Participants were fully vested in non-safe harbor matching and profit-sharing contributions after six years of continuous service. Due to the partial plan termination that occurred during 2023, all participants in the Plan with termination dates during 2023 were determined to be 100% vested in all types of employer contributions.

Contributions

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set a 1 percent above the prime rate, as defined. Principal and interest is paid ratably through bi-weekly payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the vested interest in their account.

Forfeited Accounts

At December 31, 2023 and 2022, forfeited nonvested accounts totaled \$0 and \$80,706, respectively. These accounts were used to reduce employer contributions or to pay administrative expenses of the Plan. During 2023 and 2022, forfeited nonvested accounts of \$17,891 and \$8,443, respectively, were used to reduce employer contributions. During 2023 and 2022, forfeited nonvested accounts of \$78,539 and \$7,396, respectively, were used to pay Plan administrative expenses. During 2023, forfeited nonvested accounts of \$20,567 were also used to restore amounts forfeited by employees that terminated during 2023 prior to the determination that a partial plan termination had occurred.

Other Unallocated Accounts

A portion of the Empower Investments Fixed Account represents a Plan level expense account that is primarily funded by expense reimbursements provided by the Plan's service providers. The balance of this account was \$0 at December 31, 2023 and 2022. The Company can use these funds to pay for administrative expenses. This account is regarded as an asset account of the Plan for financial statement and Form 5500 reporting. During the years ended December 31, 2023 and 2022, the Plan used \$30,627 and \$34,476, respectively, to pay for administrative expenses of the Plan.

NOTE B SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document. No allowance for credit losses has been recorded as of December 31, 2023 or 2022.

Payments of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

NOTE C CERTIFICATION OF PLAN CUSTODIANS

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Empower Annuity Insurance Company of America and Empower Trust Company, LLC, have certified the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2023 and 2022.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2023 and 2022.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE D RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are group annuity contracts managed by Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America is a custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan Sponsor pays directly certain other fees related to the Plan's operations.

NOTES TO FINANCIAL STATEMENTS

The Plan paid administrative expenses of \$68,038 and \$64,578 to Empower during the years ended December 31, 2023 and 2022, respectively. Individually nonmaterial expenses paid to other parties in interest aggregated \$135,318 and \$48,472 during the years ended December 31, 2023 and 2022, respectively. The Company provides certain administrative services at no cost to the Plan.

NOTE E PLAN AMENDMENTS

In November 2022, the Plan was formally amended to adopt the provisions of the *Setting Every Community Up for Retirement Enhancement Act* (SECURE Act). There were a variety of different provisions modified in connection with this amendment, some which had already been operationally adopted prior to this formal amendment to comply with the required effective dates within the SECURE Act. The more significant changes to the Plan provisions resulting from this amendment include:

- The beginning date for required minimum distributions was changed from 70.5 to 72 years of age. This was retroactively effective for required minimum distributions required to be made after December 31, 2019.
- Long-term part-time employees are now eligible to participate in the Plan after meeting the service requirement of three consecutive eligibility computation periods with at least 500 hours of service in each period. The effective date is for computation periods beginning after December 31, 2020.

Effective January 1, 2024, the Plan was formally amended to freeze the Plan, in which all future contributions will cease, including employee deferrals and employer matching contributions.

NOTE F DISCLOSURES ABOUT FAIR VALUE OF PLAN ASSETS AND LIABILITIES

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2023 and 2022. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

NOTE G INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a fully benefit-responsive traditional investment contract with Empower Annuity Insurance Company of America who maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of HVL, LLC or other events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. In conjunction with the merger discussed in Note H, the group annuity contract was fully liquidated prior to the transfer of Plan assets on December 31, 2023. At the time of liquidation, the fair value of this group annuity contract was less than its contract value by \$14,300. The difference between fair value and contract value was funded by the Company as it deposited this amount into the Nestle 401(k) Savings Plan to make the impacted participants whole.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE H MERGER OF THE PLAN

On December 31, 2023, the Plan merged with the Nestle 401(k) Savings Plan (the surviving Plan). All participants in the HVL Employee Retirement Savings Plan shall have balances in the Nestle 401(k) Savings Plan equal to the sum of the account balances each participant had in the Plan and shall retain credit for their prior service for purposes of meeting Plan eligibility and vesting requirements. To facilitate this transition, there was a scheduled blackout period from December 25, 2023 through December 31, 2023. The Plan's assets at December 31, 2023 were transferred to the surviving plan and are recorded as a transfer to Nestle 401(k) Savings Plan on the statements of changes in net assets available for benefits.

NOTES TO FINANCIAL STATEMENTS

NOTE I PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions. While not considered to be a termination, the Plan was merged into the Nestle 401(k) Savings Plan (the surviving Plan) on December 31, 2023.

NOTE J TAX STATUS

The Plan operates under a non-standardized adoption agreement in connection with a pre-approved plan document sponsored by Walker Benefits, LLC. This pre-approved plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

NOTE K NONEXEMPT TRANSACTIONS

Defined contribution plans are required to remit employee contributions and loan repayments to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted all employee contributions and loan repayments to the Plan, contributions of \$351,548 and 869,696 were not remitted within the required time period for the years ended December 31, 2023 and 2022, respectively. Management identified additional payroll periods that had not been previously reported in the Plan's 2022 financial statements were also not timely remitted during the years ended December 31, 2022 and December 31, 2021. As a result, the late remittances reported in the supplement schedule were changed for 2022 to the amount above and for 2021 were added in the amount of \$478,846.

The Plan calculated lost earnings owed to participants and remitted these lost earnings to the Plan on December 1, 2023. Additionally, the Plan prepared and submitted a Voluntary Fiduciary Correction Program (VFCP) application to the Department of Labor (DOL) that included the corrective measures taken to address the late remittances for 2023, 2022, and 2021. The Plan received a response from the DOL on February 16, 2024, noting no civil enforcement action will be taken regarding these late remittances based on the corrections made.

NOTE L RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan identified certain bonuses paid from 2021 through 2023 had not been included in eligible compensation when calculating employee elective deferrals or employer matching contributions. The Plan has calculated the corrections required under the IRS Employee Plans Compliance Resolution System and remitted these amounts including lost earnings to the Nestle 401(k) Savings Plan on February 28, 2024. The Plan submitted a Voluntary Correction Program (VCP) application during December 2023 for the correction of these eligible compensation issues, but has not yet received a response from the IRS.

NOTE M SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 11, 2024, which is the date the financial statements were available to be issued.
