Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of GEO Services, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of January 10, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the ten day period ended January 10, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the 2023 Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of January 10, 2023 and December 31, 2022 and for the ten day period ended January 10, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:



As a result, all of the Plan's assets, including \$6,301,168 of cash and \$104,582 of notes receivable from participants, were transferred from the Plan into the Universal Engineering Sciences 401(k) Plan on January 10, 2023.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF PLAN

The following description of GEO Services, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan that covers all eligible employees of GEO Services, LLC (the "Company"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan has entered into an agreement with Voya Retirement Insurance and Annuity Company ("Voya") and has appointed this company as trustee of the Plan assets. The recordkeeping of the Plan has also been delegated to Voya.

Plan Merger and Transfer of Assets - Effective January 1, 2023, the Plan was merged, in full, into another defined contribution plan, Universal Engineering Sciences 401(k) Plan, operated by the Company's parent. The closing asset transfer was finalized on January 10, 2023. During the period between January 1 and January 10, 2023, no contribution, distribution, or loan activity occurred. The \$6,579,797 transfer out of the Plan on January 10, 2023 included all assets of the plan as of December 31, 2022, plus change in value of investments of \$175,547 less administrative fees of \$1,500 incurred during the period between the transfer effective date and the date of actual transfer.

Eligibility - Employees of the Company become eligible to participate in the Plan after completing six months of service and reaching 21 years of age. For the purposes of both employee and employer contributions, employees may participate in the Plan on the first day of the quarter coinciding with or next following the date eligibility requirements are met.

Contributions - Participants may defer up to 100% of their eligible compensation into the Plan, up to the maximum amount allowed by the Internal Revenue Code ("IRC"). Contributions may be made on a pre-tax or post-tax basis. Participants who have attained the age of fifty before the end of the Plan year are eligible to make additional "catch-up" contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct allocation of their contributions into various investment options offered by the Plan. The Plan offers multiple registered investment companies and a guaranteed investment contract as investment options for participants.

The Company provides a safe harbor matching contribution equal to 100% of participants' elective deferrals that do not exceed 3% of the participant's compensation plus 50% of participants' elective deferrals between 3% and 5% of the participant's compensation. As the Plan was merged into another plan effective January 1, 2023, there were no safe harbor contributions for the ten day period ended January 10, 2023.

The Company may also make discretionary profit sharing contributions. No such contributions were made for the ten day period ended January 10, 2023.

Participant Accounts - Each participant's account is credited with the participant's contributions and allocations of (a) Company contributions (if any) and (b) plan earnings (losses), and charged with an allocation of administrative expenses. Allocations to each participant are made as an equal dollar amount based upon the number of participants in the Plan.

Vesting - Participants are immediately vested in their contributions and employer safe harbor matching contributions, plus actual earnings thereon. Participants vest in other Company contributions and earnings thereon in 20% increments for each year of continuous service beginning in year two; therefore, participants become 100% vested after six years of credited service.

NOTE 1 - DESCRIPTION OF PLAN - (Continued)

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years and are collateralized by the respective participants account and are evidenced by a note which bears interest at prevailing interest rates. Interest rates ranged from 4.25% to 6.50% during 2022. Principal and interest are paid ratably through payroll deductions. All loans shall be repaid within five years; however, if the loan is for the purchase of a participant's principal residence, the Plan Administrator may permit a longer repayment term. Notes receivable were included in the assets transferred as part of the Plan's merger.

Forfeited Accounts - At January 10, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$0 and \$203, respectively. These amounts may be used to reduce Company contributions or to pay Plan expenses. There were no forfeitures used during the ten day period ended January 10, 2023.

Administrative Expenses - Plan expenses may be paid out of Plan assets unless paid directly by the Company.

Hardship Withdrawals - The Plan allows participants to withdraw a portion of their account balance in the event of immediate and heavy financial need. Any hardship withdrawal is limited to the amount needed to meet the financial need and must qualify with respect to plan provisions.

Payment of Benefits - On termination of service due to death, disability, retirement, or separation, participants may receive a lump-sum payment equal to the participant's vested interest in his or her account. Vested account balances less than \$5,000 are automatically distributed without participant consent.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates - The preparation of financial statements requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value, except for the guaranteed investment contract, which is reported at contract value. Quoted market prices are used to value investments. Shares of registered investment companies are valued at the net asset value of shares held by the Plan at year-end. The guaranteed investment contract is stated at contract value based on the net asset value of the underlying securities.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments held during the year. Employee contributions are recorded when salaries are paid. Employer matching contributions are recorded when authorized.

Benefit Payments - Benefit payments are recorded when paid.

Date of Management's Review - Management has evaluated events and transactions occurring subsequent to the statements of net assets available for benefits date for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through October 14, 2024, which is the date these financial statements were available to be issued.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedule.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. A valuation hierarchy has been established for disclosure of the inputs used to measure fair value. This hierarchy prioritizes the inputs into three broad levels. Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities. Level 2 inputs are quoted prices for similar assets and liabilities in active markets or inputs that are observable for the asset or liability, either directly or indirectly through market corroboration, for substantially the full term of the financial instrument. Level 3 inputs are unobservable inputs based on the Plan's assumptions used to measure assets and liabilities at fair value. A financial asset or liability's classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value.

Registered Investment Companies (Level 1) - The fair value of registered investment companies (mutual funds) is based on quoted net asset values of the shares held by the Plan at January 10, 2023 and December 31, 2022.

General Account (Level 2) - The general account is part of a group annuity contract which invests in a stable value investment contract. The contract value of the general account approximates fair value at January 10, 2023 and December 31, 2022.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - GUARANTEED INVESTMENT CONTRACT

The Plan sponsor has a guaranteed investment contract with Voya, Voya Fixed Account, which is maintained as general assets with Voya. The contract earns interest at a floating rate subject to quarterly adjustments, though the minimum rate is 1.00%. The guaranteed investment contract issuer is contractually obligated to repay the principal and the specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value, subject to a market value adjustment, to any other investment option offered under the Plan at any time.

The average yield and crediting interest rates was approximately 1.50% and 1.00% for the ten day period ended January 10, 2023 and the year ended December 31, 2022, respectively. The crediting interest rate is based on a formula agreed upon with the issuer.

NOTE 7 - TAX STATUS OF PLAN

The initial effective date of the Plan was January 1, 2007. Effective January 1, 2022, the Plan was amended and restated and adopted the ERISA Services, Inc. Non-Standardized Pre-Approved Profit Sharing Plan With CODA (the "ERISA Services Plan"). The Internal Revenue Service determined and informed ERISA Services, Inc. ("ERISA Services") by a letter dated June 1, 2021, that the ERISA Services Plan, as then designed, was in accordance with applicable sections of the IRC. The Plan has not filed for its own determination letter and there were no significant changes to provisions of the Plan as a result of the restatement. The Plan has not been amended since the pre-approved profit sharing plan determination letter was issued; therefore, the Plan administrator and the Plan's tax counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust tax-exempt as of the financial statement date.

The Plan recognizes tax loss contingencies when it is probable that a liability had been incurred and the amount of the loss could be reasonably estimated. The amount recognized would be subject to estimates and management's judgment with respect to the likely outcome of each uncertain tax position. Although the tax years ending December 31, 2020 through January 10, 2023 remain open for examination by various taxing authorities, it is management's opinion that no significant uncertain tax positions remain open at January 10, 2023.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - PARTY-IN-INTEREST

The Company is the administrator of the Plan and, as such, executes the normal duties associated therewith. Costs incurred for audit, legal, and other administrative functions are paid by the Company on behalf of the Plan. There were no financial transactions recorded between the Company and the Plan other than contributions made by the Company to the Plan. ERISA Services provides certain administrative services to the Plan. The Plan's investment adviser is WMG Financial Advisors. The Plan invests in funds managed by Voya. Voya acts as contract holder and recordkeeper for those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Other parties in interest include the auditors of the plan.
