We have performed audits of the accompanying financial statements of Star Truck Rentals, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management has obtained certifications from Greenleaf Trust, a qualified institution, as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. As a result, Star Truck Rentals, Inc. 401(k) Profit Sharing Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following brief description of the Star Truck Rentals, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of Star Truck Rentals, Inc. (Company), the Plan sponsor, and Star Truck Sales, Inc., Star Employee Leasing, LLC, and Sun Truck Service and Support, Inc. Employees become eligible to participate in the Plan after 90 days of service and attaining age 18. A participant becomes eligible to receive employer matching and profit-sharing contributions upon completion of one year of service and attaining age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). As of June 1, 2022, the Plan was restated to bring the Plan into compliance with the Pension Protection Act of 2006 and other legislative and regulatory changes. This Plan restatement also allowed transfer drivers to participate in the Plan. The Plan was terminated during 2023, see Note 5.

**Contributions**

Participants may elect to make contributions to the Plan through payroll deductions from each participant's compensation, as defined, subject to statutory limitations. The Plan also allows participants to transfer funds from other employer qualified plans into the Plan.

For the 2023 plan year, the Company elected to make a matching contribution of 50% of up to the first 6% of compensation deferred. The Company may also elect to make an additional discretionary matching contribution after the end of the plan year. To receive an allocation of the discretionary additional matching contribution a participant must have made elective deferrals during the plan year, be actively employed on the last day of the Plan year and must have 1,000 hours of service during the Plan year. The Company elected to make an additional elective matching contribution of \$0 and \$500,000 to the Plan for the years ended December 31, 2023 and 2022, respectively.

**Plan Operations**

The Company has appointed Greenleaf Trust to act as trustee and the Company to act as plan administrator. The trustee is responsible for holding the investment assets of the Plan, executing investment transactions, and making distributions to participants. The plan administrator interprets and communicates the provisions of the Plan and ensures that all government and participant reporting requirements are fulfilled.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's additional discretionary matching contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Plan allows a participant to self-direct investment transactions associated with separate investment fund options made available by the employer for this purpose, as listed in the accompanying schedule of assets held at end of year.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at 4.25 – 9.25 percent, which is commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through payroll deductions. The loans were paid off as of December 31, 2023.

**Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in employer discretionary contribution accounts is based on years of continuous service, as follows:

A participant also becomes fully vested at the time of the participant's death, if the participant becomes disabled while employed, or upon attainment of normal retirement age.

**Payment of Benefits**

Upon termination of service a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account or partial payments of at least \$1,000. In-service withdrawals are permitted in cases of financial hardship and upon attaining age 59½ if a participant has completed six years of participation in the Plan.

**Forfeitures**

The Plan has forfeitures of non-vested accounts of \$-0- at December 31, 2023 and 2022.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. While management believes it has consistently applied its best judgment in those areas requiring estimates, actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. The insurance policy held by the Plan is excluded from the investment assets in the accompanying financial statements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payments of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation of fair value of investments. Other administrative and investment expenses paid directly to the third-party administrator and the investment advisor are reported as a deduction from changes in net assets. See Note 4.

**Subsequent Events**

For the year ended December 31, 2023, Plan management has evaluated subsequent events for potential recognition and disclosure through October 15, 2024, the date the financial statements were available to be issued.

**NOTE 3 - FAIR VALUE MEASUREMENTS AND DISCLOSURES**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The mutual funds have been valued using unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access. Using unadjusted quoted prices for identical investments in an active market is defined as a level 1 measurement method. All assets were distributed by December 31, 2023.

**NOTE 4 - RELATED-PARTY TRANSACTIONS**

Plan investments included shares of mutual funds managed by Greenleaf Trust. Greenleaf Trust is the trustee, as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing rather than a direct payment. The Plan made a direct payment to the third-party administrator and the investment advisor of \$66,139 which was not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the Plan's operations.

**NOTE 5 - TERMINATION**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participants will become 100% vested in their employer contributions.

During 2023 Star Truck Rentals was sold to another company and the Star Truck Rentals, Inc. 401(k) profit sharing plan terminated effective June 1, 2023. Each participant became fully vested and rolled their account balance out of the Plan by December 31, 2023.

**NOTE 6 - INCOME TAX STATUS**

The IRS has determined and informed the Company by a letter dated June 1, 2016, that the Plan was designed in accordance with the applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
