The following description of the Culichtown Management Group Inc-401k Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan was established to provide retirement benefits for employees of Culichitown Management Group Inc. (the "Company"). Eligible employees become participants in the Plan following 3 months of service and attainment of age 21, as defined in the plan documents. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Trustees, which is made up of key officers of the Company, is responsible for oversight of the Plan.

Contributions - Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the plan document and subject to limitations by the Internal Revenue Code ("IRC"). Participants may also elect to contribute to a Roth subject to limitations by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Employer matching contributions are allowed under the Plan. Additional employer amounts may be contributed at the option of the Company. During the year ended December 31, 2023, no employer amounts were contributed to the Plan.

Participant Accounts - Each participant's account is credited with the participant's contributions and the Company matching contributions (if any), as well as allocations of the Company's profit-sharing contributions (if any) and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the company contributions portion of their accounts is based on years of continuous service. A participant is 100% vested after 5 years of credited services.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Interest is charged on loans at a rate ranging from 6.75% - 10.50% (prime rate plus 2% at inception of loan). The loans must be repaid within 5 years. Principal and interest are paid ratably through payroll deductions.

Note 1 Description of Plan (continued)

Payment of Benefits - On termination of service due to death, disability, retirement or other reasons a participant may elect to receive either a lump-sum amount, substantially equal installments or partial withdrawals equal to the value of the participant's vested interest in his or her account.

Forfeited Accounts - The non-vested portions of participants' employer-derived account balance are treated as forfeitures. At December 31, 2023 and 2022, there were no forfeited non-vested accounts. These accounts can be used to offset plan expenses or may be used to reduce the employer matching contributions, if any.

Note 2 Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes there-in, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022.

Payment of Benefits - Benefits are recorded when paid.

Note 2 **Summary of Significant Accounting Policies** (continued)

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Date of Management's Review - The Plan has evaluated subsequent events through October 14, 2024, the date the financial statements were available to be issued.

Note 3 **Party-in-Interest Transactions**

Certain plan investments are shares of mutual funds managed by Reliance Trust Company, the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions under the Department of Labor's ("DOL") Rules and Regulations.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 4 **Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December, 31 2023, was obtained, by management and agreed to, or derived from information certified as completed and accurate by Reliance Trust Company.

Note 5 **Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable input (level 3).

Note 5 Fair Value Measurements (continued)

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) 820 are described as follows:

LEVEL 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

LEVEL 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

LEVEL 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 6 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7 Tax Status

The Plan adopted a volume submitter plan offered by ADP Retirement Services. The volume submitter plan received an IRS Opinion Letter, dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has not been amended since receiving determination letter.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks.
