**Note 1. Description of the Plan**

***General***

The following description of Ritchie Bros. Auctioneers (America) Inc. Cash or Deferred 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Ritchie Bros. Auctioneers (America) Inc. (Company) for the benefit of substantially all employees on the first day of the month coincident with or next following the date of employment. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Employees of the Company serve as trustees of the Plan. Voya Retirement Insurance and Annuity Company (Voya) serves as Plan custodian.

***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 100% of eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows the Company to make matching contributions of 50% of employees' salary deferral amounts, up to a maximum of \$4,500 and \$4,000 for the years ended December 31, 2023 and 2022, respectively. The Plan allows the Company to make discretionary profit-sharing contributions. There were no discretionary profit-sharing contributions for the years ended December 31, 2023 and 2022. Contributions are subject to certain limitations.

***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 4% of eligible compensation unless the participant made an affirmative election otherwise.

Employer profit-sharing contributions to the Plan are invested based on the participant's current elections at the time of the contribution.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contribution and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions and the Company's contribution portion of their accounts plus earnings thereon.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. All loans are covered by demand notes and are repayable over a period not to exceed five years, except for loans for the purchase of a principal residence, through monthly payroll deductions. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator.

***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant with account balances in excess of \$5,000 must consent to receive a lump-sum amount equal to the value of his or her account. Participants with account balances less than \$5,000 will automatically receive a lump-sum distribution of the interest in their account.

**Note 2. Summary of Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract values). Quoted market prices, if available, are used to value investments. Common stocks, included with self-directed funds, are valued at the closing price reported on the active market on which the individual securities are traded.

Pooled separate accounts are valued at estimated fair value as provided by Voya.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

***Contributions Payable***

Amount payable to 4 participants for match over contributions totaled \$3,350 and is recorded as a liability with a corresponding reduction to contributions at December 31, 2023. Amount payable to 2 participants for match over contributions totaled \$333 and is recorded as a liability with a corresponding reduction to contributions at December 31, 2022.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya, the custodian of the Plan, has certified the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2023 and 2022.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2023 and 2022.
- Investment information included in the accompanying schedule of assets (held at year end) as of December 31, 2023 and 2022.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**Note 4. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain Plan investments are common stocks of the Plan Sponsor, which qualifies as a party-in-interest transaction. These investments are held within the self-directed accounts.

Certain Plan investments are pooled separate accounts managed by Voya. Voya is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

The Plan paid \$191,617 and \$211,095 of recordkeeping fees to Voya during 2023 and 2022, respectively. The Company provides certain administrative services at no cost to the Plan. Individually nonsignificant expenses paid to parties in interest aggregated \$157,845 and \$24,750 during the years ended December 31, 2023 and 2022, respectively.

**Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2023 and 2022. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy.

**Note 6. Investment Contract with Insurance Company**

The Plan has entered into a fully benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company (Voya). Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit-responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The guaranteed investment contract is a traditional investment contract.

**Note 7. Transfer of Plan Assets**

In March 2023, Ritchie Bros. Auctioneers (America) acquired IAA, Inc. On December 20, 2023, an agreement was approved effective January 1, 2024 to merge the Ritchie Bros. Auctioneers (America) Inc. Cash or Deferred 401(k) Plan and the IAA 401(k) plan to form a new plan, the RB Global Retirement Plan. On December 29, 2023, plan assets of the Ritchie Bros. Auctioneers (America) Inc. Cash or Deferred 401(k) Plan totaling \$133,691,971 transferred from Voya to Fidelity Investments, the Custodian of the RB Global Retirement Plan. The Plan assets held at Voya at December 31, 2023 were transferred to the RB Global Retirement Plan subsequent to year-end.

In September 2021, Ritchie Bros. Auctioneers (America) acquired Xcira LLC. On December 14, 2022, an agreement was approved effective January 1, 2023 to merge the Xcira LLC 401(k) Plan assets into the Plan. All Xcira LLC. participants became 100% vested in the Plan upon merger and were provided the option to receive an in service distribution from their fully vested Xcira Employer Matching or Profit Sharing balance. An aggregate of \$2.7 million in assets was rolled into the Plan on February 1, 2023.

In November 2021, Ritchie Bros. Auctioneers (America) acquired SmartEquip, Inc. On December 13, 2022, an agreement was approved effective January 1, 2023 to merge the SmartEquip Inc. 401(k) Profit Sharing Plan and Trust assets into the Plan. All SmartEquip Inc. participants became 100% vested in the Plan upon merger and were provided the option to receive an in service distribution from their fully vested SmartEquip Employer Matching or Profit Sharing balance. An aggregate of \$4.9 million in assets was rolled into the Plan on February 1, 2023.

**Note 8. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**Note 9. Tax Status**

The Plan operates under a Volume Submitter Cash or Deferred Profit Sharing Plan. This prototype plan document has been filed with the appropriate agency and has obtained a letter of acceptance from the Internal Revenue Service that the form of the Plan is acceptable under Section 401 of the Internal Revenue Code. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

**Note 10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 11. Subsequent Events**

Subsequent events have been evaluated through October 15, 2024, which is the date the financial statements were available to be issued.
