## INDEPENDENT AUDITOR'S REPORT

To the Trustees  
**Southern New Hampshire University Retirement Plan and Trust**

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **Southern New Hampshire University Retirement Plan and Trust**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and August 31, 2023, and the related statement of changes in net assets available for benefits for the period ended September 1, 2023 through December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of **Southern New Hampshire University Retirement Plan and Trust's** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2023 and August 31, 2023, and for the period September 1, 2023 through December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to, or derived from, the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of **Southern New Hampshire University Retirement Plan and Trust** and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

#### NOTE 1: DESCRIPTION OF PLAN

The following description of the Southern New Hampshire University Retirement Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General:** The Plan was a non-contributory money purchase defined contribution plan covering all employees of Southern New Hampshire University (the "University" or "Employer") who worked at least 1,000 hours during the Plan year and were age twenty-one or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Plan Merger and Plan Amendments:** The University had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. During the period ended December 31, 2023, the University elected to freeze the Plan and merge the assets of the Plan into a new 401(k) plan offered by the University that began on January 1, 2024 (Southern New Hampshire University 401(k) Plan). As part of this decision, the Plan was amended effective December 31, 2023, to allow employees who worked at least 333 hours during the Plan period to be eligible to participate in the Plan. The Plan was also amended for vesting of the non-elective employer contributions to be 100% vested immediately. Participants who were not employed by the University on December 31, 2023, remained subject to the three year cliff vesting schedule.

**Management of the Plan:** Under the terms of the Plan agreement, the Administrative Committee, comprised of members of management, and Investment Committee acted as the Plan Administrator and operator, respectively. The Investment Committee provided oversight for investments based on the recommendations of an independent investment advisor.

**Employer Contribution:** Each Plan year, the Employer contributed 9% of each eligible participant's compensation allocated on a pro-rata basis based on the eligible compensation of the participant to the total eligible compensation of all participants eligible to be shared in such contributions.

**Participant Accounts:** Each participant's account was allocated a pro-rata share of the Employer's contribution and an equitable share of net investment income (loss) of the Plan. Allocations were based on the participants' compensation or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the Participant's vested account.

**Vesting:** Contributions were previously fully vested to a participant upon attainment of (1) three years of contribution eligibility with service of 1,000 hours or more before reaching normal retirement age (fifty-five), as defined, or (2) one year of service of 1,000 hours or more after age fifty-five. Participants directed the investment of contributions into various investment options offered by the Plan.

**Payment of Benefits:** Participants were entitled to their total vested account balance upon death, disability, retirement, or termination of employment. A participant could have elected to receive a lump-sum amount equal to the value of his or her accounts, or a life or joint and survivor annuity. If a participant's vested account was less than \$1,000, the Plan Administrator, after notification, could have distributed the entire non-forfeited account balance to the participant. If a participant's vested account was greater than \$1,000, but less than \$5,000, the Plan Administrator, after notification, could have distributed his or her entire vested account balance to the participant in the form of an IRA rollover account.

### NOTE 1: DESCRIPTION OF PLAN (CONTINUED)

**Forfeitures:** Upon termination of service, Plan participants forfeited any nonvested balance. At December 31, 2023 and August 31, 2023, forfeited nonvested accounts totaled \$0 and \$432,413, respectively. These amounts were used to reduce future employer contributions. During the period ended December 31, 2023, there were no forfeited non-vested accounts used to reduce employer contributions.

**Teachers' Insurance and Annuity Association ("TIAA") Traditional Annuity:** The TIAA Traditional Annuity was a guaranteed fixed annuity contract that was available as an investment option to Plan participants. Each contract was fully and unconditionally guaranteed by TIAA. The TIAA Traditional Annuity was offered through a variety of contract types. The type of contract through which a participant invested in the TIAA Traditional Annuity determined the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account, and the options for receiving income upon retirement. The Plan's participants were solely invested in Group Retirement Annuities (GRAs) as of August 31, 2023. There were no assets at December 31, 2023.

When participants chose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchased a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium was paid. The participant's principal, plus a specified minimum rate of interest, were guaranteed by TIAA's claim-paying ability. The TIAA Traditional Annuity also provided the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remained in effect for the declaration year, which began each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest was not guaranteed for future years. Together, the guaranteed minimum and additional amounts made up the crediting interest rate. For accumulating GRA contracts, the crediting interest rate was 4.00% as of August 31, 2023.

Under the GRA contract, lump-sum withdrawals were available within 120 days of termination of employment and were subject to a 2.50% surrender charge. All other withdrawals and transfers from GRA contracts had to have been spread over 10 annual installments (five annual installments for withdrawals after termination of employment).

### NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

**Basis of Presentation:** The financial statements of the Plan were prepared in accordance with U.S. generally accepted accounting principles ("GAAP").

**Use of Estimates:** The presentation of financial statements in conformity with GAAP required Plan management to make estimates and assumptions that affected certain reported amounts and disclosures. Accordingly, actual results could have varied from those estimates.

**Investment Valuation and Income Recognition:** Investments were reported at fair value. Fair value was the price that would have been received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for a discussion of fair value measurements.

### NOTE 2: SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included both realized and unrealized gains and losses.

**Administrative Expenses:** Certain expenses for maintaining the Plan were paid by the Plan, unless otherwise paid by the University.

**Payment of Benefits:** Benefits were recorded when paid.

### NOTE 3: CERTIFICATION OF TRUSTEES

The Plan Administrator had elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company ("Fidelity") and TIAA, the Trustees of the Plan, certified that the following data included in the accompanying financial statements were complete and accurate.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

### NOTE 4: FAIR VALUE MEASUREMENTS

The Plan's investments were recorded at fair value using a framework for measuring fair value in accordance with GAAP. That framework provided a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gave the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

#### NOTE 4: FAIR VALUE MEASUREMENTS (CONTINUED)

The three levels of the fair value hierarchy under GAAP are described below:

Level 1 - Inputs to the valuation methodology were unadjusted quoted prices for identical assets or liabilities in active markets that the Plan had the ability to access.

Level 2 - Inputs to the valuation methodology included:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that were observable for the asset or liability; and
- Inputs that were derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability had a specified (contractual) term, the Level 2 input must have been observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology were unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques used needed to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value at August 31, 2023.

There were no Plan assets at December 31, 2023.

Registered mutual funds were valued at the daily closing price as reported by the fund. Funds held by the Plan were open-end mutual funds that were registered with the U.S. Securities and Exchange Commission. These funds were required to publish their daily net asset value ("NAV"). These holdings were classified in Level 1 of the hierarchy.

Investments in TIAA Traditional Annuity GRA contracts were reported at contract value, which approximated fair value. As these investments were contract-based, observable prices for identical or similar investments did not exist, and accordingly, these investments were valued using unobservable inputs (Level 3). The contract value equaled the accumulated cash contributions and interest credited to the contract, less any withdrawals. Liquidity restrictions applied to certain types of contracts that could have impacted the value realized upon exiting the contract.

TIAA offered eight CREF variable annuities. Unlike the TIAA Traditional Annuity, the variable accounts did not provide guaranteed returns. Participant returns depended entirely on the investment performance of each account. The accounts invested principally in mutual funds, equity securities, fixed income instruments and short-term investments in accordance with each portfolio's investment objectives. Account investments were primarily valued using market quotations or prices obtained from independent pricing sources who may have employed various pricing methods to value the investments including matrix pricing.

The fair values of accumulation units held by the Plan in CREF variable annuity accounts were based on each account's daily NAV, which was considered by Plan Management to be the best approximation of the fair value hierarchy. Data for NAVs were available daily to plan administrators and client investors on TIAA's website and provided sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of individual underlying holdings. Underlying holdings were primarily valued using market quotations or prices obtained from independent pricing sources. There were no unfunded commitments from participants in the Plan who invested in these accounts. Variable annuity accounts may have been redeemed on daily basis.

TIAA offered the Real Estate Fund, which was a pooled separate account of TIAA. The account generally invested in real estate properties and real estate-related investments. The account's value was based on the fund's daily NAV, which was considered by Plan Management to be the best approximation of fair value. The investment was classified within Level 1 of the fair value hierarchy. The unit value of the fund was calculated daily and available to plan administrators and client investors on TIAA's website as well as a nationally recognized securities exchange. Underlying holdings were primarily valued using independent appraisals or independent pricing sources. There were no unfunded commitments from participants in the Plan who invest in the account. The TIAA Real Estate Fund may have been redeemed on a quarterly basis.

The common/collective trust was valued at the NAV of units of a collective trust. The NAV, as provided by the fund manager, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not have been used if it is was determined to be probable that the fund would sell the investment for an amount different from the reported NAV.

The methods described above may have produced a fair value calculation that may not have been indicative of net realizable value or reflective of future fair value. While Plan Management believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

**NOTE 5: RISKS AND UNCERTAINTIES**

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**NOTE 6: TAX STATUS**

On June 30, 2020, the Internal Revenue Service ("IRS") stated that the prototype adopted by the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan had not received a determination letter specific to the Plan itself; however, Management believed that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes had been included in the Plan's financial statements.

#### **NOTE 6: TAX STATUS (CONTINUED)**

GAAP required Plan Management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan had taken an uncertain tax position that more likely than not would not have been sustained upon examination by the IRS. The Plan Administrator had analyzed the tax positions taken by the Plan, and had concluded that as of December 31, 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress. The Plan Administrator believes it was no longer subject to income tax examinations for years prior to 2020.

#### **NOTE 7: RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain investments were shares in registered investment companies managed by TIAA and Fidelity, the Trustees of the Plan. Accordingly, these were considered exempt party-in-interest transactions.

#### **NOTE 8: SUBSEQUENT EVENTS**

The date to which events occurring after December 31, 2023, the date of the most recent statement of financial position, have been evaluated for possible adjustment to the financial statements or disclosure is October 15, 2024, which is the date the financial statements were available to be issued.
