### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed the audits of the financial statements of San Jorge Children's Hospital Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). ## Notes to Financial Statements

December 31, 2023 and 2022

### Note 1 - Description of the plan

The following description of the San Jorge Children's Hospital Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan, established in 1993, covering substantially all full-time employees of San Jorge Children's Hospital, Inc. (the Plan Sponsor or the Company) who have at least three months of service, as defined, and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On September 1, 2022, the Plan Sponsor (the "Debtor") filed a voluntary petition for relief (the "Chapter 11 Case") under Chapter 11 of the United States Bankruptcy Code (the "Bankruptcy Code") with the Bankruptcy Court for the District of Puerto Rico (the "Bankruptcy Court") in order to implement the financial restructuring of the Company.

The Debtor continued to operate its business as a "debtor-in-possession" under the jurisdiction of the Bankruptcy Court and in accordance with the applicable provisions of the Bankruptcy Code, the Debtor may not engage in transactions outside the ordinary course of business without the prior approval of the Bankruptcy Court. Further, Debtor has filed a variety of motions with the Bankruptcy Court requesting permission to continue the Company's business activities in the ordinary course.

The Bankruptcy Court held hearings to consider the Debtor's different motions and entered orders approving the expenses to continue to operate its business in the ordinary course of business.

The Debtor filing of the Chapter 11 Case constituted an event of default that accelerated the Company's obligations under its debt agreements. Specifically, the filing of the Chapter 11 Case constituted an event of default under (a) the Credit Agreement, among the Company, its lenders including its administrative agent and collateral agent, with respect to the Senior Credit Facility. Due to the Chapter 11 case, however, the lenders' ability to exercise remedies under their respective credit agreements and debt instruments was stayed as of the date of the Chapter 11 petition and continues to be stayed.

Note 1 - Description of the plan – (continued)

General – (continued)

Effective in June 7, 2024, the Company completed the sale on its business to an independent third party. As a result on this transaction the Plan's net assets and all related operations, including trusteeship and record-keeping were transferred to new entities. Company management has confirmed that the transaction was conducted in accordance with all required compliance regulations and received the necessary approvals from relevant regulatory authorities.

Contributions

Participants may contribute a percentage of their compensation, as defined in the Plan, not exceeding the maximum deferral amount specified by local law. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan Sponsor contributed 50% of a participant's eligible contributions, not to exceed 2% of compensation, as defined, until August 31, 2019, when the Plan was amended to eliminate matching contributions. Consequently, no sponsor contributions were made for the years ended December 2023 and 2022.

Participant's accounts

Each participant's account is credited with the participant's contribution and allocations of Plan earnings. Allocations are based on participant earnings or account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's contributions portion of their accounts, plus actual earnings thereon, is based on years of continuous service.

2 years less than 3	25%
3 years less than 4	50%
4 years less than 5	75%

Notwithstanding the above, all participants are fully vested upon attaining the latter of age 65 or the fifth anniversary in which the employee was eligible.

Investment options

Participants direct the investment of their account balances into various investments options offered by the Plan. The Plan currently offers mutual funds and money markets as investment options for its participants.

Note receivable from participants

Notes receivable from participants are not permitted.

Excess participant's contribution payable

Excess participant's contributions are reimbursed to the participants. Excess contributions are recorded as a liability in the accompanying statements of net assets available for benefits and as a reduction of participant-directed contributions for the year.

Payment of benefits

Upon termination of service due to death, disability or retirement, a participant or the participant's beneficiaries may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or periodic installments.

Payment of benefits – (continued)

For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

In addition, the Plan provides for in-service distributions in certain circumstances, including financial hardship withdrawals, subject to certain limitations. Also, in-service distributions may be available to participants as special disaster distributions, as determined by the Puerto Rico Treasury Department.

Forfeitures

Upon termination from employment or withdrawal from the Plan for any reason other than death, retirement or disability, the Plan's contributions on behalf of the participants not then vested are forfeited and may be used to reduce related Plan costs and expenses. During the years ended December 31, 2023 and 2022, the Plan used these funds to pay certain administrative expenses amounting to \$6,899 and nil, respectively. As of December 31, 2023 and 2022, forfeited non-vested accounts amounted to \$7,589 and \$1,983, respectively.

Administrative expenses

Administrative expenses are paid by the Plan Sponsor, as provided in the Plan document.

Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor's has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts. The Plan's assets transfer disclosed in Note 1 did not constitute a plan termination.

Note 2 - Summary of significant accounting policies

Basis of accounting

The accompanying financial statements have been prepared under the accrual method of accounting and in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Note 2 - Summary of significant accounting policies – (continued)

##### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Investment valuation and income recognition

The Plan's investments are reported at fair value. Shares of mutual funds are valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis.

Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation (depreciation) in fair value of investments, includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Risks and uncertainties

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

##### Benefits payable

The Plan accounts for benefits payable in accordance with the guidance provided by the American Institute of Certified Public Accountants (AICPA) *Audit and Accounting Guide, Audits of Employee Benefit Plans*. This guidance requires that benefits payable to persons who have withdrawn from participation in a defined contribution plan be disclosed in the notes to the financial statements rather than recorded as a liability of the Plan. As of December 31, 2023 and 2022, benefits payable to participants who have elected to withdraw from the Plan, but have not yet been paid amounted to \$8,956 and \$2,439, respectively.

##### Payment of benefits

Benefits are recorded when paid.

Note 3 - Information certified by the trustee (unaudited)

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee of the Plan, Banco Popular de Puerto Rico (the Trustee), has certified as to the completeness and accuracy of all investment related information reflected in the accompanying financial statements as of December 31, 2023 and 2022, and for the year ended December 31, 2023, and the related notes to the financial statements, and the schedule H, Part IV, line 4i – Schedule of Assets (held at end of year) as of December 31, 2023. The Trustee maintains all records, executes investments transactions, and holds all of the assets of the Plan. In addition, the Trustee, upon authorization from the plan administrator, distributes benefit payments to the participants.

During the year ended December 31, 2023, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$664,509.

Note 4 - Fair value measurements (unaudited)

In accordance with the provisions of Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) No. 820, *Fair Value Measurements*, the Plan uses valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs to the extent possible to estimate fair values. The Plan determines fair values based on assumptions that market participants would have used in pricing an asset or liability in the principal or most advantageous market.

FASB ASC 820 provides a fair value hierarchy that prioritizes the use of observable inputs in the valuation techniques used to measure fair value, as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Note 4 - Fair value measurements (unaudited) – (continued)

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3        Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used by the Plan for investments measured at fair value at December 31, 2023 and 2022:

Mutual funds – Investments in mutual funds consist of shares of mutual funds that are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan consist of open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and were categorized as Level 1.

Money market – Money market accounts are valued at cost, plus accrued interest, which approximates fair value. These investments are classified as Level 1.

The preceding valuation methodologies may have resulted in fair values that may had not been indicative of net realizable values. The use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in different fair value measurements at the reporting date. The Plan management believed its valuation methods were appropriate and consistent with other market participants.

Note 5 - Party-in interest transactions

Certain Plan investments consist of cash deposits managed by the Trustee. Therefore, these transactions qualify as party-in-interest transactions.

Note 6 - Non-discrimination test

The Plan did not comply with the discrimination test for the years ended December 31, 2023 and 2022. This test requires compliance with a determined percentage of contributions to the Plan as established in Section 1081.01 of the Code. The Plan Sponsor elected to reimburse highly compensated employees the excess contributions made during the years ended December 31, 2023 and 2022, amounting to \$2,193 and \$6,982, respectively.

Such participants received the 2023 and 2022 excess contributions in March 2024 and August 2023, respectively.

Excess contributions are recorded as a liability in the accompanying statements of net assets available for benefits.

Note 7 - Tax status

The Plan constitutes a qualified plan, exempted from income tax under the provisions of Section 1081.01 of the Internal Revenue Code for a New Puerto Rico (the Code), as amended. The Plan is required to operate in conformity with the Code to maintain its qualification.

The Plan obtained its latest determination letter on June 26, 2012, in which the Commonwealth of Puerto Rico tax authorities stated that the Plan, as then designed, was in compliance with the applicable requirements of Section 1081.01. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

Management has evaluated the Plan tax position and concluded that the Plan has maintain its tax-exempt status and had a taken no uncertain tax positions that require adjustment to the financial statements.

Note 8 - Subsequent events

The Plan has evaluated subsequent events through October 15, 2024, which is the date the financial Statements were available to be issued. Except as described in Note 1 (General) and Note 6, no other events have occurred subsequent to the statement of net asset available for benefit date and to the date financial statements were available to be issued, that would require additional adjustment to, or disclosure in the financial statements.
