Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes (collectively referred to as the “financial statements”).

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Notes to Financial Statements

December 31, 2023 and 2022 and Year Ended December 31, 2023

1. Description of Plan

The following description of the Patterson Companies, Inc. Employee Stock Ownership Plan (the Plan) provides general information about the Plan's provisions. Patterson Companies, Inc. (the Company) is the plan sponsor and plan administrator. The Plan is administered through a trust for which Delaware Charter Guarantee and Trust, d/b/a Principal Trust Company, serves as the directed trustee (the Trustee). Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

General

The Plan became effective as of May 1, 1989. The Plan is designed to be a qualified stock bonus plan and employee stock ownership plan under the provisions of Section 401(a) of the Internal Revenue Code of 1986 (the Code), as amended, and the Employee Retirement Income Security Act of 1974, as amended (ERISA). As such, substantially all investments held in the Plan are in common stock of the Company.

The Plan was amended in July 2021 to freeze the Plan. No new employees are eligible to participate in the Plan after June 30, 2021.

During the course of its operation, debt had been used to acquire shares of stock by the Plan. The Company's annual contribution was used to satisfy principal and interest due on the loan, and a portion of the shares of stock acquired with the loan were then released by the Trustee in the plan year for allocating to participants' accounts.

In 2020, the Company's final contribution for the 2020 Plan year was sufficient to retire all debt held by the Plan and all unallocated shares held in the Plan were released and allocated to participants.

Prior to the Plan being frozen to new participants (and except for the year in which the safe harbor non-elective contribution was made), an Employee of the Company became eligible to receive a discretionary contribution as of the first of the month after six months of employment of at least 500 hours of service. An Employee is defined under the Plan as any individual employed by the Company other than an independent contractor. An Employee who is eligible to receive a

1. Description of Plan (continued)

contribution is known hereafter as a participant. With respect to a discretionary contribution, the Company had contributed an amount to the Plan each year as determined by the Board of Directors of the Company. A participant received an annual stock allocation from the Plan as of each December 31, provided the participant worked at least 1,000 hours during the period and was still employed by the Company on the last day of the plan year or was terminated during the plan year due to disability or death. The allocation was based on the proportionate share of a participant's compensation for the plan year to the total compensation of all participants for such plan year.

Contributions

The Company made no contributions to the Plan for the Plan years ended December 31, 2023 and 2022.

Vesting and Forfeitures

Contributions made to a participant's account vest at a rate of 100% after three years of service; with the exception of the participant's account attributable to the safe harbor non-elective contribution which vests at a rate of 100% after two years of service. Participants may become 100% vested upon attainment of age 65, if still employed by the Company, termination due to disability or death while employed, or upon termination of the Plan. Forfeitures of non-vested account balances during the Plan year are credited proportionately to each active participant account. The total amount of forfeitures credited to participants for Plan year ending December 31, 2023 was \$613,849.

Distributions

Upon separation from service with the Company due to death, disability, retirement or termination, a participant is paid in whole shares of stock (valued at its fair value), in cash, or in a combination of both. Participants are only entitled to the benefit that can be provided from the participant's vested account.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service (the "IRS") and a participant must exhaust all available loan options and available distributions prior to requesting a hardship withdrawal.

Additionally, participants who are age 59 1/2 or older may withdraw all or a portion of their vested account balance for any reason.

1. Description of Plan (continued)

The Plan permits participants at least 55 years of age and who have completed ten full years of participation to diversify a portion of their vested account balance. Diversification occurs through a transfer of cash into the 401(k) Plan.

Plan Termination

The Plan was frozen to new participants effective July 1, 2021 and the Company no longer makes contributions to the Plan. Effective December 31, 2023, the Company merged the Plan into the Patterson Company's, Inc. 401(k) Plan, another plan sponsored by the Company. As a result of this merger, net assets in the amount of \$249,359,553 were transferred to the Patterson Companies, Inc. 401(k) Plan on December 31, 2023. The net assets transferred out of the Plan are reflected on the statement of changes in net assets available for benefits as a transfer from the Plan. Subsequently, it is the Company's expectation that the Plan shall remain in effect, but the Company retains the right to terminate the Plan subject to the provisions of ERISA and the continuance of the Plan is not assumed as a contractual obligation of the Company. In the event of the Plan's termination, all participant accounts become 100% vested, and the assets of the Plan shall be distributed to the participants in accordance with the original terms specified in the plan document.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid. Accordingly, benefits payable to persons who have elected to withdraw from the Plan but have not been paid are not accrued. At December 31, 2023 and December 31, 2022, no benefits were payable to participants.

Expenses

Costs and expenses incurred in conjunction with the operation of the Plan are borne by, and paid out of, the Plan's assets, except to the extent the Company's Board of Directors directs such expenses to be paid by the Company. For the Plan year ended December 31, 2023 the Plan paid \$2,586 for plan-related expenses.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts

reported in the financial statements and accompanying notes and supplemental schedules. Actual results could differ from those estimates.

Investment Valuation, Income, and Dividend Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis.

Interest income is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. The Company paid dividends of \$1.04 per common share of Patterson Companies, Inc. stock during the Plan year ended December 31, 2023.

3. Investments

At December 31, 2023 and 2022, the Plan held a total of 0 and 9,383,203 shares of common stock of the Company, respectively, all of which were allocated to Plan participants. All investments are held by the Trustee.

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2023 and December 31, 2022, net appreciation (depreciation) in fair value of investments, and interest and dividends for the year ended December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Trustee.

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

4. Fair Value Measurements (continued)

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- quoted prices for similar assets and liabilities in active markets
- quoted prices for identical or similar assets or liabilities in markets that are not active
- observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety. In determining fair value, the Plan uses observable market data when available.

The following sets forth the types of assets measured at fair value:

Effective December 31, 2023, the Company merged the Plan into the Patterson Companies 401(k) Plan. As a result of this merger all assets of the Plan were transferred to the Company’s 401(k) Plan.

Money market mutual funds and the common stock of Patterson Companies are valued at the quoted market price on the last business day of the Plan year. Quoted market prices for money market funds represent the net asset value (NAV) of shares held by the Plan at year-end. Quoted market prices for common stocks represent the last reported sales price on the last business day of the Plan year.

5. Reconciliation of Financial Statements to the Form 5500

There were certain immaterial differences between the financial statements and Form 5500 attributed to a reporting matter.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Tax Status

The Plan has received a determination letter from the IRS dated June 9, 2017, stating that the Plan is qualified under Section 401(a) of the Code and therefore, the related trust is exempt from taxation. Subsequent to applying for this determination by the IRS, the Plan was amended and restated. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and therefore, believes the Plan, as amended and restated, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States, require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions.

9. Subsequent Events

Management evaluated subsequent events for the Plan through October 15, 2024, the date the financial statements were available to be issued. The Company amended the Company's 401(k) Plan to merge this Employee Stock Ownership Plan into the Patterson Companies, Inc. 401(k) Plan effective December 31, 2023. As a result, and pursuant to 401(a)(35), participants with three or more years of service, may diversify up to 100% of their ESOP balance in other investments offered within the merged plan.
