## Notes to Financial Statements

---

### Note 1: Description of Plan

The following description of the WB Manufacturing, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all full-time employees of WB Manufacturing LLC (the "Company"), except for leased, casual or part-time, collectively bargained employees, and non-resident aliens, as defined in the plan document. An employee becomes eligible to participate in the Plan with an immediate entry date following one hour of service within a one-month time period following the employee's employment commencement date and attainment of age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Change in Custodian/Trustee

Effective March 1, 2023, the Plan changed from Sentry Life Insurance Company, the Custodian of the Plan, to Reliance Trust Company, the Trustee of the Plan, and adopted a restatement of the Plan.

#### Contributions

Participants are allowed to contribute pretax compensation, as defined in the Plan, and Roth contributions up to the annual maximum allowed by the Internal Revenue Service (IRS) each year. Effective March 1, 2023, participants are automatically enrolled to defer 3% of eligible pretax compensation if no election or waiver is made by the participant. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of contributions into various investment options offered by the Plan.

Prior to March 1, 2023, the Company matched 100% of eligible participants' contributions up to the lesser of 6% of their eligible compensation or \$1,500. Effective March 1, 2023, the Company matches an amount equal to 100% of a participant's elective deferrals, not to exceed 3% of a participant's eligible compensation. Rollovers are not matched. Plan matching contributions were \$397,454, net of forfeitures, for the year ended December 31, 2023.

Contributions are subject to certain IRS limitations.

### Note 1: Description of Plan (Continued)

#### Participant Accounts

Each participant's account is credited with the participant's contribution and rollover contributions, Company matching contributions, and allocations of plan earnings (losses), and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant's eligible compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings (losses) thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Prior to March 1, 2023, participants vested at a rate of 20% per year beginning with the second year of service. Participants became fully vested after six years of service. Effective March 1, 2023, participants vest at a rate of 25% per year beginning with the first year of service. Participants become fully vested after four years of service.

#### Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, including the Roth deferral account balance. Note terms range from one to five years or up to 15 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at a rate determined by the plan administrator. The interest rates on existing loans range from 5.25% to 7.50%. Principal and interest are paid ratably through payroll deductions. Effective March 1, 2023, no new participant loans are permitted.

#### Payment of Benefits

On termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, installments, or ad-hoc distributions. If the terminated participant's vested account balance does not exceed \$5,000, the Plan will automatically distribute the account balance in a lump-sum amount. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59½.

#### Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's contributions. These forfeitures are used to pay plan expenses or reduce Company matching contributions. Unallocated forfeitures from nonvested accounts at December 31, 2023 and 2022, were \$10 and \$17,565, respectively. Forfeitures in the amount of \$24,875 and \$3,760 were used to reduce Company contributions and pay plan expenses, respectively, for the year ended December 31, 2023.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

#### Excess Contributions Payable

At December 31, 2023, amounts payable to participants totaled \$92,560 for contributions in excess of amounts allowed by the IRS and are recorded as liabilities with a corresponding reduction to contributions. The excess contributions payable were distributed to the applicable participants prior to March 15, 2024. The Plan had no excess contributions for the year end December 31, 2022.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

The Company absorbs various plan expenses including third-party administration fees and audit fees. Expenses that are paid by the Company are excluded from these financial statements. Investment advisory and management fees are allocated proportionately to plan participants based on their respective account balances and are offset against earnings. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

#### Subsequent Events

The Plan has evaluated subsequent events through October 9, 2024, which is the date the financial statements were available to be issued.

On January 24, 2024, a portion of the John Boos and Co. 401k Plan merged into the WB Manufacturing, LLC 401(k) Plan.

### Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

### Note 3: Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2023 and 2022.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective investment trust fund:* Valued at the NAV of the underlying investments held by the collective investment trust, as reported by the fund house or other investment provider. The underlying investments are valued and published daily and transact at that price.

*Mutual funds held in pooled separate accounts:* Fair value of mutual funds held in pooled separate accounts is based on the quoted net asset value (NAV) of underlying investments held by the pooled separate accounts adjusted by an asset charge. The underlying mutual funds held in the pooled separate accounts are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily NAV and transact at that price.

*Guaranteed fund:* The fair value is equal to the book value plus or minus any market value adjustment. Book value of the guaranteed fund is based on contract provisions and represents participant contributions, plus interest, less transfers and amounts used to pay benefits and withdrawals.

### **Note 4: Information Prepared and Certified by the Custodian and Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, the Trustee of the Plan as of December 31, 2023, and for the period of March 1, 2023 to December 31, 2023, and Sentry Life Insurance Company, the Custodian of the Plan as of December 31, 2022, and for the period of January 1, 2023 to February 28, 2023.

### **Note 5: Related-Party Transactions and Party-in-Interest Transactions**

Certain plan investments are managed by Reliance Trust Company and Sentry Life Insurance Company, as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. Fees for investment management services were offset against earnings during the plan year ended December 31, 2023. Specific detail for management fees is not available from the Reliance Trust Company and Sentry Life Insurance Company.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 6: Tax Status**

The Company adopted a non-standardized pre-approved plan document with an IRS notification letter, which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
