**December 31, 2023 and 2022**

#### **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the BridgeTower Media 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### ***General***

The Plan is a defined contribution plan covering all employees of BridgeTower OPCO LLC (the "Sponsor" or "Employer") eligible to participate. Employees who have attained the age of 21 are eligible to participate. The Plan commenced operations on January 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") as amended. The Plan administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

The Plan trustee is Ascensus Trust Company ("ATC" or the "Trustee"). The Vanguard Group, Inc. ("Vanguard") serves as the Plan's recordkeeper. However, Vanguard has retained Ascensus, LLC ("Ascensus") as a subcontractor to provide all recordkeeping services on behalf of Vanguard.

##### ***Contributions***

A participant may elect to contribute up to 100% of their pretax, annual compensation or elect to contribute up to 100% of the participant's annual compensation as after-tax Roth deferrals, as defined in the Plan. The Plan does allow for transfers and rollovers from qualified plans. The Plan includes an auto-enrollment provision whereby all newly hired employees who satisfy the eligibility requirements are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan also includes an auto-escalation provision whereby auto-enrolled participants are subject to an annual automatic deferral rate increase of 1% until their deferral rate reaches 10% of eligible compensation. Participants may elect to discontinue their participation in the automatic deferral rate increase at any time.

Contributions are subject to certain limitations. For the year ended December 31, 2023, the maximum contribution allowed by a participant under 50 years of age is \$22,500. For a participant over 50 years of age the maximum contribution allowed is \$30,000. The Sponsor may make matching contributions at its discretion. During 2023 and 2022, the Sponsor matched 25% of the first 6% of eligible compensation deferred. Further, the Sponsor may make discretionary profit-sharing contributions. For the years ended December 31, 2023 and 2022, no discretionary profit-sharing contributions were made to the Plan.

##### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Sponsor's contributions and Plan earnings. Participants' accounts are charged with benefit payments and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### ***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's matching contributions and discretionary profit-sharing contributions, plus actual earnings thereon, is based on years of continuous service. A participant is fully vested when they attain normal retirement age of 65. Prior to normal retirement age, a participant's interest in the contributions of the

Sponsor vest 20% after one year of service, increasing 20% each succeeding year until 100% vested after five years of service. Additionally, a participant's balance will become 100% vested upon death or disability.

#### ***Forfeitures***

Account balances are forfeited as a result of a participant's termination of employment prior to vesting in discretionary matching and profit-sharing contributions. Forfeitures may be used by the Sponsor to reduce its contributions to the Plan or to pay for the administrative expense of the Plan, as determined by the Sponsor at its sole discretion. As of December 31, 2023 and 2022, forfeited nonvested accounts totaled \$25,790 and \$21,782, respectively. During the years ended December 31, 2023 and 2022, \$5,004 and \$5,621, respectively, was used to pay the Plan's administrative expenses. No forfeited nonvested accounts were used to reduce the Sponsor's contributions during the years ended December 31, 2023 and 2022.

#### ***Notes Receivable from Participants***

Participants may borrow from their vested fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are permitted to have only two loans outstanding at any time. The loans are secured by the balance in the participant's account. The interest on loans from the Plan will be computed based on the prime rate, as specified in the Wall Street Journal, plus one percent. Principal and interest is paid ratably through monthly payroll deductions.

#### ***Investment Options***

Upon enrollment in the Plan, a participant may direct contributions to any or all of the investment options offered by the Plan for investment.

#### ***Payment of Benefits***

Distributions are permitted only upon attainment of normal retirement age, termination of employment, or the event of financial hardship, as defined. On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. Hardship distributions to active participants are allowed by the Plan from any accounts which are 100% vested.

### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### ***Use of Estimates***

The preparation of financial statements in accordance with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are held by the Trustee. The Plan's investments are stated at fair market value. Fair market value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. See Note 5 for discussion of fair value measurements.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions when they are determined to be uncollectible.

#### ***Risk and Uncertainties***

Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

#### ***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

#### ***Administrative Expenses***

Expenses incurred in the establishment, administration and operation of the Plan are charged to the Plan and allocated to participants' accounts based on each participant's account balance, unless the Sponsor agrees to pay the fees. Amounts paid by the Sponsor are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments in the statements of changes in net assets. Certain transaction fees related to loans are charged directly to the specific participant's account.

#### **NOTE 3 - PARTY-IN-INTEREST TRANSACTIONS**

Vanguard manages certain Plan investments and is the investment advisor for the Plan. Therefore, these transactions qualify as party-in-interest transactions. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. Notes receivable from participants also qualify as party-in-interest transactions.

#### **NOTE 4 - INFORMATION CERTIFIED BY PLAN'S TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 20 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

#### NOTE 5 - FAIR VALUE MEASUREMENTS

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the best level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* These investments are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust fund:* These investments are valued using NAV as the practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. The net asset value of the funds is calculated daily. There were no unfunded commitments as of December 31, 2023 and 2022. **NOTE 7 - INCOME TAX STATUS**

The Plan Sponsor adopted a prototype non-standardized Profit-Sharing Plan with Cash or Deferred Arrangement ("CODA"). The Internal Revenue Service ("IRS") determined and informed Ascensus in an opinion letter dated June 30, 2020, that the CODA is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the IRS' opinion letter on the prototype plan. The Sponsor and the Plan administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Accordingly, the Plan is exempt from income taxes.

GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2023 and 2022, no uncertain tax positions have been taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events (events occurring after December 31, 2023) through October 15, 2024, the date the financial statements were available to be issued. Except as described below, the plan is not aware of any subsequent events that required recognition or disclosure have been incorporated into these financial statements.

Effective January 1, 2024, the Employer adopted Aspen HR PEO LLC Retirement Savings Plan, a multiple employer plan, for its employees. In May 2024, the Plan's funds were transferred from Vanguard to National Financial Services (Fidelity), plan trustee and Slavic Integrated Administration, Inc., is the plan recordkeeper.
