Independent Auditor's Report

To the Trustees of
Dansons USA, Inc. 401(k) Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Dansons USA, Inc., 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2023 (in liquidation) and December 31, 2022 (ongoing), and the related statement of changes in net assets available for benefits for the year ended December 31, 2023 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the 2023 and 2022 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Use of Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the plan sponsor was acquired in July 2023. Those charged with governance made a decision to terminate the Plan, and management determined liquidations is imminent. As a result, the Plan has changed its basis of accounting to liquidation basis of accounting, starting with the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”), and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan’s transactions that are presented and disclosed in the financial statements are in conformity with the plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental schedule of assets held at year end as of December 31, 2023, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of the Plan Prior to Plan Termination

The following description of Dansons USA, Inc., 401(k) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Plan Termination

In July 2023, the plan sponsor was acquired by an unaffiliated entity. A decision was made to terminate the plan effective July 31, 2023. Effective with the Plan’s termination, all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of status of years of vested service. The Plan’s termination also ceased employee contributions into the Plan and ceased new participant notes receivables from the Plan. Following the termination of the plan, the distributions of participants’ assets began and is expected to be completed in 2024.

General

The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (the “Code”) covering all employees of Dansons USA, Inc., (the “Company” and “Plan administrator”). The trustee of the Plan assets is the Reliance Trust Company (“Trustee”). ADP serves as the recordkeeper of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is currently in conformity with all Internal Revenue Service (“IRS”) and Department of Labor rules and regulations.

On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security Act (“CARES Act”) was passed by Congress. The CARES Act contained several provisions that temporarily impact 401(k) plans, including the waiver of required minimum distributions, a new hardship withdrawal option, increased loan limits, and a pause option for loan payments. The provisions of the CARES Act were effective and operationalized immediately, prior to amending the plan document. The Company has adopted certain relief provisions included in the CARES Act, and an official amendment is expected to be signed on or before December 31, 2025.

Eligibility

Employees are eligible to participate in the Plan upon completing two months of service with the Company. Plan entry date is the first day of the month coinciding with or following the date the requirements are met. Entry into the plan is automatic unless elected to not participate. Certain nonresident aliens and employees who are residents of Puerto Rico are excluded from participating in the Plan.

Contributions

Under the terms of the Plan, eligible employees may elect to defer from 1% to 90% of their annual compensation limited to a maximum annual amount specified by the IRS (\$20,500 for employees under age 50 and \$27,000 for employees ages 50 and over in 2023). Deferrals are automatically set at 6% upon automatic enrollment, once eligible. Deferrals may be made on a pre-tax and/or after-tax (Roth 401(k)) basis through salary deductions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

1. Plan Termination and Description of the Plan Prior to Plan Termination (Continued)

The Company may make discretionary match contributions based on a discretionary percentage allocated proportionate to the participant's salary deferrals. The Company may also make discretionary profit-sharing contributions based on a percentage of each participant's base compensation or a dollar amount per participant. For the year ended December 31, 2023, the Company made matching contributions up to 6% of eligible compensation which totaled \$270,243.

Participant Accounts

Each participant's account is credited with the participant's contribution, including the earnings and losses on these contributions, and an allocation of the Company's matching and profit-sharing contribution. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

The Plan provides a variety of investment options with differing risk and growth characteristics. As of December 31, 2023, Plan's net assets available for benefits were invested in mutual funds. Participants may change their investment allocations and/or transfer their account balances among the various funds at any time.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contributions plus earnings thereon is based on years of continuous service in accordance with the following schedule:

Participants also become fully vested in the Company's contributions at their normal retirement age of 65, upon retirement due to disability, upon death, and upon termination of the Plan.

Notes Receivable from Participants

Participants may borrow from their accounts, subject to Code regulations, a minimum of \$500 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Loan terms range from 1 year to a maximum of 5 years, except for loans used to purchase the participant's primary residence, which may be extended up to 30 years. The outstanding loans are secured by the balance in the participant's account and bear interest at prime plus 2%, which is commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions. The unpaid balance of any loan is immediately payable upon termination of employment and maybe offset against the participant's vested account. The Plan had notes receivable from participants at December 31, 2023 and 2022, of \$0 and \$77,860, respectively.

Benefit Payments and Withdrawals

Benefits start on a participant's normal retirement date if the participant is no longer an employee and has a vested account under the Plan. The participant may choose to have benefits paid on this date even if the participant is still an employee. Normal retirement means the first day of the month on or after the participant reaches age 65. Plan distributions can be made as lump-sums, substantially equal installments or partial withdraws, provided the minimum withdrawal is \$500.

If a participant's employment ceases as a result of termination, normal retirement, death or disability, the participant or participant's beneficiaries are entitled to receive the value of the participant's vested interest. Participants or their beneficiaries may receive benefit payments in a lump-sum amount equal to the value of the participant's vested interest, in installments over a period determined by the participant, or a direct transfer to a qualified plan of equivalent value. Upon severance of employment vested account balances less than \$5,000 will be automatically distributed in a lump-sum amount without Participant consent.

The Plan also allows for an in-service distribution from the participants' vested accounts at any time after the attainment of age 59 ½ years old. There is no limitation in the number of in-service distributions during a plan year, however, the minimum amount that can be requested for an in-service distribution is \$500.

Distribution may be made from the participants' vested accounts at any time for a hardship withdrawal. Events that qualify for a hardship withdrawal are as follows: to cover necessary medical expenses, for costs directly related to the purchase of the participant's primary residence, for expenses related to post-secondary education, for payments necessary to prevent the participant's eviction from or foreclosure of the primary residence, burial and funeral expenses for deceased family members or expenses for repair and damages of the participant's primary residence. The minimum amount that can be requested for a hardship distribution is \$500.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP). For the period ended December 31, 2023 the accounting and reporting is on the liquidation basis under U.S. GAAP.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 or 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Forfeited Accounts

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures may be used to pay Plan expenses. Forfeitures totaled \$210,967 and \$397,595 for the years ended December 31, 2023 and 2022, respectively.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Net appreciation in fair value of investments included in the accompanying statement of changes in net assets available for benefits includes realized gains or losses from the sale of investments and unrealized appreciation or depreciation in fair value of investments. Net unrealized appreciation or depreciation in the fair value of investments represents the net change in the fair value of the investments held during the period. Then net realized gains or losses on the sale of investments represents the difference between the sale proceeds and the fair value of the investments as of the beginning of the period or the cost of the investment if purchased during the year.

Expenses

All expenses incurred in maintaining the Plan are paid using the Plan's assets, unless the Company, at its discretion, elects to pay certain expenses. These expenses include fees of the Plan's custodian and third-party administrators. The expenses of maintaining the Plan paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in the fair value of investments. Administrative expenses for the year ended December 31, 2023 and were \$127,769 and \$46,271, respectively.

3. Information Prepared and Certified by the Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, investments at December 31, 2023 and 2022, and investment income for the year ended December 31, 2023, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Trustee of the Plan.

4. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1: quoted prices in active markets for identical assets or liabilities; or

Level 2: inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

Level 3: unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The following is a description of the valuation methodologies used for financial instruments measured at fair value.

Registered investment companies: open-end mutual funds registered with the Securities and Exchange Commission and valued at the daily closing price. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded (Level 1).

Common collective trust: valued using fair value based on the underlying securities within the fund, which represents the NAV of the shares held by the Plan at year end. The NAV practical expedient of common collective trusts ("CCT") is based on the fair value of the underlying assets held by the CCT minus its liabilities and then divided by the number of units outstanding. The NAV practical expedient is calculated based on a compilation of primarily observable market information.

4. Fair Value Measurement (Continued)

The method described above for common collective trusts may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

5. Related Party and Party-In-Interest Transactions

The Plan engages in transactions involving acquisition or disposition of units in funds managed by ADP or the Trustee. These transactions qualify as exempt party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

The Plan allows participants to borrow from their vested balances. These transactions qualify as party-in-interest transactions and are exempt from prohibited transaction rules under ERISA.

6. Tax Status

The Plan sponsor adopted a non-standardized prototype plan, which received a favorable IRS opinion letter dated October 6, 2020. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability or (asset) if the plan takes a position that is more likely than not to be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan provides for various investment securities. Investment securities are exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

8. Subsequent Events

Management has evaluated subsequent events through October 15, 2024 which is the date the financial statements were available to be issued. No events have occurred, other than that described in Note 1, subsequent to December 31, 2023 requiring recording or additional disclosure in these financial statements.
